This year's focus is accessible employment and customer service during COVID-19. You are invited to attend a <u>free webinar</u> on June 18<sup>th</sup> from 2:00 to 3:00 pm. This online training event will feature the launch of a new made-in-Manitoba video about accessibility in the workplace.

The Province has developed a social media kit to raise awareness about MAAW and accessibility issues affecting individuals, community organizations and businesses. To download these resources, visit the Disabilities Issues Office website at AccessibilityMB.

#### Reminder and new free resources

The Accessibility Standard for Employment requires accessibility at all stages of employment. The <u>requirements affecting an emergency</u> are in effect and provide guidance during COVID-19.

The deadline for public sector organizations to meet the remaining requirements is May 1, 2021. Businesses and non-profits with at least one employee have until May 1, 2022.

The Manitoba government continues to build its toolbox of free resources to support compliance with accessibility standards:

- Accessibility Standard for Employment, Employers' Handbook (PDF) explains how to meet the requirements the Accessibility Standard for Employment.
- Sample Accessible Employment Policy (PDF) assists in documenting policies.



## **COVID-19: Advocacy progress continues**

As local leaders continue working flat out to carry our communities through this pandemic, FCM continues to press your priorities in Ottawa—and we're making progress.



Federal help for municipalities: a modest first step

The Prime Minister's announcement today that he will accelerate 2020-2021 Gas Tax Fund transfers to municipalities recognizes that our municipal financial crisis is a national crisis—one that requires urgent national leadership, with meaningful provincial collaboration.

While this modest, preliminary measure may help some municipalities, it is not new money. This money has already been accounted for in municipal budgets. It does not directly address our financial crisis—or the stark choices municipal leaders now face in this pandemic.

The Prime Minister did confirm his readiness to engage with municipalities on solutions, and we're encouraged by that. FCM will continue working directly with the federal government—and with our members and partners across the country—to secure emergency funding for municipalities.



### This years Policing Priorities 2020-2021

Hello All.

Hopefully all is well with you in this world of Covid 19. We have had a couple of scares here in the office, but all negative, thank goodness.

It's that time of year again, the annual policing priorities have been set by Division HQ. This year is very much the same as last year as far as priorities. We have traffic, crime reduction and communication. We were fairly successful last year with these priorities.

Traffic we looked for impaired driver and stop sign violations. We ended up with 27 impaired drivers charged over the year our goal was 35. Stop sign violations had a goal of 42, we had 41.

We took a three step plan in our crime reduction strategy, using Community Mobilization referrals, restorative justice referrals and criminal condition compliance checks. We wanted 25 Community Mobilization referrals and had 35. We wanted 25 compliance checks and got 32. Restorative justice referrals we had 2 and we wanted 10. These referrals are now coming out of the Crowns office with the new pre-charge system. We only track the ones we did before sending cases with recommended charges to the Crowns office. So there is many more.

Communication strategy has both internal and external components. Internally we wanted 4 Area meetings. We managed 2. We missed one due to scheduling issues and one due to Covid. Externally we wanted to reach out to you all 50 times, we got 61. We beat our goal here but the traditional overall value is in the hundreds.

I have attached last year's overall stat report for your review.

I have also attached a letter that, I'm hopeful you will sign. Basically it just says what we are looking at for the upcoming year. I have addressed them to Council, so that anyone can sign. Please return the letter by mail or e-mail, whichever is easier for you.

Currently, our human resource situation has us with 2 Constables off on Paternity leave and one Corporal on Maternity leave. All are due back before the end of summer. I have one Cpl on long term sick leave and another that has been temporarily seconded to Nunavut. The secondment is back by the end of May.

I have 4 Constables slated for transfer. One from Carberry is gone by months end. Another, also from Carberry is gone by the end of summer. Two members from Souris are gone anytime after they sell their respective houses. One of those members will be joining the new Crime Reduction Team and will be based out of Brandon for the time being. He will continue to help us out at the Detachment level on an as needed basis. I have two members transferring in, but they are also trying to sell houses. A third decided to quit and join Brandon Police Service before he arrived here. The search is on for additional members. The struggle is real with keeping boots on the ground here. We are managing. Ideally, we'll see our incoming before our outgoing are on the road.

That's the news from here for now. As always, give us a call or drop an e-mail and we'll help you out wherever we can. Take care.
