

We just launched a free, online course on gender-responsive public budgeting for municipal staff and elected officials. It covers basic considerations such as how to identify gender gaps and inequalities in payroll management and the provision of services. It also helps to understand the causes of discrepancies and suggests corrective measures. The course is a collaboration between our Inclusive Municipal Leadership Program in Tunisia and our Canadian Women in Local Leadership project.

Did you know that your municipality's landfills can be a source of unexcepted environmental, social and economic benefits? By converting the methane gasses produced in landfills into a renewable natural gas, you can reduce local GHG emissions and offset energy produced by fossil fuels. You can also sell the converted gas on the open market, creating a new source of revenue for your community. With support from our Green Municipal Fund, the City of Winnipeg, MB, developed a plan for its landfill that can produce as much as \$21.36 million in value.





The City of St. Albert, AB, has received \$5 million to fund a home-energy retrofit program that could add \$17 million to the local economy. Federal Natural Resources Minister Jonathan Wilkinson and FCM President Taneen Rudyk announced a \$25.6-million investment on Monday, October 3 to support home energy retrofit programs in St. Albert, Calgary, Lethbridge, and Canmore. The Single Point of Access is a single electronic point of access (website) which allows vendors to quickly retrieve information about CETA covered procurements throughout Canada. The Government of Canada has developed the fully functional Canada-wide electronic tendering website <u>CanadaBuys (https://canadabuys.canada.ca/en)</u> as the Single Point of Access.

Federal, provincial, territorial, municipal, academic, social and health entities including Crown Corporations who are subject to CETA are required to ensure notices for CETA-covered procurements are posted on the Single Point of Access, <u>CanadaBuys</u>, starting September 21, 2022.

Please review the attached questions and answers for more information about how your entity can ensure compliance with the CETA Single Point of Access requirement by September 21, 2022.

#### Q1. What is CETA?

**A1.** CETA is an acronym for the Canada-European Union Comprehensive Economic and Trade Agreement (CETA), a bilateral agreement between Canada and the European Union (EU). The agreement covers virtually all sectors and aspects of Canada-EU trade, from tariffs to product standards, investment, professional certification and many other areas of activity. CETA is explained in detail here:

#### Q2. Does CETA apply to the public sector?

**A2.** CETA applies to high value procurement contracts by the public sector at federal, provincial entities as well as MASH sector. However, certain exceptions are built into CETA's government procurement rules, such as cultural industries, Indigenous (Aboriginal) businesses, defense, research and development, financial services, and services in the fields of recreation, sport and education, as well as social and health-care services.

Notable entity exemptions in Manitoba include Manitoba Public Insurance, Venture Manitoba Tours Limited, and select exemptions for Manitoba Hydro and the Manitoba Hydro Electric Board.

#### Q3. What is the Single Point of Access (SPA)?

**A3.** CETA requires a notice of intended procurement and summary notice to be published for covered procurements. The Single Point of Access is an electronic point of access (website) which allows vendors to quickly retrieve such notices Canada-wide.

#### Q4. What are covered procurements (CETA thresholds)?

A4. Covered procurements are procurements that meet or exceed CETA thresholds and requirements. Please read Chapter 19 \_ Government procurement (https://www.international.gc.ca/trade-commerce/trade-agreements-accordscommerciaux/agr-acc/ceta-aecg/text-texte/19.aspx?lang=eng) and 19 Annex (https://www.international.gc.ca/trade-commerce/trade-agreements-accordscommerciaux/agr-acc/ceta-aecg/text-texte/19-A.aspx?lang=eng#b) carefully to understand exemptions, applicability, and thresholds.

#### Q5. What is the Single Point of Access implementation date?

A5. The Canada-wide implementation date for the Single Point of access is September 21, 2022.

#### Q6. How do I comply with the CETA Single Point of Access requirement?

A6. The answer depends on which electronic tendering website you use, and whether you also have a process to simultaneously post tender notices manually on MERX.

#### A6a) If you use MERX:

MERX has been the designated electronic tendering website for Manitoba since June 1, 1997. Manitoba's Municipal, Academic, Social, Education and Health entities (MASH), Crown Corporations, and other public sector entities in Manitoba are required to post their tenders and tender notices on MERX.

MERX has been working with the Government of Canada to ensure that notices for tenders that meet or exceed CETA thresholds are posted automatically to the Single Point of Access CanadaBuys. More information about MERX and the Single Point of Access is available here: https://eprocurement.mdfcommerce.com/hubfs/eProcurement/eProcurement-Files/merx/CETA\_SPA\_merx\_en.pdf.

If your tender value meets or exceeds CETA thresholds, staff posting on MERX must select "CETA" as applicable. MERX will then automatically interface with, and post notifications, on the Single Point of Access <u>CanadaBuys</u>. If staff miss this step, they can submit an amendment in MERX to indicate that CETA is applicable.

A6b) If you use **BidsAndTenders**:

<u>BidsAndTenders</u> will feed directly into the Single Point of Access <u>CanadaBuys</u>. Please contact your account manager directly to learn more about their activities related to the Single Point of Access <u>CanadaBuys</u>, and to learn about the steps you need to take to comply with the Single Point of Access requirement using their tendering website.

A6c) If you use a non-MERX electronic tendering website such as <u>Bonfire</u> or <u>Biddingo</u> AND you also simultaneously post your notices manually on MERX:

Ensure staff posting on MERX select "CETA" as applicable for procurements that meet or exceed CETA thresholds. MERX will then automatically interface with, and post notifications, on the Single Point of Access <u>CanadaBuys</u>.

A6d) If you use a non-MERX electronic tendering website and you do not simultaneously post your notices manually on MERX, and/or you rely on automated aggregation from MERX:

You will need to begin manually posting your notices on MERX for procurements that meet or exceed CETA thresholds by September 21, 2022. Ensure staff posting on MERX select "CETA" as applicable. MERX will then automatically interface with, and post notifications, on the Single Point of Access <u>CanadaBuys</u>. You can request the creation of a MERX account for the purpose of publishing tender notices to <u>CanadaBuys</u> by contacting the MERX Buyer Support team at 1-888-738-3005 or by email at <u>service@merx.com</u>.

Dear Minister Gordon, Minister Reyes, Deputy Minister Karen Heard, Deputy Minister Eric Charron, and Mr. Adam Topp,

On June 16, a group of representatives from the Southwest Caucus met with you to discuss ways we might work together to address issues within paramedicine in rural Manitoba. (The Western Caucus is a group of over 20 municipalities from Southwest Manitoba who's representatives meet regularly to discuss common issues and identify ways to share our best practices and work together to address these issues.) We also indicated that were willing to work with the province, training institutions and/or other regulatory bodies to address these ideas, which included:

- 1) Increase paramedics training opportunities in rural Manitoba,
- 2) Allow EMRs to act as the second paramedic in an ambulance,
- 3) Implement more cost effective stretcher services in rural Manitoba,
- 4) Resolve the wage and working condition inequities between rural and Winnipeg paramedics, and
- 5) Develop a coordinated, comprehensive Paramedicine action plan in consultation with all paramedicine stakeholders.

We left the meeting with a promise of a response from the province regarding these ideas, but are sorry to say that we have not yet received a response from anyone. We realize everyone is very busy and working hard to address the many issues that we face as a province, but also feel that three months is a long time to wait for a response. We hope that this is an oversight and look forward to a speedy reply in the next few days.

In the meantime, we have carried on our efforts to address point 1) to increase paramedics training and point 2) allowing EMRs to act as the second paramedics on shift. To move these ideas forward, we have met twice with representatives of Assiniboine Community College to discuss their interest in offering paramedics training. In a recent meeting with Karen Hargreaves (Dean of the School of Health & Human Services at ACC), her staff, and Western Caucus representatives, we have identified a potential "quick win" for everyone, that would include the following:

- Allowing Emergency Medical Responder's (EMR's) to be the second paramedic on shift, along with a Primary Care Provider (PCP), rather than requiring two PCP's for each shift. (Note: Karen Hargreaves from ACC is following up with the College of Paramedics to discuss this idea).
- Offer EMR training through ACC (320 hours/approx. 12 week course as opposed to a two year course to become a PCP). (Note: ACC is interested in providing this training.)
- Promote the training to rural students. (Western Caucus municipalities will be asked to promote the course in their schools and to provide bursaries.)
- Confirm with Shared Health and local RHAs that EMR's would be hired as the "second" paramedic on shift and for ambulance calls. (Karen Hargreaves is also following up with Shared Health and Prairie Mountain Health to discuss.)

While we are moving forward with ideas to address 1) and 3) on our list, we are still waiting to hear from you regarding the provision of stretcher services in rural Manitoba, support to resolve working conditions between rural and Winnipeg paramedics, and the idea of developing a paramedicine action plan that includes not only the province, but other paramedicine stakeholders.

We are confident that we will receive a prompt reply from your departments to help us understand how the province is helping us to address this issue which is critical to all of rural Manitoba.



# Western Canadian Municipal Associations (WCMA) Gather in Edmonton for Annual Meeting

Leaders representing the municipal associations from Western Canada's three Prairie provinces met in Edmonton on Wednesday, October 5, 2022, to discuss common issues.

Alberta Municipalities (ABmunis) and the Rural Municipalities of Alberta (RMA) co-hosted the annual meeting which brings together elected officials and staff from ABmunis, RMA, Saskatchewan Urban Municipalities Association (SUMA), Saskatchewan Association of Rural Municipalities (SARM), and the Association of Manitoba Municipalities (AMM).

Discussion items included municipal challenges in accessing federal infrastructure funding, the impacts of the Government of Canada's proposed fertilizer emission reduction targets on Canada's agriculture sector, escalating uncertainty related to RCMP policing, challenges in supporting broadband connectivity, and limited access to health services and mental health and addictions support.

In terms of infrastructure funding, the associations agreed on the need for the federal government to engage with municipalities to ensure future funding programs meet the needs of all municipalities. More specifically, WCMA members are calling for the permanent doubling of the Canada Community Building Fund (CCBF) as a core federal action to support strong and resilient municipalities.

"Municipalities need a seat at the table. We are often required to share costs with the federal and provincial governments but lack a voice in negotiating infrastructure agreements. Our expertise, insights and priorities are vital to the process."

Another important issue discussed was the challenge being faced by each province regarding access to healthcare, emergency medical services, and mental health and addictions support in both urban and rural communities. Provincial under-resourcing in these areas have put municipalities across western Canada in a

challenging position due to the ongoing downloading of responsibilities without corresponding increases in funding or support.

"The COVID-19 pandemic compounded mental health and addictions issues, which were already a critical crisis in Canada. From affordable housing to additional mental health resources, we need more supports. We need a coordinated response from the provincial and federal governments to help our residents, and our communities."

The associations discussed the Government of Canada's proposed 30% reduction in fertilizer emissions. It was communicated that if implemented, the proposal would unfairly target the agriculture industry, which is already at the forefront of emissions reductions efforts. Canada's agriculture industry massively contributes to food security across the world and any new barriers or restrictions placed on the industry must weighed against its economic and humanitarian contributions. All the WCMA members agreed that the federal government must support our Canadian agriculture sector and consult with all sector stakeholders before proceeding with any announcements or directives that affect our agriculture industry.

"Western Canadian ag producers are the most technologically advanced in the world. Heavy restrictions on the use of fertilizers would pave a path to unsustainable agriculture in Canada, leading to lower production and reduced food security."

As many municipalities contract RCMP for policing services, the associations are concerned with the uncertainty around many aspects of policing. This includes a lack of accountability from the federal government to formally commit to assuming the costs of the retroactive RCMP salary increases negotiated through a recent collective agreement with the federal government. Municipalities were not at the table to negotiate the agreement and were not engaged on the impacts of assuming such costs. WCMA is calling on the federal government to firmly indicate that municipalities will not be required to assume these costs.

WCMA members are also seeking clarity from the Government of Canada in the RCMP's future role in contract policing. With several provinces considering or actively studying a transition to a provincial police service, WCMA believes the Government of Canada has a responsibility to provide municipalities with certainty around the RCMP's role moving forward.

"Despite being a paying contract partner, municipalities were completely shut out of the RCMP collective bargaining process. While we appreciate the Government of Canada pausing invoices to municipalities, the federal government needs to find an immediate solution to retroactive policing bills. Moving forward, we will continue to call on the federal government to fully absorb all retroactive pay increases."

Access to broadband is critical to community sustainability across western Canada. While the federal government has provided a range of broadband funding over the past decade, it continues to miss the mark in

improving connectivity in the most underserved areas. WCMA is calling on the Government of Canada to revisit their approach to connectivity to better support communities that need it most.

"Access to broadband for small, rural and remote communities across the Prairies continues to be a challenge despite several funding announcements by provincial and federal governments. The opportunity to connect with our peers from Western Canada provides immense opportunity to identify collaborative solutions to push the Government of Canada to distribute funding transparently and in a manner that supports improved connectivity in the most underserved areas."

As western Canadians, the association representatives agreed on the importance of oil and gas in supporting Canadians' basic needs and in helping to fund a nationwide transition to a net zero economy in the future. Oil and gas continues to be hugely important to municipalities across western Canada, and WCMA sees a need for the Government of Canada to better recognize the importance of the industry to Canada's economy, and support its world class efforts to produce resources in an ethical and environmentally responsible way.

The annual WCMA meeting was a great opportunity for the associations to not only share concerns but build a stronger relationship. "We reaffirmed today that we have much in common and can have a strong voice when working together. It was a great opportunity to have an open discussion on how we can address issues impacting municipalities in Manitoba, Saskatchewan and Alberta," explained Paul McLauchlin, President of the Rural Municipalities of Alberta.

"Western Canada's municipalities are leaders in many areas, from renewable energy to mental health supports and many in between," said Alberta Municipalities President Cathy Heron. "We made great progress on determining how to work with other levels of government on these key issues and we look forward to more collaboration in the months ahead."

- We finally received the 2021 Payments in Lieu of Taxes (PILT) federal shortfall amount owed for 2021.

#### BY-LAW NO. 32-2022

BEING a By-law of the Municipality of Oakland-Wawanesa to establish an Emergency Mitigation and Preparedness Reserve Fund.

WHEREAS Subsection 168 (1) of The Municipal Act provides as follows:

"A council may by by-law establish reserve funds for any general or specific purpose";

AND WHEREAS it is deemed necessary and desirable to establish an Emergency Mitigation and Preparedness Reserve Fund to utilize the deductible from the Disaster Financial Assistance (DFA) Program;

AND WHEREAS the funding for this purpose will come from the 2022 Disaster Financial Assistance Program deductible through the 2022 operating budget;

NOW THEREFORE the council of the Municipality of Oakland-Wawanesa enacts as follows:

- 1) That an Emergency Mitigation and Preparedness Reserve Fund be created.
- 2) That a sum equaling the amount of the deductible from the 2022 DFA Program be allocated to establish the reserve, and further contributions be based on any future DFA deductibles.

#### Good afternoon Elaine,

The following is a written summary of what was discussed at the previous council meeting by page number:

- Page 4 and 5 Audit report explained that the independent auditor's report outlines management's and the auditor's responsibilities and that Sensus issued a qualified audit opinion on certain revenues earned by the Souris River Recreation Commission due to certain revenues being received mainly in cash that there is no way to verify are 100% correct. This is a standard qualification so nothing of concern. Otherwise a clean audit opinion was issued indicated any issues encountered were able to be cleared up between with further information, clarification, or an audit adjustment.
- 2. Page 6 Statement of financial position
  - a. Noted the decrease in amounts receivable in 2021 compared to 2020 was due to the taxes on roll receivable being down as well as not having a receivable from the Brandon School Division for overpayment of school levies which occurred in 2020
  - b. Noted the increase in accounts payable in 2021 compared to 2020 was due to more money owing to \$38,000 more to MWSB than in the prior year as well as having roughly a \$156,000 payable for progress payment #2 on the municipal office
  - c. Noted long-term debt increased in 2021 compared to 2020 as a result of obtaining the Fibre loan during the 2021 year offset by the repayments on all loans during the year
  - d. Noted prepaids increased in 2021 compared to 2020 as a result of pre-payments for the Fibre project as well as a deposit on a wheel loader
- 3. Page 7 Statement of operations
  - a. Noted user fees were up in 2021 compared to 2020 due to less COVID restrictions
  - b. Noted other revenue was up in 2021 compared to 2020 due to debenture pre-payments received in relation to the Fibre loan obtained in 2021
  - c. Noted water and sewer revenue was up in 2021 compared to 2020 due to more provincial grants received as well as an increased amount of water service fees received
  - d. Noted Grants Province of MB was down in 2021 compared to 2020 due to not having any DFA fundings in 2021
  - e. Noted Grants Other was up in 2021 compared to 2020 as a result of increased gas tax funding and grants for the rec commission
  - f. Noted resource conservation and industrial development expenses were up in 2021 compared to 2020 due to the Fibre project contribution for 2021
  - g. Noted Recreation and Culture services expenses were up in 2021 compared to 2020 due to expenses of the rec commission and grants from the Municipality to the Rec for donations received
  - h. Noted Water and sewer expenses were up in 2021 compared to 2020 increased maintenance costs including filter media repairs
- 4. Page 14 Note 7 Long term debt
  - a. Pointed out that over the next 5 years \$535,031 of the current debt of \$1,036,344 will be paid off
- 5. Page 18 Note 17 Government partnerships
  - a. Pointed out that this note outlines the amounts the Souris River Recreation Commission and Glenboro-South Cypress-Wawanesa Handi Transit add to the Municipality's figures
- 6. Page 20 Schedule of Tangible Capital Assets

- a. Noted some of the larger capital asset additions during the year being a truck, fire equipment, mower, trailer, office building, rink upgrades, paving, and water plant upgrades
- 7. Page 27 Consolidated details and reconciliation to core government results
  - a. Explained that Core Government section represents the Municipality's figures and the Government Partnerships section represents the Souris River Recreation Commission and Glenboro-South Cypress-Wawanesa Handi Transit figures that are added in for the consolidated financial statements
- 8. Pages 28 and 29 Schedule of changes in reserve fund balance
  - a. Outlined that these two pages show the transactions in each reserve fund for the 2021 year
- 9. Page 31 Schedule of Financial Position for utility
  - a. Explained this page is the balance sheet for the utility. Only major changes on here was the increase in accounts payable due to more owed to MWSB and the long-term debt decreasing due to payments made during the year
- 10. Pages 32-33 Schedule of utility operations
  - a. Explained these pages are the income statement for the utility. Reiterated here that on page 32 you can see the increased amount of government funding and water fees received in 2021 that were originally mentioned when looking at page 7
  - b. Discussed that the public utility board looks at the deficit noted on the "NET REVENUES (DEFICIT)" line which was \$19,455 for 2021. However, you need to subtract current year government transfers received (\$59,803 per page 32) and add in the amortization of capital grants (\$5,446 and \$50,203) as noted in Note 19 on page 19 so the deficit for 2021 is actually \$23,609 calculated as follows:
    - i. <\$19,455> \$59,803 + 5,446 + 50,203 = <\$23,609>
- 11. Page 39 Reconciliation of Annual Surplus (Deficit)
  - a. Explained that the Municipality's general operating fund incurred a deficit of \$205,695 during the year, as shown on the "Municipal Surplus (deficit) under the Municipal Act line. I outlined that this deficit was a result of a payable for around \$156,000 for the office building being set up as part of the audit but wasn't transferred from reserves until 2022 with the remaining deficit being a result of council transferring \$75,000 to the general reserve from the 2021 surplus per the December 21, 2021 meeting minutes however once the audit was completed there was not that much of an operating surplus to transfer.
    - i. I further explained that the Province will reach out at some point on the Municipality's plan on how to cover the deficit incurred. The large portion of the deficit from the payable relating to the office building will have been covered already in 2022 via transfers from reserves to cover the costs of the office building. The remining portion of the deficit will need to be covered through via a method to be determined by council.

#### 12. Audit findings letter


- a. Discussed the following internal control deficiencies identified:
  - i. The original inventory count sheets were not being retained for audit purposes therefore we recommended keeping the original count sheets to serve as audit evidence that the inventory listing is accurate
  - ii. Indemnity claims forms were not always being signed by the claimant and/or a second person authorizing the claim form for the purpose of ensure the claim is authorized/approved by all parties involved

iii. Discussed use of the terminology of flow-through donations in the Municipality's general ledger. Explained CRA's rules on donations received by the Municipality and how they are to be treated and that it is at the discretion of council as to where each donation received ultimately gets allocated.




# Municipality of Oakland-Wawanesa PROPOSED SUBDIVISION Regional Setting




