FCM Municipal Asset Management Program

The FCM realizes it is hard to make important choices about maintaining, replacing, and repairing aging municipal infrastructure. To make these important decisions, you need a solid foundation for asset management within the municipality, which also includes good data. The FCM MAMP helps municipalities with this process to gather accurate data, to ultimately make solid asset-related decisions.

Key program areas of focus are:

- Getting municipalities to use good asset management practices.
- Supporting training and workshops in your community.
- Helping you plan for and conduct data collection and analysis.
- Gathering and sharing your knowledge and lessons learned.

Municipal asset management helps municipalities manage their aging infrastructure to make better investment decisions. The FCM MAMP has funded:

- Over 500 municipal asset management projects

Project Overview

Under the FCM Municipal Asset Management Program, we look to deliver asset management services for the Municipality of Oakland-Wawanesa. This project will provide guidance, reflection, and produce a roadmap to coordinate municipal asset management decisions with municipal-owned infrastructure. To do this, we look to identify what asset data the municipality has and consolidate it into one central database to identify what the assets are, where the assets are geographically, and what the assets are made of. Since accurate data is key, we then analyze the systems the municipality is currently using to go out in the field to collect further asset data. During this, we will also educate and provide the tools necessary to the municipality on how to accurately collect asset data in the field.

These activities will not only produce a roadmap for better asset investment decisions, it will also create a formal asset management process while creating a high level, in-house asset management capacity. Lastly, we then will look at this data and work with Administration and Council to develop a comprehensive asset management policy, strategy, and plan.





Deliverables

This project will provide the following deliverables:

- 1. Analyze and bring municipal asset data into one central database
 - a. To identify:
 - i. What the asset is
 - ii. Where the asset is
 - iii. What the asset is made of
 - b. Develop a solid foundation for asset management
- 2. Provide education and tools necessary to collect asset information in the field
 - a. Collect accurate, up-to-date asset information for investment decisions
 - b. Ensure municipal assets are maintained and safe for public use
- 3. Identify gaps in current asset information
 - a. Education and ongoing support through the asset management process
 - b. Recommendations on best-practices
 - c. Setup processes to better manage asset management tasks
- 4. Development of an asset management policy, strategy, and plan
 - a. Work with Administration and Council to produce a roadmap for future asset investment decisions
 - b. Formalize the asset management process
