Verbal representation was received as follows:

Linda McCrae Walker, SE 31-8-19W, appeared to ask the following questions:

Why did the Municipality move to a harmonized mill rate? She pointed out it was different from Souris-Glenwood Municipality where they also have land.

Could street lighting be put as a special services levy as rural residents do not benefit from it?

What was Council's position on replacement of equipment?

With the Municipality providing funding for fibre optic installation in Wawanesa from funds in the General Reserve raised by Wawanesa residents, could the same not be done for the rural area?

When and where would a new office building be constructed? She highly recommended Nesbitt as a central location.

Will taxpayers who are not interested in the Rural Water Co-op be charged for it?

Margret Kristjansson, NE 22-7-17W, appeared in addition to her written submission to ask questions related to the questions on the survey for a rural water co-op and to ensure that those not interested will not be required to pay.

John Robinson, 4-7-18W, appeared to ask questions on the allocation for computers and suggested it was \$10,000 too high.



The above noted by-law, being an amendment to the Municipality of Oakland-Wawanesa Municipal Development Plan By-law No. 04-2018, has been circulated to government departments and agencies for review and comment following first reading. This report summarizes provincial departmental responses received as of today. Original copies of all comments received are attached, and are for review and consideration at the public hearing set for August 18, 2020. Council should provide a copy of this report and copies of all comments received to the development proponent (Mr. Cale Jefferies) at the Public Hearing for his review and consideration.

Manitoba Municipal Relations - Community Planning Branch. This office does not object to the proposed development plan amendment. It proposes to re-designate approximately 10 acres of land from "Conservation and Recreation Area" to "Agriculture – General Area" to accommodate the subdivision and development of a single rural residential lot for use by Mr. Jefferies.

Manitoba Agriculture and Resource Development – The department notes the impact to agricultural land is minimal and therefore does not object to this development plan amendment. The department notes the SW36-8-17WPM consists dominantly of soils with Agricultural Capability Class 5IW, with limitations caused by periodic flooding and wetness. The quarter is mostly treed and is not actively farmed. The area proposed for re-designation is physically separated from the residual parcel by the Assiniboine River. These 10 acres form part of a larger soil map complex consisting of soils with Agricultural Capability Class 3I (limitation caused by periodic flooding, as well as Class 2I and 5IW. The 10 acres are mostly treed, front onto an undeveloped municipal road allowance and are adjacent to designated Agriculture General Area lands to the south.

Manitoba Department of Sport, Culture and Heritage - Historic Resources Branch - The Branch does not object to the proposed development plan amendment. The Branch has examined the location in conjunction with Branch records for areas of potential concern. No further action is required specific to the re-designation at this time, as there are no imminent plans for development that will cause ground disturbance.

However, as indicated in the application, the intent is to develop the property for rural residential development. If future developments are planned in which construction activities may impact the landscape or cause ground disturbances, the Historic Resources Branch is requesting that prior notification is given so that any possible impacts to heritage resources can be determined and mitigated as necessary.

Under Section 12(2) of The Heritage Resources Act, if the Minister of Sport, Culture and Heritage has reason to believe that heritage resources or human remains are known, or thought likely to be present, on lands that are to be developed, then the owner/developer is required to conduct at his/her own expense, a heritage resource impact assessment and mitigation, if necessary, prior to the project's start.

Manitoba Infrastructure – The department does not object to the proposed development plan amendment. However, Infrastructure has no record of permits for the existing access onto PR 340. Therefore, the owners/proponent is required to obtain a permit from Manitoba Infrastructure to legalize the existing access and for the intensification of use of the access. It is understood that there will be an easement agreement across the adjacent property. Therefore, included in the permit will be the declaration of right-of-way for the continued use and maintenance of the access to the subject property. Permission from the adjacent landowners will be required. Please be advised that through the permitting process, there may be a need to relocate the access away from the bridge.

Other Comments: MTS and the Mines Branch each provided responses indicating they had no concerns with the proposed plan amendment.

Concluding Remarks:

Based on provincial comments received to date, there are no provincial objections to the by-law. The Brandon Community Planning Office therefore recommends Council proceed to give the by-law 2nd reading (with or without outstanding local objections) following the conclusion of the public hearing. Thereafter, please submit two signed, sealed and certified copies of the amendment, a copy of the minutes of the public hearing and any local written submissions presented to Council at the hearing to the Minister care of the Brandon Community Planning Office. Council must not give the by-law 3rd reading unless and until after the Minister has first approved By-law 4-2020.

Finally, if there are any local objections to the by-law made at the public hearing, please be sure to provide each objector with a Notice of second Reading of By-law 4-2000 in accordance with section 48 of the Planning Act.

On behalf of the Agri-Resource Branch of Manitoba Agriculture and Resource Development, I have reviewed this proposed amendment from an agricultural perspective and in the context of the Municipality of Oakland-Wawanesa Development Plan By-Law 04-2018 and the Provincial Planning Regulation. This Bylaw proposes to re-designate ~ 10 acres in Pt. SW 1/4 36-8-17WPM from Conservation and Recreation Area to Agriculture General Area in order to accommodate a future subdivision and development of a single rural residence which are not permitted in the Conservation and Recreation Area. We have the following comments to offer.

The area in question is approximately 10 acres in Pt. SW 1/2 27-2-4W. The quarter section consists dominantly of soils with Agricultural Capability Class 5IW, with limitations caused by periodic flooding and wetness. The quarter is mostly treed and is not actively farmed. The area proposed for re-designation is physically separated from the residual parcel by the Assiniboine River. These 10 acres form part of a larger soil map complex consisting of soils with Agricultural Capability Class 3I (limitation caused by periodic flooding, as well as Class 2I and 5IW. The 10 acres are mostly treed, front onto an undeveloped municipal road allowance and are adjacent to designated Agriculture General Area lands to the south.

The Agriculture General Area is intended to preserve and protect agricultural land for a full range of agricultural activities and livestock operations (Policy 4.1.1). The Agri-Resource Branch expresses concern with the intent to re-designate land to an agricultural designation to accommodate a residential use; however, the Provincial Land Use Policies and the DP do provide for subdivision of physically isolated parcels. In this instance, the impact to agricultural land is minimal and we do not object to this development plan amendment.

Further to your e-mail regarding the above noted development plan amendment, the Manitoba Historic Resources Branch (HRB) has examined the location in conjunction with Branch records for areas of potential concern. No further action is required specific to the current amendment at this time as there are no imminent plans for developments that will cause ground disturbance.

However, as indicated in the application, the intent is to develop the property for rural residential. If future developments are planned in which construction activities may impact the landscape or cause ground disturbances, the Historic Resources Branch is requesting that prior notification is given so that any possible impacts to heritage resources can be determined and mitigated as necessary. The property in question is located on the lower terrace of the Assiniboine River, which has numerous previously recorded Pre-European Contact Indigenous settlements, as well as being in close proximity to documented fur trade posts such as Brandon House, Assiniboine House, and Fort La Souris. These factors, to name a few, suggest that any future planned development within the area has the potential to impact heritage resources, therefore, the Historic Resources Branch may have concerns with future development.

Under Section 12(2) of The Heritage Resources Act, if the Minister of Sport, Culture and Heritage has reason to believe that heritage resources or human remains are known, or thought likely to be present, on lands that are to be developed, then the owner/developer is required to conduct at his/her own expense, a heritage resource impact assessment (HRIA) and mitigation, if necessary, prior to the project's start.

The developer must contract a qualified archaeological consultant to conduct a Heritage Resources Impact assessment (HRIA) of the proposed development location, in order to identify and assess any heritage resources that may be negatively impacted by development. If desirable, the Branch will work with the developer/land owners and its consultant to draw up terms of reference for this project.



Hi Peter,

We have reviewed this proposed development plan amendment and do not object. However, we have no record of permits for the existing access onto PR 340. Therefore, we require the owners/proponent to obtain a permit from Manitoba Infrastructure to legalize the existing access and for the intensification of use of the access. We understand that there will be an easement agreement across the adjacent property. Therefore, included in the permit will be the declaration of right-of-way for the continued use and maintenance of the access to the subject property. Permission from the adjacent landowners will be required. Please be advised that through the permitting process, there may be a need to relocate the access away from the bridge.

Please note the following statutory requirements affecting PR 340.

Statutory Requirements:

Under the Transportation Infrastructure Act, a permit is required from Manitoba Infrastructure to construct, modify, relocate, remove or intensify the use of an access. A permit is also required from Manitoba Infrastructure to construct, modify, remove or relocate a structure or sign, or to change or intensify the use of an existing structure (including the alteration of existing buildings) within the **38.1** m (125 ft) controlled area from the edge of the highway right-of-way.

In addition, a permit is required from the Manitoba Infrastructure for any planting placed within **15 m** (50 ft) from the edge of the right-of-way of this highway.
