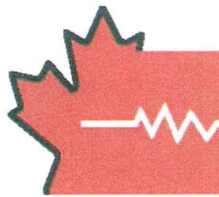

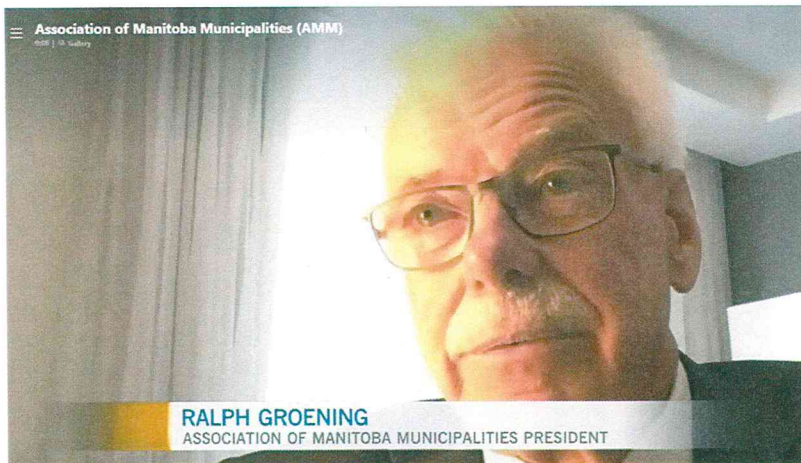

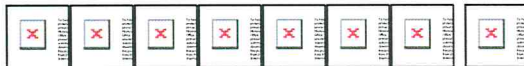

## Province streamlines approach to drainage

**October 3, 2019** - Please be advised that the Province of Manitoba issued a press release yesterday regarding its new streamlined approach to drainage under *The Water Rights Act*.

### Key regulation points:

- 14-day approval period for registrable drainage projects
- Exemption for 'like-for-like' municipal culvert replacements
- Ability to bundle project applications under certain conditions
- Increased application fees (registrable projects: \$25 to \$100; licensed projects: \$25 to \$500)

- NEW online [Water Licensing Portal](#) to track applications and map water control works

Since moving forward with this new approach, the backlog of existing drainage applications has been significantly reduced by approximately two-thirds. **Existing municipal applications will be automatically reviewed by Manitoba Sustainable Development and inputted into the new online system and corresponding application stream.**

The AMM is mindful of the potential effects of a fee increase on encouraging potential illegal drainage and therefore believes the impact of the fee increase should be closely monitored to ensure its effectiveness on speeding up the licensing process and reducing the existing backlog. We are also working with Manitoba Sustainable Development to ensure greater flexibility is provided to municipalities regarding municipal 'sign-off' stipulations; we feel municipalities should be able to determine what types of projects they want to be made aware of and have control over within their jurisdictions.

Overall, reducing red tape for low-risk, low-impact drainage projects is long overdue. We are hopeful that these changes will help reduce the significant backlog of drainage project applications and expedite routine projects.

Manitoba Sustainable Development has consulted the AMM and municipalities throughout the development of these regulations at previous AMM events and during the public consultation period. The AMM was also a part of the Drainage Regulation Steering Committee, while our staff have met extensively with departmental representatives.

In addition, the AMM has repeatedly stressed the importance of developing informational materials to help municipalities navigate the new online Water Licensing Portal and submit completed applications. Manitoba Sustainable Development has committed to developing these resources in consultation with the AMM; some materials have already been created and uploaded on the new portal.

Going forward, the AMM will be closely monitoring the implementation of these regulations and impacts on our members. We will also continue to provide regular updates as more information becomes available.

If your municipality experiences any challenges, I encourage you to contact AMM policy staff immediately so that we can bring your concerns forward in a timely manner.

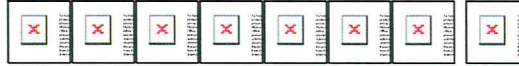

## Mind the Gap: Inequalities in Health

Imagine for a moment what it would be like to grow up knowing that you, your family and your community are three times less likely to make it to the age of 75 than everyone else in Manitoba. Not only that, but **the gap between your health and everyone else's is getting wider as time goes on**. This is the reality for First Nation people living in our province, and it is only one small piece of the unequal health status that looms large in their everyday lives.

To understand why First Nations' health is worse than other Manitobans, we need to first acknowledge the history of colonization and the horrendous effects it had (and continues to have) on the First Nations ways of life. As part of an effort to 'civilize' First Nation people, many children were forcibly removed from their families and communities and placed in residential schools. In being made to adopt the European way of life, they lost much of their language, their culture, and their connection to their families and communities. The trauma from this experience is still being felt today as the pain of this loss is passed down through generations.

In 2008, the Truth and Reconciliation Commission of Canada (TRC) was formed to give voice to the survivors of the residential school system. Their work showed how Government of Canada policies denied First Nation people equal access to high quality food and housing, higher education and higher paying jobs, and how this had a negative impact on their health. The TRC report contains 94 Calls to Action, which call upon all levels of government and educational institutions to improve the health and living conditions of First Nation people. They are a pathway to begin healing the harms enacted by residential schools and to advance the process of reconciliation in Canada.

It is in response to these calls, and especially Call #19, that researchers at the Manitoba Centre for Health Policy (MCHP) and the First Nations Health and Social Secretariat of Manitoba (FNHSSM) partnered on the latest report on Manitoba First Nation people's health.

## An Updated Look at First Nation People's Health

The report looks at several aspects of First Nation people's health and their use of healthcare. It draws comparisons between First Nation people living on-reserve vs off-reserve, First Nation people vs all other Manitobans, and between people living in different health regions and tribal council areas. It also uses data from the First Nations Regional Health Survey in Manitoba (2015-16). The Regional Health Survey is the only survey on health and well-being in Canada that is developed and overseen by First Nations, and it includes information from First Nation people living on reserve<sup>1</sup>.

## Deaths before Age 75

Deaths that happen before the age of 75 are viewed as 'early' or 'premature'. The rate of early deaths serves as a good overall measure of how healthy groups of people are and what their need for healthcare is. We've already mentioned that First Nation people have a much higher rate of early deaths than other Manitobans, but the reasons behind this are complex. It's not just that First Nation people don't enjoy the same access to healthcare. There are also underlying social factors that affect their health and well-being. While health services are important, factors like access to quality housing, water and food also need to be addressed.

## Mental Health

The mental health data at MCHP tell us how many people seek help from their doctors and get a diagnosis for a mental health disorder like depression or anxiety. In almost every health region across Manitoba, a far higher percent of First Nation people are diagnosed with a mood or anxiety disorder than are other Manitobans. And because we are only counting people who have a diagnosis, there are probably many more people who have a mental illness but have not seen a doctor about their symptoms.

Mental health disorders make many aspects of life more difficult. Sadly, they are also linked to suicide and suicide attempts. The rate of suicide attempts for First Nation people is four times higher than for all other Manitobans. And the rate of deaths by suicide among First Nations is also much higher

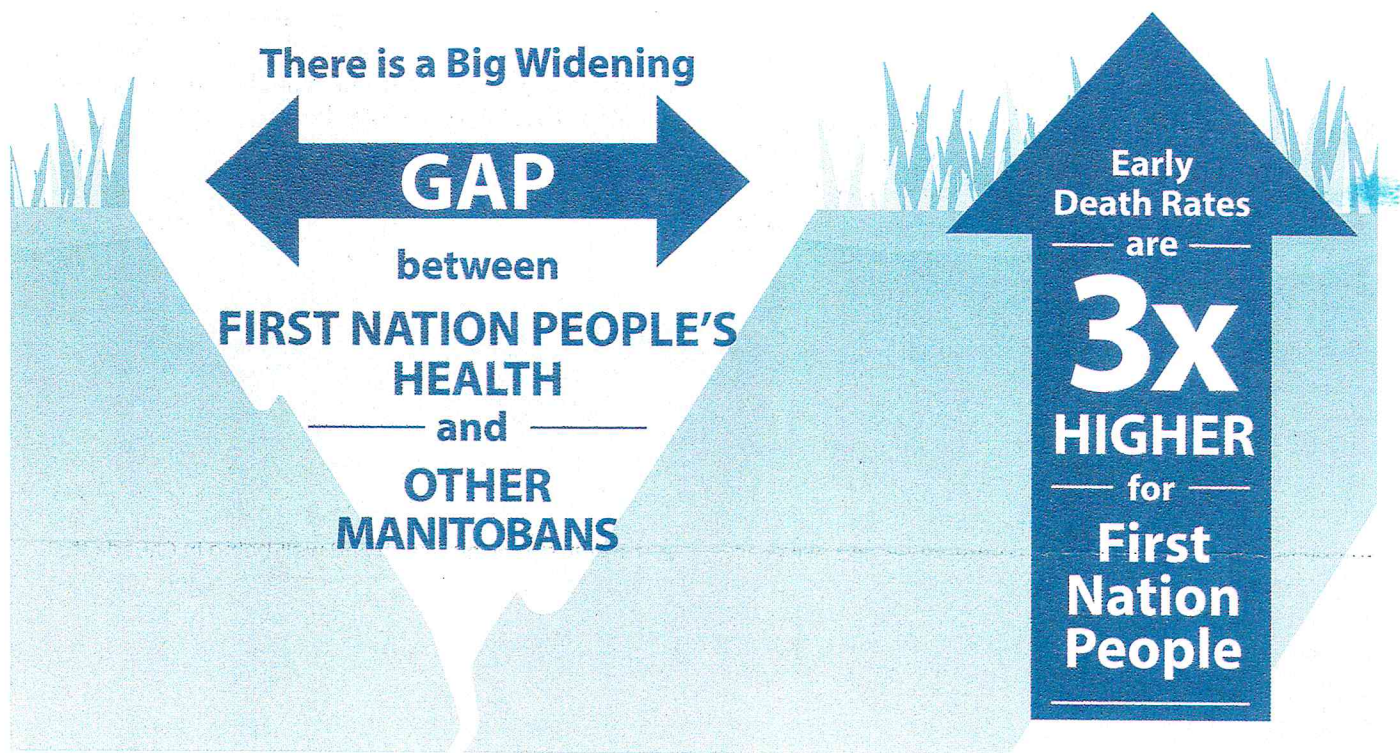

than for the rest of the province. In the Regional Health Survey, almost a quarter of First Nation people living on reserve felt that suicide was a challenge for their community.

These results will not be surprising for those who have heard about the recent mental health crises in First Nation communities across Canada. Many of these communities are in remote areas, and don't have access to supports like mental health counsellors. But First Nation people have shown how strong they are, even when faced with these challenges. In the Regional Health Survey, some communities report that they are making progress when it comes to mental health. They are drawing on their cultural roots, using traditional medicine, and making stronger connections with their families and communities. These are all positive aspects that show First Nation people are striving for mental wellness.

## Prescription Opioids

Opioids are a type of drug that are very effective at relieving pain. Over the last ten years, opioids have been prescribed more often than before to treat pain from all kinds of illnesses and injuries. But we know now that opioids are highly addictive, and taking them can make a person dependent on having more of them. And that can be dangerous – an opioid overdose can cause the user to stop breathing.

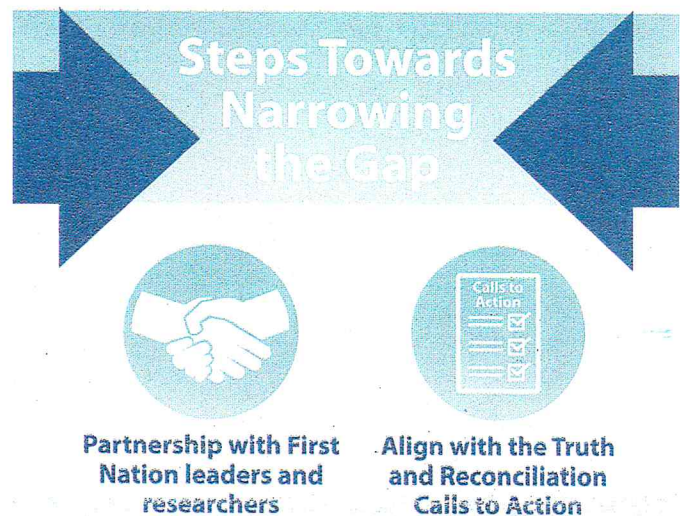
In our study, we looked at how many people received just one opioid prescription and how many had many prescriptions. A single prescription is used to treat pain from a one-time health event like surgery, and is less likely to lead to the user becoming dependent on opioids. But a pattern of many opioid prescriptions raises a red flag. While some people need to use opioids over the long term (for example, during cancer treatment), more than one prescription might also mean that the user will be at risk for opioid dependence.

We found that First Nation people were about twice as likely to be prescribed a single dose of opioids as other Manitobans. They were about 4 times more likely to have multiple prescriptions than other Manitobans. This pattern

could be seen in all regions across the province. And even though the results can't tell us why more opioids are prescribed to First Nation people, the large differences we see are a major concern to First Nation leaders.

## Where to from Here?

In the two decades since MCHP's last report on First Nations' health, the gap between First Nation people's health and the rest of the province has grown. What steps can we take on the road to bettering the health of First Nation people and redressing the harms done? The partnership between researchers at MCHP and FNHSSM that was formed to produce this report is an important part of the journey. It reflects the aim of First Nations in Canada that there be "nothing about us without us". This is the kind of partnership that is needed at all levels of government across the country to move past the effects of colonization. Working together to define problems and solutions will bring about sustainable change in the many systems that affect First Nations' health and help to narrow the gap between First Nations and other Manitobans.

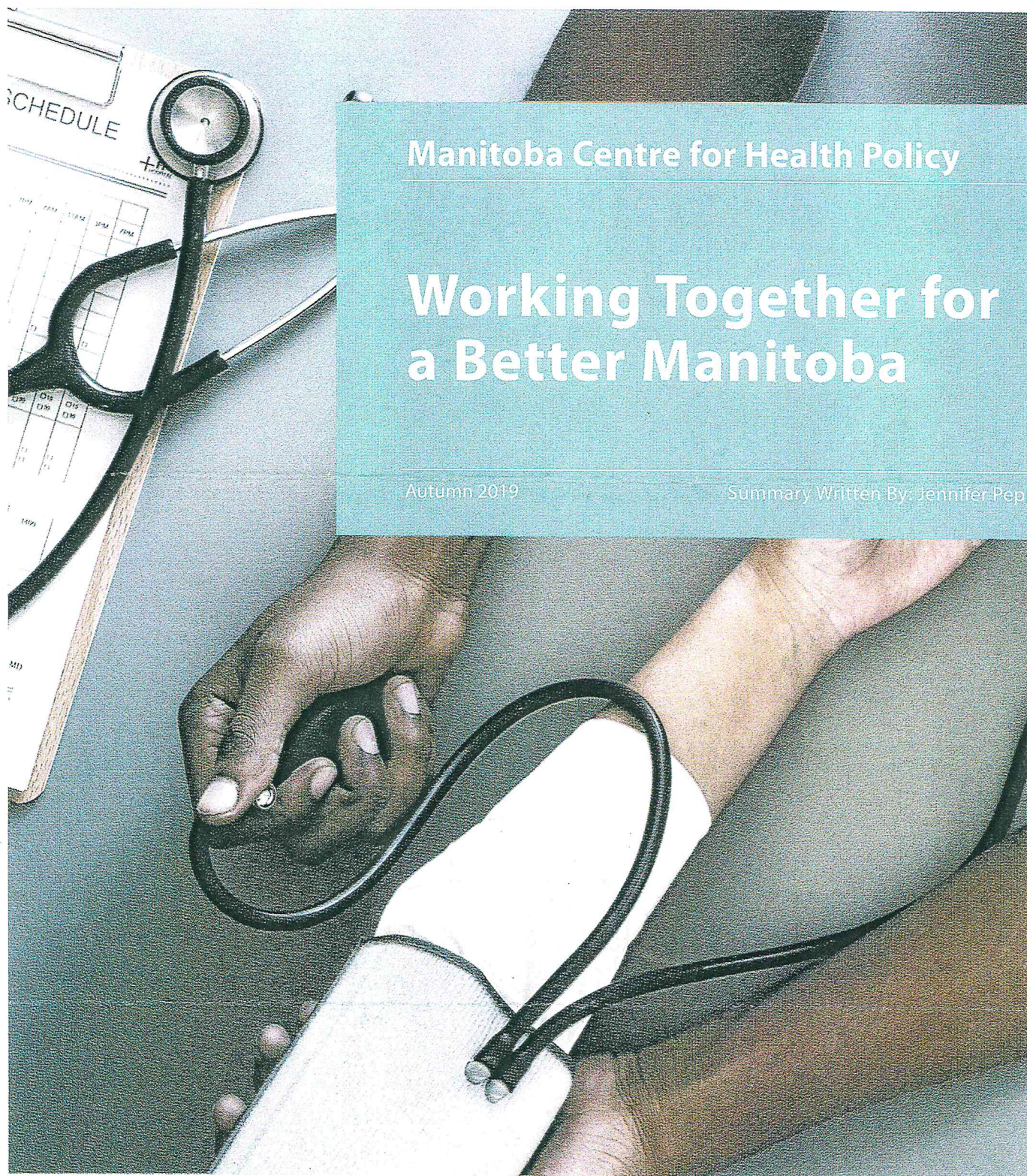

Imagine that you are on a hockey team trying to improve your game and your team's performance. You would want to know what you do well and what areas need improvement. Like that hockey team, the Regional Health Authorities (RHAs) face a similar challenge. They need to know what is going well in the health system, and what areas need improvement, so they can provide the right services to improve our health.

While hockey teams look at their offensive and defensive skills, decision makers in the healthcare system can look at health services and outcomes like:

- How long are Manitobans living?
- What is the level of disease in Manitoba?
- How are we using healthcare services, like doctor's office visits and lab tests?
- What are the outcomes related to the use of healthcare services?

Data like these help us to find out how healthy Manitobans are. It also helps to identify areas to focus on to improve the healthcare system.

One of Manitoba's healthcare teams working to improve services and health outcomes is called the 'Need to Know Team'. This team has been working together since 2001. The team includes researchers from MCHP, managers from all five RHAs, and provincial planners. A provincial research and healthcare system collaboration like this is unique to Manitoba. This is the fourth atlas-style report this team has created. It looks at the health status of all Manitobans, and our use of the healthcare system.

Each time a Manitoban visits a doctor, fills a prescription or uses a hospital, data are created. These data are in MCHP's Data Repository. Names are removed and health card numbers are replaced with a 'scrambled' number to protect privacy. This lets researchers link data. Linked data helps us to answer questions like how many Manitobans with diabetes develop kidney failure.

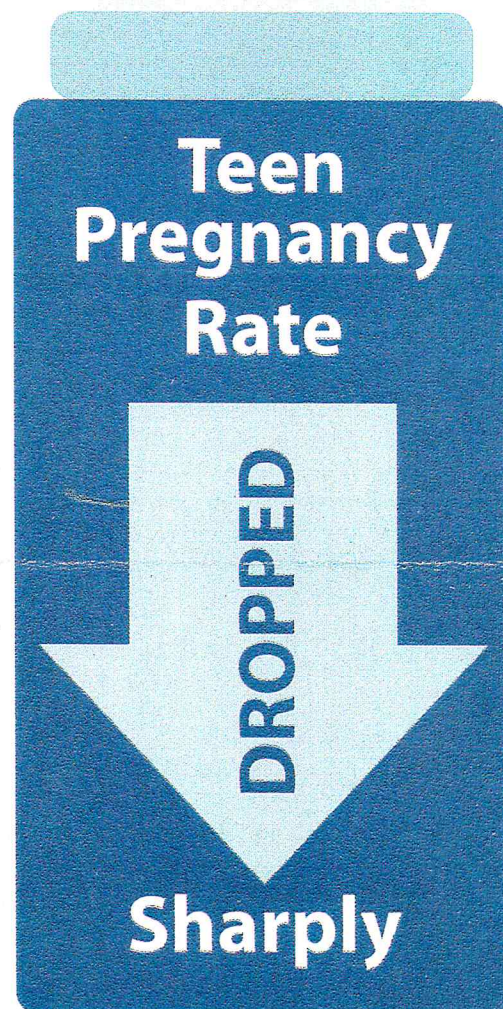
Data from the Repository were used to create this atlas report. The Need to Know Team worked with researchers at MCHP to decide what would be included. They also helped interpret the results. These team members will also help their colleagues across the province to use these new findings to "improve our game" in healthcare.

## What We Do Well

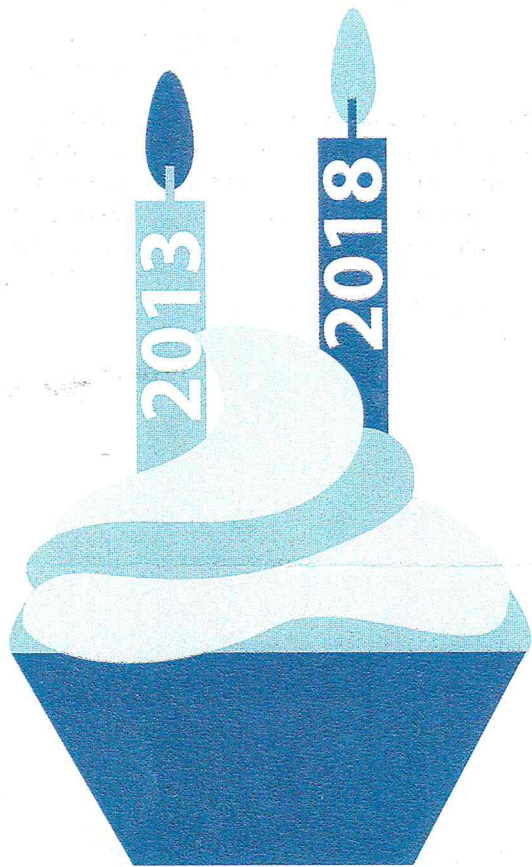
In the last RHA Atlas report, the health gap between the wealthy and the poor was widening. Since 2013, findings show that this gap is no longer widening. Rich or poor, urban or rural, when we look at Manitoba as a whole, everyone is living longer, which is very good news.

We also found that we are using hospitals less over time, and that hospital care remains closely matched to our need for healthcare. These trends are positive for our healthcare system.

Maternal and child health also showed improvement. Manitoba's teen pregnancy rate dropped sharply. It has been among the highest for Canadian provinces. More pregnant women are receiving good prenatal care. Infant mortality has decreased. The rate at which preschoolers had surgery to have multiple cavities removed has also decreased. All of these are good signs.

## Areas that Need Improvement

Typically, people who live in the poorest neighbourhoods are also the least healthy. Our healthcare system is meant to respond to need. In this system, we would expect people living in poorer neighbourhoods to use more health services. In many parts of the system like hospital care, this is exactly what we found. However, there were a few exceptions. The rate at which Manitobans consulted specialist physicians, received hip replacements, and got MRI scans all had the opposite trend. Manitobans in wealthier, healthier neighbourhoods received more of these services than those in lower income areas. These differences need more investigation to make certain healthcare access is fair for all Manitobans.

Even though this report showed that the gap in health status between rich and poor is no longer increasing, it's not shrinking either. Reducing those gaps should remain a key target for health system managers. Almost every disease we studied was more common in lower than higher income areas.

## The Bigger Picture

For most hockey teams, not all players are going to improve at the same time. In this report, we found a number of recent improvements along with a number of challenges for the healthcare system. Thankfully, we have an excellent team of experienced players, and an outstanding data system providing the evidence we need to work on those challenging areas. Let's take a moment to celebrate recent successes, then get back to work to address the areas that need more attention.

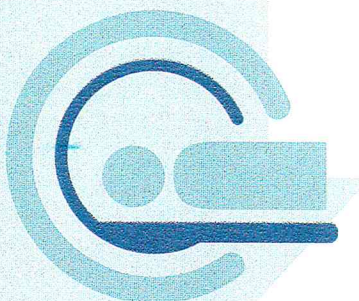

### **New Transportation Infrastructure Act – Fee Structure**

On June 4, 2018 the Manitoba government passed Bill 14, The Traffic and Transportation Modernization Act (TTMA). The Act was officially enacted on March 1, 2019 replacing various acts and regulations as part of a new regulatory framework. The changes support Manitoba government's plan to transform the management and administration of the Province's road network.

As a result of TTMA, The Transportation Infrastructure Act (TIA) came into force replacing The Highways and Transportation Act and The Highways Protection Act. As part of the changes, TIA includes administration fees which take into account the proposed location of third party utilities such as sewer and water distribution systems in provincial highway rights-of-way. The new fees are outlined on page 4 of Regulation 15/2019 and can be found at <https://web2.gov.mb.ca/laws/regs/current/pdf-regs.php?reg=15/2019>.

**PROVINCE PROVIDES LIVESTOCK PRODUCERS WITH FUNDING OPTIONS TO  
ADDRESS DRY CONDITIONS ON PASTURE**

The province is advising that livestock producers who have been affected by dry conditions on pasture can apply for funding to support water access and management under Ag Action Manitoba, Agriculture Minister Ralph Eichler announced today.

“We recognize that many producers are feeling the effects of our dry summer and that they may require additional assistance to secure a safe and reliable water supply for their livestock,” said Eichler. “Properly functioning and adequately protected ground and surface water sources are essential to ensuring the health of livestock and ground water sources.”

Funding is provided through the Managing Livestock Access to Riparian Areas beneficial management practice (BMP) under Ag Action Manitoba – Assurance. Eligible projects and related costs include:

- drilling new or deepening existing wells, test hole drilling, screening, casing, well caps and related activities;
- installing water pumps and required plumbing components and related activities, such as professional and contractor fees;
- constructing new or rehabilitating existing dugouts including professional and contractor fees; and
- establishing alternative watering system equipment and permanent fencing to restrict livestock access to surface water and dugouts.

To be eligible, applicants must complete an environmental farm plan (EFP) that will help manage risk on their farm related to water quality and supply, soil health, air quality and biodiversity. Producers have until Nov. 1, 2020, to submit their EFP statement of completion.

Ag Action Manitoba – Assurance: Beneficial Management Practices provides targeted incentive programs to agricultural producers and select industry service providers to advance the adoption of beneficial management practices (BMPs). These practices reduce identified environmental risks, improve agro-ecosystem resilience, build public trust and improve environmental sustainability of farm options in Manitoba.

Applications will be accepted and reviewed on an ongoing basis until Oct. 11. Priority will be given to applicants within federal tax deferral areas, as identified at [www.agr.gc.ca](http://www.agr.gc.ca) under Drought Watch.

## Frequently Asked Questions

### Why has Transport Canada introduced new regulations?

New regulations have been introduced to provide consistent grade crossing safety standards and to ensure that existing crossings are brought up to that standard.

### Which grade crossings need assessments?

All new or existing grade crossings must meet the new regulations, and it is the responsibility of rail agencies and municipalities to ensure that their crossings meet these standards. The easiest way to do this is through a grade crossing safety assessment.

### What does a grade crossing safety assessment entail?

The assessment starts with an initial desktop review, and then a field inspection that includes a review of the existing conditions, including signs, markings and sightlines. Following the field inspection, additional desktop research and analysis is completed, and a report and recommendations are developed.

### What is required by November 27, 2021?

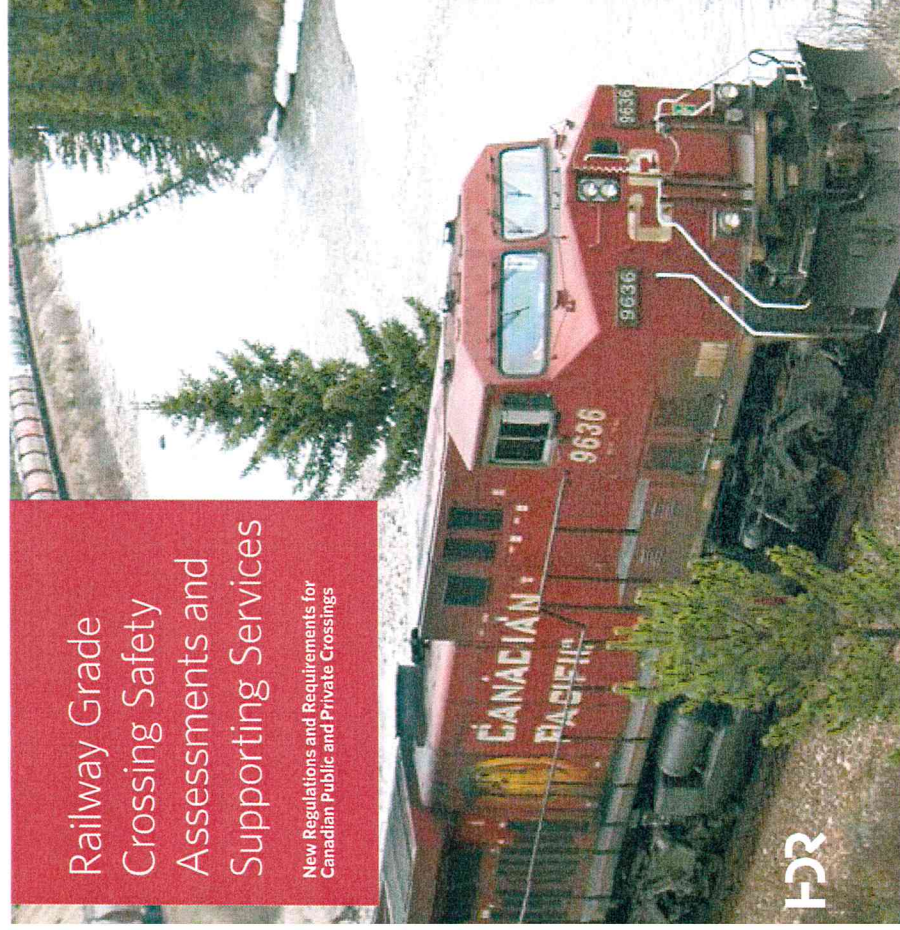
Grade crossings must meet the standards, with requirements varying depending on the type of crossing. Upgrades that could be required include signage, crossing surface improvements, warning systems, or grade separation.

### How long does the process take?

A grade crossing safety assessment can typically be completed within a month or two, and we can assess multiple crossings in parallel. When upgrading is required, the entire upgrading process can take between 6 to 18 months, dependent on the location and applicable railway agencies, as they may complete all detailed design and construction for the improvements.

### Are there funding sources available to help us upgrade our crossings?

Improvements costs will vary by crossing, and high level cost estimates can be provided following the grade crossing safety assessment. The good news is that there are funding sources available for rail agencies including the Rail Safety Improvement Program (RSIP). The fund is intended to address more safety issues, and recipients may be eligible for up to 80% of total project expenditures.





# New Transport Canada Federal Grade Crossing Regulations

## What You Need to Know

Transport Canada is requiring all new and existing grade crossings to be compliant with the new safety regulations by **November 27, 2021**.

The new legislation requires municipalities to review and assess the current state of their existing grade crossings to be compliant. If an deficient, municipalities and rail agencies are required to improve the crossings and bring them in line with the new safety regulations. In addition to understanding compliance with regulations, crossing assessments provide municipalities with an opportunity to identify issues and improve the safety of their crossings.

## What are the Goals of the New Regulations?

- Improve crossing safety
- Define the roles and responsibilities of respective parties in implementing crossing improvements

Federal funding is available through the Rail Safety Improvement Program (RSIP), and recipients may be eligible for up to 80% of total project expenditures.

## **REVIEW OF PETITION RE BARDING DOGS – CLEMENTI ROAD**

Existing dog by-law - #1228/2000

Agreement with Sola Dog Salon and Kennels to enforce By-law 1228/00 – dogs only. Have tried to reach the owners of the Salon on several occasions with no success.

Present dog control by-law does not limit number of dogs

Most offences referred to By-law 1228/00 apply mainly to barking, running at large, public nuisance or vicious dogs. These types of infractions are very difficult to enforce in court.

Zoning By-law – Home occupation in a Rural Zoning District is described as an occupation operated by members of the family residing at the same dwelling unit and shall not generate pedestrian or vehicular traffic or parking, in excess of that which is characteristic of the area in which it is located. I believe that this home occupation business meets these criteria.

Present situation: Council received a petition signed by several (15) ratepayers living along Clementi Road. Petition was received by Council at the regular meeting of September 17/19. Council heard from the petitioners and from the dog owner at the meeting. This matter was tabled to give administration more time to review the issue. Two main issues were raised at the meeting. 1. # of dogs on the property and 2. Constant barking of dogs.

The existing by-law does not limit the number of dogs one may have on his/her property. As previously stated, the existing by-law provides for several offences such as excessive barking, etc.

In my experience, any type of noise related by-law is very difficult to enforce in court. If the municipality were to charge the homeowner, the matter could eventually find its way into court. The municipality would have to absorb all the legal cost to proceed with this charge.

If council is of the mind to lay charges on this matter, I would suggest that a legal opinion be obtained to ensure that there are legal grounds to proceed and a reasonable rate of success.

I believe that council should authorize staff to proceed with the preparation of a new by-law which would be more up to date. Of course, any new by-law would not be applicable to this situation as this matter would be grandfathered. There are several municipalities which would have more up to date dog by-law who would be pleased to share with this municipality.

I have spoken to the dog owner to see if any progress/changes had been made. She mentioned that an exterior light has been installed, also cameras, and the inside of the shed where the dogs are sometimes kept has been insulated for sound proofing. There are 4 adult dogs and 2 puppies remaining on the property.

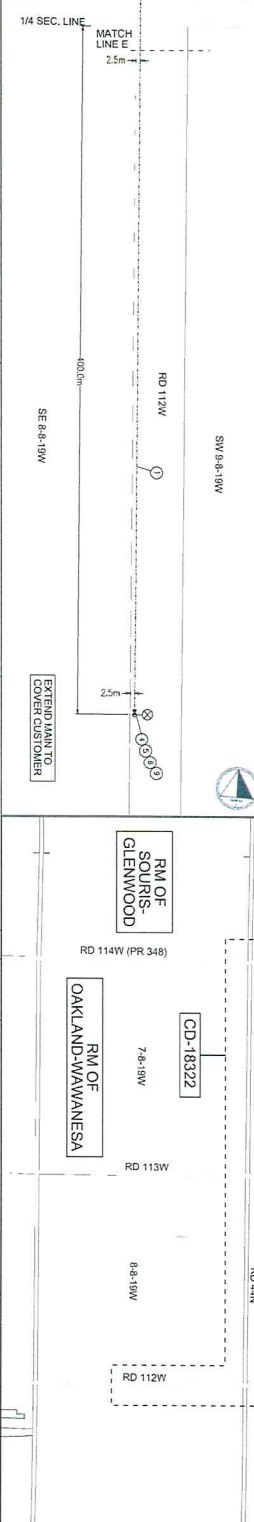
