#### Summary

All flow and water level information is based on data available at 7:00 am. Flood sheets
with updated information will be posted later today at

- The weather system affecting the USA portion of the Red River basin has shifted north slightly and is expected to bring up to 45 cm (18 inches) of wet snow today and tomorrow, with highest amounts in the south. The forecasted snowfall from this precipitation has been accounted for in the forecast for the Red River. Most of the precipitation yesterday occurred outside of the Red River basin.
- PR 204 has been closed west of PR 212, including the bridge connecting Selkirk and East Selkirk, because of high water levels. A partial ring dike closure at Morris is anticipated to occur on approximately April 18 and will result in the closure of PTH 75 North of Morris. #### Weather

- The weather system affecting the USA portion of the Red River basin has shifted north slightly and is expected to bring up to 45 cm (18 inches) of wet snow today and tomorrow, with highest amounts in the south. The forecasted snowfall from this precipitation has been accounted for in the forecast for the Red River. Most of the precipitation yesterday occurred outside of the Red River basin.
- A smaller weather system is expected hit much of southern Manitoba early next week but is forecasted to bring only 5-10 mm of precipitation.

#### Red River Basin

 The forecasted precipitation in the USA portion of the Red River basin has been factored into Manitoba's most recent forecast. In general, this precipitation event increased the forecasted peak slightly, closer to 2011 levels, and delayed the forecasted peak by a day or two. The additional volume of water may also slightly increase the duration of the flood event.

- Water levels on the main stem of the Red River in Manitoba continue to rise. The Red River at Emerson rose 1.2 feet and at Morris by 1.4 feet in the last 24 hours.
- Provincial crews are deployed in a number of communities in the Red River Valley
  preparing for potential ring dike closures and pumping operations to facilitate internal
  drainage. Partial ring dike closures are currently underway at Emerson and at St. Jean
  Baptiste, and the communities will remain accessible by road. Partial ring dike closures
  are also expected at Morris, Letellier, Ste. Agathe, and St. Adolphe. A partial ring dike
  closure at Morris is anticipated to occur on approximately April 17 and will result in the
  closure of PTH 75 North of Morris.
- Based on the revised forecast, the Red River Floodway is expected to begin operations
  after the weekend but may be delayed until ice is flowing freely at the Floodway control
  structure. Rising water levels at the Floodway Inlet may result in some water spilling
  naturally into the Floodway Channel prior to operation.
- The water level at James Ave in Winnipeg is 13.9 feet and, with operation of the Red River Floodway and provincial water control structures, is projected to peak at approximately 18.5-19 feet in late April. Ice is moving through the city with ice jams occurring at some locations but no problems have been reported.
- PR 204 has been closed west of PR 212, including the bridge connecting Selkirk and East Selkirk, because of high water levels.

#### Roseau River

 Water levels on the Roseau River continue to rise. The forecast has been reassessed to account for the winter storm in the USA portion of the basin, a peak flow of 3,800 cfs (110 cms) is expected April 20-22.

#### Assiniboine River Basin

- The Shellmouth Dam reservoir water level is at 1394.2 feet and the reservoir is rising towards the target water level range. Inflows to the reservoir are approximately 2,060 cfs (58 cms) and outflows are 25 cfs (0.7 cms).
- The current flow down the Portage Diversion is 460 cfs (13 cms). The Portage Diversion continues to be operated to limit flows on the Lower Assiniboine to less than 5,000 cfs (140 cms) to manage ice while it is still in place downstream. Crews continue to monitor ice conditions on this section of the river.
- Generally, flows and water levels upstream of Portage la Prairie have peaked and are beginning to decline. However, fluctuations to Portage Reservoir inflows and Portage Diversion flows are expected to continue occurring over the next several days as ice upstream of Portage La Prairie continues to break up.

#### Interlake Region

 Flows on the Icelandic and Fisher Rivers are low, with water levels at most points on the rivers stable or beginning to decline.  Outflow from Lake Manitoba is approximately 3,090 cfs (90 cms) through the Fairford River Water Control Structure.

#### Manitoba Lakes

- Generally, greater than 90% ice coverage is reported on larger Manitoba lakes, some smaller lakes in southern Manitoba, such as Pelican, Rock and Oak Lakes, have lost more ice, with approximately 2/3 of ice coverage remaining.
- The water levels on Manitoba's major lakes are relatively stable and within normal or desirable ranges. Today's water levels are as follows:

Lake Winnipegosis 831.8 feet

Lake Manitoba: 811.5 feet at Steep Rock

Lake St. Martin: 799.4 feet
Lake Winnipeg: 712.9 feet
Dauphin Lake: 854.5 feet

#### \*Definitions

Flood Warning: A flood warning is issued when river or lake levels are exceeding or are expected to be exceeding flood stage within the next 24 hours.

Flood Watch: A flood watch is issued when river or lake levels are approaching and likely to reach flood stage, but likely not within the next 24 hours.

High Water Advisory: A high water advisory is issued when a heavy storm or high flows are expected and may cause water levels to rise, but not necessarily reach flood stage. A high water advisory can be an early indicator for conditions that may develop into a flood watch or flood warning.







## BUILDING SUSTAINABLE COMMUNITIES PROGRAM

# How does this program relate to other community development programs that were available in previous years?

The Building Sustainable Communities program integrates seven formerly separate application-based programs and will streamline processes, add flexibility and reduce red tape for applicants from:

- · Community Places Program;
- Neighbourhoods Alive! Community Initiatives Program;
- · Neighbourhoods Alive! Neighbourhood Renewal Fund;
- Hometown Manitoba;
- Community Planning Assistance Program;
- · Community Support Small Grants Program; and
- Partner 4 Growth.

#### How much is government investing in this new program?

Budget 2019 sets aside a consistent level of funding that was budgeted in Budget 2018 for the application based grant programs – up to \$7.9 million.

#### What other community development support is available?

Manitoba remains committed to supporting non-profit organizations, recognizing the important work that takes place to promote thriving, sustainable communities.

In addition to the new Building Sustainable Communities Program, the department provides \$15.6 million to community organizations and initiatives. This includes the Urban/Hometown Green Team programs and the Emergency Capital program, which are continuing in 2019-20.

## PROVINCE STREAMLINES COMMUNITY DEVELOPMENT PROGRAMS

The Manitoba government has launched a new Building Sustainable

Communities Program that will streamline and modernize grant support to nonprofit organizations, Municipal Relations Minister Jeff Wharton announced today.

"Our government recognizes the importance of community development initiatives and supporting non-profit organizations," said Wharton. "This new program will support a broader range of community-led projects and deliver on our mandate to renew community development programs to best serve the needs of Manitobans."

The new \$7.9-million Building Sustainable Communities Program will transform and modernize grant funding with a focus on increasing community capacity and promoting sustainability for non-profit organizations. The new program replaces seven legacy grant programs that each had significant administration, rigid requirements and operated in silos. The overall funding levels for community grants remains consistent, the minister noted.

The modernized grant program will respond to local neighbourhood, municipal and regional priorities while providing a more comprehensive grant funding package to support a broader range of projects including planning, capital (construction), capacity building, and recreation and equipment purchases among others. The program will also reduce both applicant and administrative red tape and duplication, Wharton added.

"As an organization committed to the social and economic development of our community, we are proud of our long-standing partnership with the province, and delighted to see a realignment of government programming that we hope will

work towards greater efficiency, reduced red tape and stronger outcomes for communities," said Greg MacPherson, executive director, West Broadway Community Organization. "In particular, we applied the effort to streamline the application process, ensuring valuable time and energy is spent doing critical front-line work."

Eligible applicants for the new Building Sustainable Communities Program include non-profit organizations, charitable organizations, municipalities, and Northern Affairs Community Councils. The program will provide a maximum provincial contribution of up to 50 per cent of total eligible project costs to a maximum grant of \$75,000.

"The Association of Manitoba Municipalities is pleased to partner with the province in assessing the applications and making recommendations on the Building Sustainable Communities Program," said Ralph Groening, president, AMM. "These projects are essential in promoting economic development and sustainability throughout our province."

The new program will have two intakes per year at set times, providing predictable support and positive outcomes in communities. Successful applications will need to demonstrate how their projects provide an overall positive benefit for their community and partnerships are encouraged.

Results of Feasibility Study for Rural Water

As you will recall, Council at its meeting held December 18, 2018 reconsidered the matter of sending out a survey with respect to the above and adopted a motion outlining the questions to be asked, and that a minimum of 50 positive responses would result in the feasibility study going forward.

On March 5, 2019, 494 surveys were sent to rural ratepayers with a return deadline of March 26. There were 269 surveys returned by the deadline, equating to a 54.5% return rate.

The results of the returned survey were:

# of surveys answering "no" to both questions:	158
# of surveys answering "yes" to both or either questions:	108
# of surveys where neither no or yes were marked:	3

Included in the 108 surveys with a "yes" response, there were 61 surveys that indicated both quantity and quality issues. There were seven responses indicating water quantity issues, the remaining 40 had water quality issues.

Given Council's direction in December, I will contact The Water Services Board to keep this feasibility study in its list of projects.

SHSD Board of Trustees and Senior Admin Meet with Local MLAs

On January 23, 2019, MLAs Cliff Cullen and Doyle Piwniuk attended a supper meeting with Southwest Horizon School Division Trustees and Senior Administrators in the Southwest Horizon School Division Office in Souris. Trustees extended this invitation in order to highlight division successes and discuss the recently announced Education Review. Trustees emphasized the positives; the excellent staff who do an outstanding job, local school initiatives, and the many strengths of small schools in small communities.

The following is a summary of Trustee questions and the ensuing discussion.

What is your vision for rural education in Manitoba moving forward?

MLA Cullen

The big picture across government is that we have financial challenges and our ultimate goal is to leave more money in your pockets. We need to get back to a balanced budget. In terms of education, for whatever reason we are the lowest in the country. How can we focus on our kids for better outcomes? Do we have the right things in place?

The Education Review is a 6-month consultation and we want public input to tell us what their visions are and what would provide the best outcomes. Then we will need to go back and figure out the funding part.

MLA Piwniuk

Over the past year, our province has the most new agri-businesses, bringing in more local dollars. Outside investment wants to come to this province so we want them to invest and increase the populations.

MLA Cullen

Our taxpayers are spending a lot of money on education but what is the change to raise us to the top? Education is the path forward and is lifelong.

How do we attract more people if we have no healthcare or education in our communities? Funding based on enrolment isn't addressing the costs.

MLA Cullen

The funding process is broken so it is time to go back to that. Nobody is talking about closing schools. We have not predetermined anything.

What do you think is working in our current education system and what needs to be improved?

MLA Cullen

We have great people with a passion for education.

MLA Piwniuk

We know there are many success stories in southwestern Manitoba. It's important to share those success stories.

What is the overarching goal of the Education Review?

MLA Piwniuk

The Premier wants to see our results improve substantially to be the most improved province. At the same time, we want to put money into front line services.

MLA Cullen

We are looking for an accountability mechanism to tax payers and to our students.

Will the Provincial Government take into account that 50% of the factors affecting a student's success fall outside the school system? Poverty, mental wellness, social problems, etc.

MLA Cullen

This is a very valid point. Fundamental social issues in the province are not getting any better. Education is an out for a lot of the kids on the justice side. If we can get them the resources they need earlier they will have a better chance. We are making sure we invest in young kids. We know the challenges and the need to focus on early years.

What is the plan moving forward for future school boards?

MLA Cullen

This will be a big part of the discussion. We need to wait and see what Manitoba says.

MLA Piwniuk

That's why we are reviewing what has happened in other provinces as well.

How will you provide equity for rural students if you move to a centralized provincial budget?

MLA Cullen

We don't know what this will look like honestly. This is a good question. Times are changing and we need to be prepared for change.

MLA Piwniuk

We want to focus on the importance of farming and oil in rural Manitoba.

With regards to the Commission, what assurances can you provide to us that the rural voice will have an equitable voice? How will the Commission remain independent and objective?

MLA Cullen

There are more rural school divisions than urban so your voice will be heard. The commission will provide a report to the government and the government will look to see if they like the recommendations in it. I believe Winnipeg will be viewed through a different lens than rural Manitoba.

Considering the current Provincial Public hiring freeze, how does the Provincial Government expect improved results in public Education?

MLA Cullen

We have reduced the size of government by 8% on the senior bureaucracy side. We have not heard a public outcry that we are providing less services.

**Summary Statement** 

The cornerstone of society is education; the backbone of our rural communities that directly influence economic growth. Our schools are our communities and our future. This is our concern, not dollars and cents. Our communities will live and die by this budget and review.





#### **ACTIVITY UPDATE**

#### Support to Attract a World-Scale Soybean Processing Facility

I am writing to update you on the activities underway through the Westman Opportunities Leadership Group (WOLG) to attract a world scale soybean processing facility to Manitoba, and to request your support for our activities. Much work has taken place over the past year to bring a soybean processing plant to Manitoba:

- 1. A full strategic plan was delivered in the spring of 2018 that engaged all key service providers in the initiative, and who provided much effort and considerable time to support the process. The plan defined key requirements and respective roles and duties to attract a facility. The full report is available on line through the Rural Development Institute at Brandon University at <a href="https://www.brandonu.ca/rdi/attract-soybeans-mb/">https://www.brandonu.ca/rdi/attract-soybeans-mb/</a>
- 2. WOLG engaged Canada's global network of Trade Commissioners to identify companies of the right size, financial capacity and potential interest in establishing a facility. Three on-line seminars were held and approximately 80 commissioners around the world participated. A contact list has been created, and several companies already have indicated initial interest to learn more of the opportunity.
- 3. WOLG commissioned a full report by the Rural Development Institute of Brandon University that describes the soybean value chain. It clearly lays out the opportunities for a plant to locate into Manitoba, the markets for soy products and the local supply of soybeans that could feed a facility.
- 4. WOLG also created a "marketing document" which summarizes the opportunity and describes the community readiness of the Community Board members to support a plant of this nature.
- 5. Recent discussions with Manitoba Pulse and Soybean Growers confirmed their interest in a facility, and we are both committed to move forward together to support improved soybean varieties through Manitoba's Protein Advantage initiative.
- 6. Ongoing meetings with Minister Eichler and personnel from Manitoba Agriculture and other departments confirm the Province's interest in our work. We anticipate working with them in support of attracting an investor.

Over the next year the direct industry contact and attraction process will unfold. We will be short listing the companies, contacting them to describe the opportunity and inviting their own evaluation of the opportunity. As we have noted, WOLG is not interested in investing in a facility, and seek to have a private sector firm build the plant. And - the investing company will decide themselves on their best location.

This process then will be followed up by actual visitation with selected potential soybean crush facility investors -those who have been identified as best targets based on capacity to invest, have confirmed real interest, and with greatest potential will be engaged, and we will meet with them where they prefer (here in Manitoba or their own offices). This process requires real effort and significant funding which will require continued raising of funds to be accomplished.

As in 2018, we would like to invite your municipality to participate in this exciting endeavour. As an associate member, we would ensure that you receive all regular correspondence on the opportunity, be involved in regular updates, and are able to fully understand how many of the spin-off benefits that are expected to emerge can be best capitalized upon in your region. In particular, there will be opportunities tied to trucking, construction and hog sector expansion as reduced feed costs are expected to help spur industry growth.

Your support will also strengthen our ability to advocate for this initiative with provincial and federal governments. Associate membership and participation is requested at \$1.00 per capita, which is the same funding criteria developed for 2018.

### The Municipality of Oakland-Wawanesa

### By-Law No. 02-2019

### Fire Prevention and Emergency Services By-Law

Being a by-law of the Municipality of Oakland-Wawanesa to provide for fire fighting, fire prevention, the related regulation of fire and other hazards, the adoption of the Code, and for establishing, continuing and operating an emergency service for the Municipality, and to be known as the "Fire Prevention and Emergency Services By-Law";

WHEREAS subsection 232(1) of the Act provides that a council may pass by-laws for municipal purposes respecting the following matters:

- (a) the safety, health, protection and well-being of people, and the safety and protection of property;
  - (i) preventing and fighting fires;
  - (ii) the enforcement of by-laws;

AND WHEREAS section 264 of the Act provides that every municipality must provide fire protection services within its boundaries to reduce the danger of fire, which may include education programs, inspections of property, the installation of alarms, instructions on fighting fires, the provision of fire fighting equipment and a fire protection force;

AND WHEREAS section 268 of the Act provides that a fire protection force may, with the approval of the council, provide other services, including the prevention and release of illness and injury and the preservation of life and property;

NOW THEREFORE the Council of the Municipality of Oakland-Wawanesa, duly assembled, enacts as follows:

### PART I: INTERPRETATION AND DEFINITIONS

### Interpretation

1. It is the purpose of this by-law to establish the standards for fire prevention; fire fighting and life safety in buildings; the prevention, containment and fighting of fires originating outside buildings which may present a hazard to all or any part of the Municipality; the operation of Emergency Services and the transportation and storage of flammable and combustible substances.

### Definitions

- (a) Unless otherwise provided, or unless the context otherwise requires, words and expressions in this by-law have the same meaning as the same words and expressions in the Act and in the Code.
  - (b) In this By-law, words importing the singular number only shall include the plural and vice versa, and words importing gender shall include all genders.
  - (c) In this by-law:

"ACT" means The Municipal Act S.M. 1996, c.58, C.C.S.M. c.M225 as amended from time to time.

"AUTHORITY HAVING JURISDICTION" means the Fire Chief, acting Fire Chief, deputy Fire Chief, or the responsible Municipal, Provincial, or Federal official with legal authority for controlling the subject referred to including, without restricting the generality thereof, municipal Fire Prevention Officers and Fire Inspectors.

"CODE" means the Manitoba Fire Code being Regulation No. 163/98 of The Fire Preventions Act, RSM c.F80, C.S.S.M. c.F80, as amended from time to time, or any subsequent Manitoba Fire Code which may be enacted.

"COUNCIL" means the council of the Municipality.

"EMERGENCY SERVICES" includes, but is not limited to, all fire protection services and all services provided at the site of an emergency for the purpose of preserving life and property and protecting persons and property from injury or destruction by fire, preventing and extinguishing fires, investigating the cause and origin of fires, providing rescue services, providing emergency medical responses, in assistance with the Provincial & PMHA EMS, purchasing and operating apparatus and equipment for fire fighting and the preservation of life and property, and preventing and mitigating other potential risks to life and property as defined by Council.

"FIRE CHIEF" means the Fire Chief for the Municipality and any one acting or authorized to act on his behalf.

"FIRE DEPARTMENT" means the Fire Department for the Municipality, and includes any part-time, composite (any combination of full-time, part-time or volunteer) or a volunteer fire department.

"FIRE FIGHTER" means any member, including volunteers, of the Fire Department while their services are actually engaged by the Municipality for the purpose of providing Emergency Services or otherwise enforcing the provisions of this by-law.

"FIRE INSPECTOR" means the person or agency employed by or acting for the Municipality and partially or wholly responsible for fire safety within the Municipality.

"MUNICIPALITY" means Municipality of Oakland-Wawanesa.

### PART II: ADMINISTRATION

Adoption of Fire Code

3. The Municipality hereby adopts the Code as part or this by-law, and the whole thereof, save and except such portions as are hereinafter deleted, modified or amended, and is hereby incorporated as if fully set out at length herein. Any reference to this by-law shall be construed as a reference to the whole by-law, including the Code.

### Recovery of Costs

4. Subject to any agreements to the contrary, where any type of Emergency Services have been taken within the Municipality, including responding to a false alarm, the Municipality may, in respect of any related costs incurred in taking such action, charge such costs to the person who caused the fire or incident, or the owner or occupant of the land or property in respect to which the action was taken. Further, the Municipality may proceed to collect any costs as against the person by any means available to it in law for the collection of outstanding taxes, including, without limitation, adding the costs to the realty taxes on any property owned by the person within the Municipality.

### PART III: CREATION OF FIRE DEPARTMENT

Creation and Membership

5. There is hereby created a Fire Department for the Municipality, to be comprised of a Fire Chief and such other Fire Department personnel as from time to time may be deemed necessary by the Fire Chief; provided however, the Fire Department shall not be comprised of less than Six (6) personnel at any one time.

Responsibility of Fire Chief

6. It shall be the responsibility of the Fire Chief to administer and enforce the provisions of this by-law; subject always to such direction as may from time to time be given by the Council.

### PART IV: EMERGENCY SERVICES

**Emergency Services** 

7. The mandate of the Fire Department is to provide the specific Emergency Services as described in Schedule "B" to this by-law.

Agreement for Emergency Services

8. The Municipality may elect to enter into an agreement with another Municipality to provide or have provided Emergency Services. Such agreement requires prior authority of the Council.

Response outside Municipality

- 9. The Fire Department will not respond to any call with respect to a fire or an emergency outside the municipal boundaries except with respect to a fire or emergency:
- (a) that in the opinion of the Fire Chief threatens property in the Municipality or property situated outside the Municipality that is owned or occupied by the Municipality; or
- (b) in a Municipality with which an agreement has been entered into to provide fire protection services or Emergency Services; or
- (c) in a Municipality which forms part of a mutual aid agreement for which the Municipality is a member; or
- (d) on property with respect to which an agreement has been entered into with any person or corporation to provide fire protection therefor; or
- (e) for which Council has first authorized such attendance; or
- (f) under such circumstances as it appears human life is in jeopardy;
- (g) upon request for assistance from the Office of the Fire Commissioner or some other properly designated office of the Province of Manitoba and shall remained covered under the Municipality Insurance programs while doing so.

### PART V: GENERAL REQUIREMENTS

Interference an Offence

10. It shall be an offence for any person, other than the Authority Having Jurisdiction or a Fire Fighter in the course of duty, to turn on or interfere with any fire hydrant, in any manner whatsoever.

### Tampering an Offence

11. It shall be an offence for any person to tamper with, damage, or discharge any fire prevention, fire suppression, or rescue apparatus, or move any such apparatus from its allocated location, without the permission of the Fire Chief.

### Requiring Additional Assistance

The Fire Chief, or in his absence, the senior officer of the Fire Department present at any fire or providing any other Emergency Service, shall have the right and authority to require any able-bodied adult person to assist in extinguishing fires, to assist in the control of spread of fire and to assist in any other required Emergency Service and any such person, while acting under the direction of the Fire Chief, shall be deemed a volunteer of the Municipality.

### Commandeering Equipment

The Fire Chief, or in his absence, the senior officer of the Fire Department present at any fire or providing any other Emergency Service, shall have the right and authority to commandeer and authorize payment for the possession or use of any equipment for the immediate purpose of fighting a fire or providing any other Emergency Service.

### PART VI: FIRE PREVENTION STANDARDS

### Access for Inspection

14. The Authority Having Jurisdiction may, at all reasonable times, enter any premises for the purpose of making an inspection, and any person in charge of the premises shall allow the Authority Having Jurisdiction free access thereto.

### Prevention of Fire Spread

15. The Fire Chief, or in his absence, the senior officer of the Fire Department present at any fire shall have the right and authority to enter, pull down or demolish any house or building or structure, directly or indirectly affected, where deemed reasonably necessary for the purpose of extinguishing a fire or to control or prevent the spread of fires or in conjunction with dangerous goods or rescue.

### Storage of Containers

- 16. All boxes, crates, petroleum barrels and other containers, empty or otherwise, packing materials, or other materials used or kept in any building or on any lot, shall be:
- (a) so stacked or piled as to keep them clear of windows and doors to provide for clear ingress and egress to and from any part of the premises or building;
- (b) kept away from any source of ignition;
- (c) removed forthwith if determined to constitute a fire hazard by the Authority Having Jurisdiction to such location as authorized by the Authority Having Jurisdiction.

### Portable Fire Extinguishers

- 17. Portable fire extinguishers shall be:
  - (a) provided and located in accordance with the requirements of the Code;
  - (b) maintained and/or hydro-statically tested in accordance with the requirements of the Code.

### Chimney Pipes

18. All chimneys and pipes for fireplaces or wood stoves shall be installed in conformance with the Code and must be cleaned regularly to prevent a buildup of creosote. Where the Fire Chief deems it necessary he may give notice to any owner requiring the cleaning of any chimney or pipe and where such order is not complied with within ten (10) days the Fire Chief may cause the work to be done and the cost therefor shall be the responsibility of the owner.

### Property Maintenance

19. All buildings and properties shall be adequately maintained in order to guard against fire or the risk of fire.

### Fire Alarm Systems

- 20. (a) Every fire alarm system shall be maintained at all times in operating condition and tested by a qualified person in accordance with the requirements of the Code;
- (b) Where the Fire Department attends in response to a fire alarm call which is an apparent false alarm, the Fire Chief, or in his absence the senior officer of the Fire Department present at the scene, will attempt to contact the property owner or other designated person to attend and secure the premises. Where unable to contact the property owner or designated person, then a security guard may be called in to perform fire duty at the expense of the owner. The total cost of restoration of any fire alarm equipment, and related costs of hiring a security guard or any firewatch service, shall be the responsibility of the owner or his insurer. If the owner cannot be located to pay this bill then all costs may be added to the real property taxes for the premises and collected in the same manner as normal taxes.

Flammable and/or Combustible Liquid Storage and Storage of Hazardous Materials

21. Prior written permission from the Fire Chief shall be required for the storage of flammable and/or combustible liquids or hazardous materials in excess of the amounts permitted in the Code.

### PART VII PENALTY PROVISION

### Penalty

- 22. (a) An order made under this by-law shall be in writing and signed by the Authority Having Jurisdiction. An order may be directed to the owner, occupier or lessee of the subject building or property in respect of which it is made or to any or all of them.
  - (b) Any order made under this by-law shall be served:
    - (1) personally upon the person to whom it is directed; or
    - (2) by registered or regular mail; or
  - (3) by posting a copy of the order in a conspicuous place on the building or property if the person to whom it is directed cannot be found, is not known, or refuses to accept service of said order.

In the case of service by regular mail the order shall be deemed to have been received on the fifth business day subsequent to the date it is mailed.

- (c) Any person who contravenes or disobeys, or refuses or neglects to obey:
- (1) any provision of this by-law, or any provision of any other by-law that by this by-law is made applicable to proceedings taken or things done under this by-law; or

- (2) any provision of any by-law, Regulation or Order enacted or made by Council; or
- (3) any Order made by this by-law;

for which no other penalty is specifically provided is guilty of an offence and is liable, on summary conviction, to a fine of \$500. or to imprisonment for a term of not more than three months, or both.

(d) Any person who hinders or obstructs the Authority Having Jurisdiction in the exercise of his duty is guilty of an offence and liable on summary conviction to a fine of not less than \$100.00 or more than \$1,000.00, and in default of payment of the fine, to imprisonment for a term not exceeding fourteen (14) days.

### PART VIII: REPEAL AND ENACTMENT

### Repeal

- 23. (a) By-law No. 448 together with amending by-law no(s), be and the same (is/are) hereby repealed.
- (b) The repeal of the by-law(s) in the last preceding subsection mentioned shall not revive any by-law or any provision of any by-law repealed by (it / them), nor shall the said repeal prevent the effect of any saving clause in the said by-law or the application of the said by-law or any other by-law or provision of law formerly in force to any transaction, matter or thing anterior to the said repeal to which they would otherwise apply.
  - (c) The repeal of the said by-law(s) should not affect:
  - (1) any penalty, forfeiture or liability incurred before the time of such repeal, or any proceedings for enforcing the same had, done, completed or pending at the time of such repeal; or
  - (2) any action, suit, judgment, decree, certificate, execution, process, order, rule or any proceeding, matter or thing whatever, respecting the same had, done, made, entered, granted, completed, pending, existing or in force at the time of such repeal; or
  - (3) any act, deed, right, title, interest, grant, assurance, registry, rule, regulation, contract, lien, charge, matter, or thing had, done, made, acquired, established, or existing at the time of such repeal; or
  - (4) any office, appointment, commission, salary, allowance, security, duty, or any matter or thing appertaining thereto at the time of such repeal; or
    - (5) any bond, note, debenture, debt, or other obligation made, executed, or entered into by the City at the time of such repeal.
  - (d) The repeal of the said by-law(s) shall also not defeat, disturb, invalidate, or prejudicially affect any matter or thing whatsoever had, done, completed, existing or pending at the time of such repeal.

### Enactment

24. This by-law shall come into full force and take effect upon the passage

- (k) vehicle extrication;
- (1) farm accident rescue;
- (m) ground search and rescue locally or provincially requested
- (n) trench rescue with assistance of Mutual aid system
- (o) biological and chemical responses;
- (p) fire prevention inspections;
- (q) pre-fire planning;
- (r) public safety education;
- (s) precautionary standby;
- (t) extinguishing and prevention of grass fires;
- (u) extinguishing and prevention of urban interface fires;
- (v) flood response;
- (w) response to any request that the Fire Department deems an emergency, including but not limited to, CO alarms, animals in peril and gas odours.

### RCMP's Planned Initiatives to Meet Objectives, Priorities and Goals:

### 3.1.1 OBJECTIVE:

Traffic Enforcement (Impaired Drivers, Intersection Violations)

### Initiative #1:

Internal Education.

With the high level of junior members and a varied cycle of transfers, it is always important to ensure the current members are aware of Area goals and objectives. These goals and objectives are tied directly to performance evaluations and assessments. This issue is routinely discussed individually and in group settings, as well as being provided in written format.

### **Current Status and Results:**

All members are aware and participating at various levels. See attached Mayor's report for details.

### Initiative #2:

Check Stops and Proactive Enforcement.

Proactive enforcement continues as time allows. We have had 3 check stops in the Blue Hills Area over the last reporting period.

### **Current Status and Results:**

See subsection 4.

### 3.1.2 OBJECTIVE:

Crime Reduction.

### Initiative #1:

Criminal Condition Compliance Checks (Street Enforceable Conditions)

### **Current Status and Results:**

By mid year we ended up with only 1 person on suitable conditions for regular monitoring. Down from three. We recorded 17 checks over the year.

### Initiative #2:

Community Mobilization Referrals.

### **Current Status and Results:**

We referred 20 individual cases to the community mobilization group. Our goal was set at 48 referrals. Suitable candidates were not available. I take this as a measure of success with the program. Ideally we are removing people from police involvement in non police matters and funneling then into the appropriate areas for assistance.

### Initiative #3:

Restorative Justice Referrals.

### **Current Status and Results:**

Over the year we referred 7 cases to this program. We beat our goal by two referrals. This is a valuable program and finding eligible cases is difficult. As a unit we are looking to increase our involvement in this area as it is effective when utilized and reports indicate the involved parties are more satisfied with the results as compared to traditional court results.

### 3.1.3. *OBJECTIVE*:

Internal/External Communications.

### Initiative #1:

Have 4 internal quarterly meetings. This helps ensure everyone is on the same page with objectives and requirements.

### **Current Status and Results:**

Four meeting were held and we met our yearly goal in this area. Internal communications remain at a high level with NCO's implementing a "call anytime" strategy along with open door policies.

### Initiative #2:

External Communications.

Current goal is set for 1 contact per council per quarter.

### **Current Status and Results:**

We beat our goal for the area on this objective by a wide margin. We recorded 111 visits over all councils for the year. This includes attending meetings and various casual pop ins and informal visits.

TITLE: GRANT REQUEST POLICY

### **PURPOSE**

This policy details the guidelines and process to be used by Council to approve and administer requests for grants that do not show as an independent line item in Council's budget.

### **PREAMBLE**

Council has passed a resolution to only consider grant requests at the February meeting each year will consider all grant requests once each year, in conjunction with adoption of its annual budget.

### **POLICY**

To be eligible for grants from the Rural Municipality of Oakland, all of the following conditions must be met:

- All organizations must be non-profit organization;
- Organizations must be located within the municipality unless they provide a direct benefit to the ratepayers and/or residents of the Municipality;
- Grants may be used for capital or operational purposes;
- Each organization, if approved, may only receive one grant per year

### Funding will not be considered in the following instances:

- Only an individual will benefit (i.e. gifts for socials, reunions etc.)
- Political organizations or groups
- For-profit organizations
- Provincial, national or international charities

### APPROVAL PROCESS

Information will be posted on the Municipal website and Face Book page in January of each year for interested organizations.

The applying organizations are required to produce a written request and should include the following:

- 1. A description of the organization and its purpose.
- 2. Names of the principal officers.
- 3. Mailing Address.
- 4. Intended use of the funds accompanied by current financial statement.
- 5. Reasons in support of the request.
- 6. Cemeteries will be exempt from these provisions.

All requests must be received by February 15 in each year in order to be considered.

Administration will forward these requests to Council for approval by resolution consistent with the budgeted amounts.

### **CRITERIA**

Approval of each grant request is an objective act by Council and each request will stand on its own merits. At minimum, Council will take into account the following criteria:

- a) Precedent has a grant been made for this purpose before;
- b) Local impact will the grant benefit the community;
- c) Neighbourhood fairness overall and over time, grants should affect the entire municipality fairly;
- d) Degree of need does the requestor deal with fundamental problem;
- e) Financial need how badly does the requestor need the grant; and
- f) Funds remaining is there any money left in the grants account.

The cheque for the approved amount of the grant will be issued to the organization within 30 days of the receipt and approval. Council approval.
