Imperial Oil Pipeline Maintenance Update

March 20, 2024 - Please be advised that the AMM acknowledges that the Province of Manitoba has <u>issued a statement</u> regarding the temporary shutdown of a pipeline that supplies gasoline to Winnipeg and surrounding areas.

In response, our association has reached out to Manitoba Municipal and Northern Relations to inquire about anticipated impacts on municipalities. We are monitoring the situation and are committed to assisting the Province as they maintain communications with local communities.

Additionally, our organization has reached out to Canoe Procurement Group of Canada to address any potential concerns regarding AMM's fuel supply offered through the program. Imperial Oil has assured Canoe that they have implemented contingency plans, ensuring uninterrupted bulk fuel supply for program members.

March 18, 2024 - The Association of Manitoba Municipalities (AMM) is pleased to host the online NAMS+ Asset Management Training Program presented by NAMS Canada. This is a proven training program designed specifically for municipal government employees to integrate the efforts of the disciplines of public works, finance, administration and political leaders towards preparing an Asset Management Plan for the organization.

Throughout the training, you will have the opportunity to "learn by doing" by utilizing your organization's own asset data and the NAMS+ templates and modelling tools. The course was designed based on internationally accepted Asset Management best practices specifically as outlined in the International Infrastructure Management Manual (IIMM) and all training material is aligned with ISO 55000.

By attending the course sessions, and keeping up with the homework activities, **you will have drafted** an asset management plan for one asset class and be well equipped for moving forward with implementing an Asset Management system for your organization.



April 3, 2024 – Please be advised that the provincial government has tabled **Budget 2024**. Preliminary observations include:

Highlights:

- Due to our advocacy efforts, the Province of Manitoba has increased both the Municipal Operating basket from \$217M to \$221.1 (an increase of \$4.4M) and Strategic Infrastructure Basket from \$160.4M to \$163.7M (an increase of \$3.3M), representing an overall increase of 2 per cent to both baskets;
- **\$24M** for the Manitoba Water Services Board (up from \$20M);
- **\$8.5M** for provincial infrastructure maintenance, including highways and **\$850,000** for water maintenance initiatives which includes third order drains;
- \$4M in new, annual and sustainable funding for Sport and Cultural organizations;
- \$1.2M to implement a new public libraries funding model;

- \$730,000 increase to support the Urban and Hometown Green Teams Program;
- **\$500,000** for the Aquatic Invasive Species (AIS) Program to more effectively prevent and slow the spread of AIS;
- **\$200,000** to reopen two Manitoba Agricultural Services Corporation (MASC) service centres (locations will be determined in consultation with communities);
- **\$135,000** for implementation of a veterinary strategy to help address a shortage of veterinary professionals in Manitoba;
- A new \$1500 Homeowners Affordability Tax Credit starting in 2025;
- Extending the Gas Tax Holiday by an additional 3 months which equates to an **estimated \$3.75M in lower costs** for the duration of the freeze and;
- Investing a record \$8.2B in Health, Seniors and Long-Term Care which includes \$309.5M to retain, recruit and train more healthcare workers to address healthcare shortages.

As inflation has significantly impacted municipal budgets and municipalities are not permitted to run deficits, the additional 2% boost in operating funding is appreciated. However, while we acknowledge this positive step, we believe the Budget falls short in fully addressing the pressing needs and priorities of municipalities.

While the increased funding allocated to municipal operating and strategic infrastructure baskets is welcomed, our concern lies with the stagnant allocation in the public safety basket. While the Budget acknowledges the \$13.7 million increase to urban policing grants, this reaffirms last year's increase, and there is no percentage increase included in Budget 2024. This is particularly troubling as we witness a rise in crime across our province.

Moreover, the Budget documents commit to working with AMM and other municipal stakeholders to develop a reliable and flexible multi-year funding model that works for all municipalities. We look forward to working with the Province on this initiative over the coming weeks and months.

The AMM will continue to track this year's budget and provide timely updates to our members as new information is discovered. We will also continue to advocate on issues highlighted in our **pre-budget submission**.

Good Day,

My name is Sandy Hutchison, I am the Manitoba-Saskatchewan rep for Health Canada's National Radon Program. As the leading cause of lung cancer in Canada after smoking, radon exposure is a serious health risk. Health Canada estimates over <u>3,000 Canadians</u> die from radon-induced lung cancer each year. The good news is that elevated exposure to radon is preventable.

Based on scientific evidence Health Canada reduced the Guideline for Radon in Indoor Air from 800 Becquerels per cubic metre (Bq/m³) to 200 Bq/m³ in 2007. Since then we have led extensive public educations programs, conducted testing in homes across the country; as well as, developed and validated technical guidance to ensure clear standards for how radon is measured and mitigated.

The Prairies are known to be one of the most radon-prone regions in the entire world. I'm reaching out to offer support with <u>educational resources</u>, <u>testing data</u> and <u>planning guidance</u> so that your Municipality can contribute to a healthier built environmental for its citizens.

How can your Municipality take action on radon?

All levels of government can take action to help reduce the risk of radon exposure, from planning and policy to education and enforcement. Thank you to all those who are already taking action. Here are a few more ideas to kick start your municipality's 2024 radon action plan:

- Include radon information on your website
- Run a regional awareness campaign
- Lend electronic radon monitors
- <u>Test</u> public buildings
- Participate in the <u>100 Radon Test Kit Challenge</u>. Applications are currently open for participation in the Fall 2024 campaign!
- Educate and enforce radon provisions in existing Building Code and consider options to <u>exceed the minimum</u>
 <u>requirement</u>

Important Notice to All Elected Officials and Chief Administrative Officers

Winnipeg Pipeline Repair Event

Manitoba EMO is coordinating the Manitoba government's response to Imperial Oil Ltd.'s ongoing maintenance work on a pipeline that runs between Gretna and a Winnipeg terminal that provides gasoline, diesel, and jet fuel to customers in Winnipeg and the surrounding area.

Imperial Oil's decision to shut down the pipeline and undertake repairs was made after preventative maintenance and proactive pipeline inspections identified integrity concerns in a section of pipe just south of St. Adolphe. The line was not compromised, and no materials were spilled into the environment. The province is engaged in oversight of the repair work to ensure necessary precautions are taken to protect the surrounding environment.

The Manitoba government issued a <u>Petroleum Bulletin</u>, which contains additional details on this event. Additional bulletins may be issued as the situation evolves.

Manitoba EMO advises you to reach out to your Regional Emergency Manager should you have additional questions about this work.

Important Notice to All Elected Officials and Chief Administrative Officers

Revised Planning Act Handbook Reflecting Legislation Currently in Effect

Manitoba Municipal and Northern Relations has released Version 2.0 of The Planning Act Handbook to reflect all remaining legislative amendments passed and proclaimed under The City of Winnipeg Charter Amendment and Planning Amendment Act (S.M. 2022, c.27) as of September 1, 2023.

The Planning Act Handbook provides a general plain language overview and summary of The Planning Act, which establishes the legal framework for planning in Manitoba excluding the City of Winnipeg, whose planning framework is established under Part 6 of The City of Winnipeg Charter.

The purpose of the Handbook is to help communities navigate land use planning processes and guide municipalities and planning districts in completing the minimum requirements for land use planning as required in The Planning Act. The Planning Act Handbook can be downloaded from the department's website here:

Key changes to The Planning Act now incorporated into Version 2.0 of the Handbook include:

- The enabling of planning regions, including the Winnipeg Metropolitan Region;
- New mandates for planning regions, including authorities granted to planning region boards, and requirements regarding the adoption of regional plans;
- Clarification of timelines for application processing and planning appeals, including the ability to extend with the agreement of the applicant;
- Changes to deadlines to The Municipal Board for appeals concerning subdivisions, aggregate quarries and large-scale livestock operations; and
- Changes to extensions allowed for an approved variance.

In addition, this revised version of the Handbook further enhances clarity to existing sections based off of feedback received from various users since its initial release, as well as from an internal review of the guide.

It is the department's intention to maintain the Handbook as a living document, with regular updates to ensure it reflects up-to-date legislation and addresses pertinent land use planning issues. Municipalities and planning districts are welcome to provide suggestions for improvements to the Community Planning Branch (contact information below).

A French translation is currently in development, and will be posted on the website when complete.


