\$3M for Spring Flood Preparedness

On February 12, 2020, the Manitoba government formally invited all municipalities to submit proposals for one-time funding to support and enhance municipal capacity and

capability to prepare for a possible 2020 spring flood emergency, and to build resiliency for future floods.

<u>Province of Manitoba Press Release</u> 2020 Flood Preparedness Program

Under the program, municipalities can be reimbursed for up to **100 per cent** of approved flood preparedness or resiliency projects and equipment costs. The maximum funding available for each municipality will be based on the total value of all approved proposals, but up to \$150,000 may be available for each municipal proposal. Consideration will be given for funding of up to \$500,000 for the City of Winnipeg should flood risk warrant additional investment.

Please note that **proposals are due by February 28, 2020**, and must be submitted by email to mrmca@gov.mb.ca.

Closure of Dauphin Correctional Facility

The Board reviewed the provincial government <u>press release</u> announcing the closure of the correctional facility in the City of Dauphin.

When this news was announced, the AMM immediately reached out to the City of Dauphin and surrounding municipalities to offer assistance and help seek additional information from the Province of Manitoba to better understand this decision.

As the planned closure of this correctional facility will have ripple effects throughout the Parkland and across Manitoba, the AMM Executive requested and held a phone call with Minister Cullen to voice concerns, including the need to be transparent and proactively communicate any changes to correctional facilities in affected municipalities. The AMM Executive will also be raising this issue again during their upcoming annual meeting with the Minister.

The AMM has strongly urged the Province to increase investments in local communities by building new or upgrading/re-purposing existing buildings, communicate their overall plan for these types of facilities and how other facilities in other parts of

Manitoba may be affected, and leverage potential funding opportunities with the federal government to ensure impacts on local jobs and families are mitigated.

FCM Western Economic Solutions Taskforce (WEST)

On February 10, 2020, FCM's <u>Western Economic Solutions Taskforce (WEST)</u> gathered in Alberta for a full-day summit, bringing together key municipal and federal decision-makers to tackle the economic uncertainty facing western communities.

Taskforce members discussed solutions—short, medium, and long-term—to the challenges facing western communities. They also met directly with senior federal officials, including Deputy Prime Minister Chrystia Freeland, Transport Minister Marc Garneau, Economic Development Minister Mélanie Joly, and several opposition Members of Parliament.

In the coming months, WEST will continue to propose a full range of concrete recommendations for the federal government to adopt—and for municipalities across the country to share and build on.

Cleanfarms currently has offices in Quebec, Ontario and Saskatchewan.

The Lethbridge office will be staffed by Davin Johnson, an environmental scientist who



grew up in Alberta and has worked for the past decade in the province's oil and gas, academic, government and agricultural sectors. He holds a Bachelor of Science in Geography from the University of Lethbridge.

Already familiar with Cleanfarms programs, Davin has helped to organize Cleanfarms' Unwanted Pesticide and Livestock/Equine Medication Collection program, which collects old and obsolete pesticides and animal health medications from farmers for safe disposal, and the newly launched 'Alberta Ag-plastic. Recycle it!' pilot program that has commissioned 20 locations throughout the province to collect grain bags and twine for recycling. Cleanfarms operates the pilot on behalf of the Alberta-based Agricultural Plastics Recycling Group.

"With the grain bag and twine recycling program now underway in a progressive province that is evolving waste management and producer responsibility programs, it's a logical and important next step for Cleanfarms to have an Alberta-based office," Friesen said.

Cleanfarms, which is celebrating its 10th anniversary this year, is the only industry funded organization working across Canada that develops and operates waste product and packaging stewardship for the agricultural community. It utilizes a vast network of industry distributors, ag-retailers and in Alberta and Manitoba, municipalities, to operate collection sites where farmers can take ag-waste plastics and other non-organic, ag-waste materials for recycling or proper disposal.

Cleanfarms was established specifically to run the successful small jug recycling program originally created in 1989. The jug recycling program is Cleanfarms' signature national agricultural recycling program with a 65% recovery rate. Other ag-waste management programs include:

- Empty pesticide and fertilizer containers for large containers, e.g., totes and barrels, operated nationally
- Unwanted and old pesticide and livestock/equine medication collection, operated nationally
- Empty seed and pesticide bags collected in eastern Canada with pilot programs underway in the Prairies, and
- Empty grain bag collection now in its third year of operation in Saskatchewan.

Cleanfarms is a non-profit industry stewardship organization committed to environmental responsibility through the proper management of agricultural plastic packaging and product waste. 

With a federal budget on the way, municipal and federal leaders gathered in Leduc, Alberta last week to explore solutions to the economic uncertainty facing many western communities. 





This report is the first of its kind to quantify the cost for municipalities: an estimated \$5.3 billion per year, or equivalent to 0.26% of Canada's GDP.





Celebrating women in local government, in Canada and around the world

FCM and the Government of Canada continue to work together to ensure all women can participate in the political life of their community, both in Canada and overseas.

To achieve gender equality and open doors for women across all diversities, we need women in leadership roles. Through our women in local government initiatives, FCM helps support women from all backgrounds increase their knowledge, build their capacity, and become leaders in their communities.

Training, education & resources

Education, capacity building, training and workshops are core tenants of our international programming. At FCM, we see our role as helping to increase the knowledge and capacity of women local elected

officials, so that they can have a greater impact on their community and help address the challenges faced by the people they represent.

The <u>Municipal Cooperation Program</u>, based in Haiti, has organised more than seven training sessions, where women elected officials from all the country shared their experiences and learn about their roles and responsibilities. Last fall, the program trained over 700 local elected women on their role, helping them strengthen their ability to navigate their city halls and be advocates for their communities.

Meanwhile, last February, Maja Tait, Mayor of Sooke, BC, who is also the president of the Union of B.C. Municipalities, <u>travelled to Cambodia</u> as part of our <u>Partnerships for Municipal Innovation</u> program, to deliver capacity-building workshops for women elected officials. These workshops focused on facilitation skills, conflict mediation and the laws protecting women and children.

Building peer support networks

Peer support networks have proven to be a powerful tool for strengthening women's leadership positions and political participation. These networks help women elected officials support each other to overcome the barriers they face and to lead their communities with confidence.

The <u>Sustainable and Inclusive Communities in Latin America</u> (CISAL) program helped develop several women's networks in Colombia and Peru. Through these networks, CISAL was able to strengthen the leadership, strategic communication, and local management capacity of 132 Colombian mayors, 20 Peruvian politicians and leaders, and over 200 women who aspired to elected office. <u>Discover what CISAL</u> did to support women's political and economic empowerment in Colombia and Peru.

CISAL's <u>Network of Women Mayors for Democracy and Peace</u> adopted an action plan to promote a gender equality agenda in the municipalities, support the participation of women in politics, and to strengthen the capacities of women mayors. The Network offered workshops for women interested in running for office in 10 different regions, based on the Canadian "campaign school" model. The Network certified 90 women strategic communication planning, and helped over 500 women access the resources online.

Helping Canadian municipalities move toward parity

At home in Canada, FCM's work to increase and <u>support women in local government</u> spans more than two decades, and includes research, advocacy and programming. Municipal governments can play a leading role in helping to achieve gender equality by helping to ensure the participation of women in the political life of their community.

Over the past year, our national program, <u>Toward Parity in Municipal Politics</u>, with support from the Government of Canada, has been consulting with and engaging municipalities, provincial-territorial associations, and sector leaders to map out the barriers women elected officials face and to generate ideas of how to tackle them. The results of this effort will be revealed later this year – <u>follow us on Facebook</u> to stay in the loop.

Please find enclosed the 2019 Annual Compliance Audit for the Wawanesa public water system (PWS). The report compares water system compliance to The Drinking Water Safety Act and its supporting regulations, and the terms and conditions of the water system's current operating licence (PWS-08-225-02 A).

Where non-compliance items are identified, the issues do not necessarily translate into increased public health risk. The Office of Drinking Water uses processes, including boil water advisories, to notify water users of a public health risk.

Please review the following terms and conditions of your operating licence to ensure ongoing compliance:

- Water quality sampling frequencies identified in Table 2.
- Water System Assessment (due date: March 1, 2020)
- Compliance Plan (due date: November 30, 2020)

Facility Classification and Operator Certification

In 2020, Conservation and Climate will be enforcing on the Water and Wastewater Facility Operators Regulation MR. 77/2003 beginning with Public Water Systems classified at Level 3 and Level 4 Water Treatment Facilities and Water Distribution. The focus will be on operator certification and submission of an up-to-date Table of Organization.

Operational Guidelines

Water suppliers that own and operate a portion of their water supply on a seasonal basis, such as a campground or park, are reminded they are required to follow Seasonal Water System Start-up/Shutdown procedures

Water suppliers are reminded to immediately notify the Office of Drinking Water of any condition(s) that may affect the ability of the water system to produce or deliver safe drinking water. These conditions include:

- treatment upsets, bypass conditions, operation outside of licence conditions
- · contamination of source or treated water
- · a disinfection, filtration, or distribution system failure

Operational Guidelines to assist operators in meeting regulatory obligations for monitoring and reporting under The Drinking Water Safety Act, including Seasonal System and Emergency Reporting requirements, can be found on our website at: www.gov.mb.ca/drinkingwater.

Additional Information

Health Canada has updated National Guidelines, including algae (cyanobacteria toxins) manganese and lead. Owners and operators are encouraged to review Health Canada's guidelines and related chemistry results to determine what impact they may have on your water supply. You will receive notification of any changes to Health Canada's Guidelines for Canadian Drinking Water Quality and Manitoba Standards should they affect your water supply.



To Rural Municipalities of Manitoba:

The Manitoba Oat Growers Association (MOGA) is concerned with the condition of the secondary roads within the Province of Manitoba. MOGA is a farmer led organization that works on issues relevant to Manitoba producers and this is becoming an issue of increasing concern.

Many of Manitoba's secondary roads are not in a condition to handle the current agricultural equipment and traffic, especially in years such as 2019. These roads are essential to be able to transport equipment to and from the fields and in moving grain off the field and to market.

MOGA would like to offer support to the Rural Municipalities (RM) to improve the conditions of these roads so farmers have the access needed to continue their vital roles in working to providing food to domestic and import markets. MOGA realizes that there may already be efforts to address this issue on road conditions and requirements and is willing to provide letters of support or possibly other deliverables as needed to help address this critical issue.

Canada is the world's largest exporter of oats, and nearly 90% of Canadian oat exports are to the United States. The Prairie Oat Growers Association (POGA), of which MOGA is a 1/3 member, has been actively working at increasing our market share in Mexico, and for the last few years has secured nearly 100% of that market. Many of the oats grown in Manitoba are exported to markets in the south, so timely and safe delivery is important to our growers. Producers have moved from tandem trucks to larger, semi trailer combinations of various sizes such as Super B's. However, the secondary roads in the province have not been upgraded to accommodate larger vehicles with many roads now restricting larger carriers in all seasons. This is creating real issues for Manitoba producers.

The oat growers of Manitoba appreciate your support in this issue and again would like to offer to support efforts to improve the rural infrastructure, especially on secondary roads.





Coronaviruses

The purpose of this article is to provide water and wastewater utilities with a summary of some of the relevant issues related to coronaviruses treatment with considerations and recommendations to water and wastewater treatment practitioners with respect to coronaviruses in general.

- Fate of coronaviruses in sewage and wastewater treatment plants
- Fate of coronaviruses in the aquatic environment
- Efficacy of water treatment filtration and disinfection processes for coronaviruses removal and inactivation

It is important to remember that an extensive body of literature on the effectiveness of water and wastewater treatment processes for coronaviruses is not available, and as always, site-specific water-quality and treatment-plant details may result in variation between full-scale effectiveness and research results found in the laboratory.


Considerations for Water and Wastewater Treatment

Infectious human coronaviruses may be present in raw wastewater that is collected from a population where an infection is occurring. About 20-40% of SARS-CoV infections presented symptoms of diarrhea and the virus is capable of binding to receptors in the intestines as well as in the lungs (Leung et al. 2003). These viruses may be detected in urine and stools from infected individuals for more than 100 days after initial infection (Liu et al., 2003). The persistence of coronaviruses in hospital wastewater and domestic sewage is estimated to be 2-3 days (Wang et al., 2005).

Wastewater treatment plants that are receiving sewage from hospitals and isolation centers treating patients for coronaviruses may have elevated concentrations of viruses in the wastewater influent. Further, if wastewater treatment is insufficient to remove or inactivate coronaviruses, or combined sewer overflows/bypasses are operational, the viruses may be released into the environment (Casanova et al., 2009).

Coronaviruses have not been found to be more resistant to water treatment than other microorganisms such as *E. coli*, phage, or human viruses such as poliovirus, which are commonly used as surrogates for treatment performance evaluations (Gundy et al., 2009). Results from bench-scale studies suggest that the survival of coronaviruses is temperature dependent; with greater survival at lower temperatures. Therefore, the persistence of coronaviruses are expected to be reduced in raw wastewater and surface waters in warmer seasons.

Common disinfection methods used in water and wastewater treatment are expected to be effective for inactivation of coronaviruses when executed properly



The recent outbreak of novel coronaviruses (COVID-19) in Wuhan City, Hubei Province, China is being closely monitored as it causes acute respiratory illness and has the potential to be fatal (CDC, 2020). The COVID-19 and the 2002 SARS-CoV (severe acute respiratory syndrome coronaviruses) are recent examples of how some coronaviruses that infect animals can evolve to infect humans.

Investigations into the COVID-19 outbreak are ongoing, and the information that we have right now may change as we learn more about this virus (WHO, 2020). As water treatment professionals, we want to inform stakeholders of the current state of knowledge on coronaviruses as it relates to our practice.

Wastewater Treatment

In general, secondary wastewater treatment may be credited with removing 1 log (90%) of viruses, though broad studies suggest the level of virus removal is highly variable between insignificant removal to greater than 2 log removal (99%) (Hewitt et al., 2011; USEPA, 1986). Because of this variability, the primary process for the inactivation of viruses in wastewater treatment is chemical disinfection (i.e. chlorination) and/or disinfection by ultraviolet (UV) light.

The efficacy of chlorination for inactivating viruses in wastewater is dependent upon numerous water quality factors. Of particular importance is the presence of disinfectant-demanding substances and in particular, ammonia, which reacts with chlorine to form chloramines. In general, chloramines are much poorer virucides as compared to free available chlorine. Thus, it is important to consider the level of ammonia before the disinfection process to adequately determine its virucidal efficiency. Chemical disinfection of wastewater with free available chlorine is expected to be effective for coronaviruses when applied at adequate levels. In one published research study, chlorination of domestic wastewater using a dose of 10 mg/L sodium hypochlorite, a contact time of 30 minutes, and a free chlorine residual of >0.4 mg/L was found to inactivate 5 log of coronaviruses (Wang et al., 2005). This level of chlorination is often applied in full-scale WWTPs. For example, the Ontario (Canada) Ministry of the Environment typically requires WWTPs to have a free chlorine residual of 0.5 mg/L after 30 minutes of contact time at the design average daily flow (Ministry of the Environment, 2008). The efficacy of UV disinfection of viruses in wastewater is highly dependent upon the fluence achieved by a particular system and it is, therefore. not possible to estimate for general systems. For UV disinfection systems that were not designed specifically for virus inactivation, only low-levels of coronaviruses inactivation are expected.

Sludge Management

The survival of coronaviruses in wastewater sludge has not been reported but is expected to vary significantly depending on site-specific sludge handling and treatment procedures. Based on a study examining survival of coronaviruses in water and wastewater (Gundy et al., 2009), coronaviruses survival in primary wastewater effluent at temperatures greater than 20°C is expected to be very low - within a period of 4 days. However, this same study reported that the survival time increases (e.g. more than 4 weeks) at cold temperatures (near 4°C) in clean water. At all temperatures studied, coronaviruses showed lower survival rates in wastewater than other viruses. Sludge handling and disposal practices should be reviewed on a case-by-case basis to prevent contamination of ground and surface waters.

The U.S. Environmental Protection Agency's (EPA's) Part 503 rule provides comprehensive requirements for the management of biosolids generated during the process of treating municipal wastewater.

Operators of Wastewater Treatment

Respiratory illnesses can be spread by contact with aerosols and by hand-to-mouth transmission. Therefore, it is recommended that wastewater treatment operators and sludge handlers use barriers such as face masks and disposable gloves to prevent exposure to aerosols. Further, strict sanitation practices should be implemented to encourage frequent handwashing, the separation of eating areas from work areas, and minimization of contact between hands and face. Communications should be sent to plant operators and staff to inform them of best sanitation practices.

Do's and Don'ts of general sanitation practices that prevent the spread of respiratory viruses are listed below.

Do's:

- Do wash hand with soap and water for at least 20 seconds, especially after using the bathroom, before eating, after blowing your nose, coughing or sneezing.
- Do stay home when you are ill.
- Do cover your cough or sneeze with a tissue and dispose of the tissue in the trash.
- Do disinfect frequently touched objects and surfaces such as door knobs.

Don'ts:

- Don't touch your eyes, nose and mouth with unwashed hands.
- Don't have close contact with people who are ill.
- CDC does not recommend the use of facemasks for the general public to prevent the spread of COVID-19 as close person-to-person contact is currently considered the greatest risk for transmission, and transmission in general population areas has not been observed.

that risk communication and community engagement (RCCE) has been integral to the success of response to health emergencies.

RCCE action items

Organization has found

RCCE action items related to coronaviruses include communicating about preparedness measures at all levels and aslablishing a system for listening to public perceptions to prevent misinformation.

Drinking Water Treatment

Surface water treatment plants with upstream wastewater impacts are the most susceptible to having coronaviruses contamination in the raw water supply during, and after, an outbreak. Conventional treatment with free available chlorine designed to provide 0.5 log inactivation of Giardia can achieve at least 8 log inactivation of viruses in general (Health Canada, 2019a). Note that it is important to ensure that disinfection performance is continuously monitored (e.g. turbidity, disinfectant dose, residual, pH, temperature, and flow). Optimized conventional filtration can achieve 2 (99%) log virus removal (Health Canada, 2019b).A UV fluence of 44 mJ/cm² can achieve up to 3 log (99.9%) inactivation of poliovirus 1 and rotaviruses, while a dose of 40-199 mJ/cm² can inactivate up to 3 log (99.9%) of adenoviruses; the most UV resistant viruses (Health Canada, 2019b; USEPA 2006). Based on published research, water treatment processes that meet virus removal/inactivation regulations are expected to be effective for coronaviruses control. Further details of the efficacy of various treatment processes for the removal/inactivation of human viruses was recently updated in the Guidelines for Canadian Drinking Water Quality (Health Canada, 2019b).

Potential response actions

Here are some response actions to potential risks from coronaviruses in water and wastewater treatment:

Critical Control Point	Potential Risk	Risk Response
Wastewater treatment - open basins	Aerosols created during wastewater treatment process	© Communicate risks, provide signage, and PPE barriers to wastewater treatment operators regarding the potential transmission of coronaviruses and precautionary sanitation practices
Wastewater disinfection	Infectious coronaviruses persisting in domestic sewage	Ensure optimal contact time for chemical disinfection
Drinking water treatment	Infectious coronaviruses in water supplies impacted by wastewater effluent	Ensure continuous monitoring and performance of drinking water disinfection processes for systems with upstream wastewater impacts during, and after, and outbreak







Global and national efforts to minimize the transmission of COVID-19 (coronavirus) are ongoing. As a proactive measure, the federal government has released recommendations for public schools. Within these recommendations, the Public Health Agency of Canada (PHAC) notes that there is currently no widespread transmission of COVID-19 in Canada; therefore, PHAC recommends that schools take standard respiratory illness precautions, the same precautions that are recommended every year for cold and influenza season. We have a collective responsibility, both at home and at school, to help prevent the spread of communicable illnesses. While youth who are generally in good health seem to be more resilient to the effects of the virus, they may become carriers who can transmit it to others either directly or indirectly.

Below are some measures that we will take or promote as a school division to further minimize risk.

- 1. Increasing our cleaning/disinfecting protocols within schools, focusing on common 'high touch' surfaces such as doorknobs, faucets, etc.
- 2. If students are displaying symptoms of illness, parents/guardians are asked to keep students home and possibly seek medical attention. Staff who are ill are asked to do the same.
- 3. Students need to be diligent with good hygiene practices, including regular hand washing and practicing the correct way to cover their nose and mouth when coughing/sneezing.
- 4. Minimizing hand-to-face contact, especially in the areas of the mucous membranes (eyes, nose, and mouth).
- 5. Students should also be discouraged from sharing food or drink at school.

We will continue to monitor the situation and communicate with you as needed on an ongoing basis.

This "conservation interest" is designed to protect natural ecosystems, fish and wildlife habitat, and plant or animal species. Areas that are the subject of a "conservation interest" are usually marginal for farming and typically include sloughs, woodlands and unimproved prairie. These areas are generally the least productive agricultural portions of the land that have not been developed for agricultural purposes because of limited capability. In most cases these conservation lands are not cultivated.

A Conservation Agreement allows landowners to use their cultivated land to its full agricultural capacity, while protecting the important wildlife habitats in perpetuity. The landowner retains control of the land and continues to be responsible for weed control, the management of pests such as beaver, control of access to the land and payment of municipal taxes. The landowner may sell the land under the Agreement, but like an easement, the conditions of the Agreement "run with the land" and will apply to

Homegrown conservation since 1986.

all future owners of the property for the term of the Agreement, unless terminated under provisions outlined in the Conservation Agreements Act.

The Manitoba Habitat Heritage Corporation plans to enter into a Conservation Agreement with Matthew Gorgerat and Virginia Greening involving 77 acres of their property (see attached aerial photo). If the Conservation Agreement is completed, a caveat will be placed on the land title. This caveat will restrict the Gorgerats and all subsequent owners of the property from breaking, burning, cultivating, draining, degrading, converting or in any other way disrupting the ecosystem components of habitats on the Conservation Lands outlined and hatched on the attached aerial photo. This caveat will also restrict the establishment of any commercial or residential buildings or facilities on the aforementioned Conservation Lands.



WHEREAS it is in the best interests of the people of Manitoba, and consistent with the principles of sustainable development, that land owners and conservation agencies be able to enter into conservation agreements for the protection and enhancement of

- (a) natural ecosystems;
- (b) wildlife or fisheries habitat; and
- (c) plant or animal species;

AND WHEREAS these conservation agreements will allow for protection and enhancements of these interests while enabling the continued use and development of the land by a landowner;

THEREFORE HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Manitoba, enacts as follows:

Definitions

1 In this Act,

"board" means the Conservation Agreements Board established under subsection 8(2); (« Commission »)

"court" means the Court of Queen's Bench; (« tribunal »)

"holder" means an eligible conservation agency that holds a conservation agreement; (« cocontractant »)

"land" means land in Manitoba that is the subject of a conservation agreement; (« bien-fonds »)

"landowner" means the owner of an estate in fee simple of land; (« propriétaire foncier »)

"minister" means the member of the executive council charged by the Lieutenant Governor in Council with the administration of this Act. (« ministre »)

Conservation agreement

2(1) A conservation agreement is a written agreement between a landowner and a holder that creates a conservation interest in land.

Conservation interest

- 2(2) A conservation interest is an interest that imposes one or more restrictions on the use of land for the protection and enhancement of
 - (a) natural ecosystems;
 - (b) wildlife or fisheries habitat; or
 - (c) plant or animal species.

Term of conservation agreement

2(3) A conservation agreement shall remain in force for the term specified in the agreement.

Optional terms of conservation agreement

3(1) As part of a conservation interest, a conservation agreement may grant to the holder rights and privileges that relate to a conservation purpose, including the right to enter on the land to do anything related to a conservation purpose.

- 5 The following conservation agencies may hold a conservation agreement:
 - (a) a corporation without share capital that is incorporated under Part XXII of *The Corporations Act* and designated by regulation as being authorized to enter into conservation agreements;
 - (b) a not-for-profit corporation that is incorporated under an Act of Parliament and designated by regulation under this Act as being authorized to enter into conservation agreements:
 - (c) the Crown in right of Canada;
 - (d) the Crown in right of Manitoba;
 - (e) a federal or provincial Crown corporation or agency;
 - (f) a municipality;
 - (g) a local government district;
 - (h) a watershed district established or continued under The Watershed Districts Act

Land description in conservation agreement

6(1) Subject to subsection (2), land that is the subject of a conservation agreement is sufficiently described if its boundaries are shown, or its area is indicated, on a map attached to the conservation agreement.

- 7(3) At least 45 days before filing a caveat against the land, the holder shall serve a notice of intent to file a caveat, in a form and in the manner prescribed by regulation, on the following parties:
 - (a) all persons who appear from the certificate of title
 - (i) to have an interest in the land,
 - (ii) to have a registered charge, lien or judgment against the land, or
 - (iii) to have a security interest in the land:
 - (b) the municipality or local government district in which the land is located;
 - (c) the Minister of Aboriginal and Northern Affairs, if the land is in Northern Manitoba as defined by *The Northern Affairs Act*;
 - (d) the board of a watershed district if the land is in a watershed district.

7(4) A party served with a notice under subsection (3) who wishes to object to the registration of the caveat shall

7(6) A holder who is served

- (a) with notice of an application to the board in accordance with subsection (4) shall not file a caveat until at least 45 days after the holder and applicant fail before the board to resolve the objection the applicant has regarding the caveat; or
- (b) with a notice of application under subsection (5) shall not file a caveat until the application is dismissed or the holder is otherwise permitted by the court to file the caveat.

Application to court after caveat filed

7(7) Where a caveat has been registered, a party required to be served with a notice under subsection (3) who was not served in accordance with that subsection, or any other person with an interest in the land, who objects to the registration of the caveat, may apply to court by way of notice of application for an order that the registration of the caveat be vacated.

Court order

7(8) On hearing an application made

(a) under subsection (5), the court may order that the caveat not be registered; or
