THE MUNICIPALITY OF OAKLAND-WAWANESA

By-law No. 01-2021

Being a By-law of the Municipality of Oakland-Wawanesa to authorize the Expenditure and Borrowing of money for the municipal contribution towards the installation of fibre optics in the rural area as a Local Improvement.

Whereas Section 311 of *The Municipal Act*, S.M. 1996, C.58, provides in part as follows:

If approved by by-law, a municipality may undertake, as a local improvement for the benefit of all or part of the municipality,

...

(b) any other project the cost of which includes a capital component.

And Whereas subsection 320(1) of *The Municipal Act* provides as follows:

Subject to subsections (2) to (6) and subsections 321(4), a Council may by by-law

- (a) approve the local improvement or special service as set out in the plan or proposal; and
- (b) authorize the municipality to impose taxes as set out in the plan or proposal.

And Whereas Section 172 of *The Municipal Act* provides in part as follows:

In this Division,

"Borrowing" means the borrowing of money, and includes

....

(b) borrowing to pay for a local improvement under Division 4 (Local Improvements and Special Services) of Part 10,

....

(e) issuing debentures.

And Whereas, the Council of the Municipality of Oakland-Wawanesa has prepared Local Improvement Plan No. 01-2021 providing for the spending, borrowing authority, and imposition of taxes for the municipal contribution towards the installation of fibre optics in the rural area as a local improvement pursuant to Part 10 of *The Municipal Act*;

And Whereas, in order to complete such undertaking, it will be necessary for the Municipality of Oakland-Wawanesa to borrow the sum of \$200,000 as hereinafter provided, which is the amount of the debt intended to be created by this by-law;

And Whereas the consecutive annual amounts, including principal and interest, required to be raised each year for three years, as hereinafter provided, for paying the principal and interest under this by-law are the amounts set out in Schedule "A" hereto;

And Whereas the amount of the existing borrowing debt of the Municipality of Oakland-Wawanesa is \$1,003,155.49, of which no portion of the principal or of the interest thereon is in arrears;

And Whereas the requirements are prescribed in Sections 318, 319 and 320 of *The Municipal Act* have been complied with;

Now Therefore the Council of the Municipality of Oakland-Wawanesa in regular session assembled, enacts as follows:

1. That pursuant to subsection 320(1) of *The Municipal Act*, the Municipality of Oakland-Wawanesa adopt Local Improvement Plan No. 01-2021 attached hereto as Schedule "B".
2. That the Municipality of Oakland-Wawanesa may expend up to two hundred thousand dollars (\$200,000.00) for the purpose of municipal contribution towards the installation of fibre optics in the rural area as a local improvement.
3. That for the aforesaid project, the said municipality may borrow two hundred thousand dollars (\$ 200,000.00), such borrowing shall be issued by the Municipality of Oakland-Wawanesa in the Province of Manitoba, and shall be payable at the Royal Bank of Canada in the Village of Wawanesa, and shall be dated the 31st day of December, A.D.2020.
4. That the said borrowing shall bear interest at a rate estimated for the time being at 2.0% per annum, and subject in any event to the authorization of The Municipal Board at the time of sale, and shall mature in accordance with the maturities set out in Schedule "A" hereto on the 31st day of December in each of the years 2021 to 2023, both inclusive.
5. That the issuance of borrowings shall be signed by the Head of Council, or by some other person authorized by by-law to sign same, and by the Chief Administrative Officer of the Municipality of Oakland-Wawanesa and there shall be affixed thereto the corporate seal of the said municipality.
6. That during the currency of the said borrowing; namely, in each of the years 2021 to 2023, both inclusive, there shall be raised annually by a special per parcel rate on all the rateable property described in Schedule "C" hereto, an amount sufficient to meet the requirement for principal and interest.
7. That pursuant to subsection 174(3)(d) of *The Municipal Act*, pending the issue of the borrowing, the Council of the Municipality of Oakland-Wawanesa may agree with a bank or person or borrow from the general funds of the municipality for temporary advances from time to time to meet expenditures incurred for the purpose aforesaid, and the total of such advances shall not exceed two hundred thousand dollars (\$200,000.00).
8. That, at any time prior to or within (30) days following completion of the work, any ratepayer of the area affected by the local improvement as described in Schedule "C" hereto may commute and pay in one principal sum that part of his/her share of the debt herein authorized in respect of the per parcel rate(s) provided herein to the said Chief Administrative Officer of the Municipality of Oakland-Wawanesa and thereafter no per parcel rate(s) shall be levied against his/her said lands in respect of the borrowing to be authorized herein.

PUBLIC NOTICE
LOCAL IMPROVEMENT BY-LAW NO. 01-2021
INSTALLATION OF FIBRE OPTICS IN THE RURAL AREA

The Council of the Municipality of Oakland-Wawanesa has scheduled a public hearing at the Carroll Hall on the **28th day of January 2021 at 6:30 p.m.** to present the following local improvement plan:

A. Proposed Local Improvement:

The Municipality of Oakland-Wawanesa wishes to establish a local improvement levy based on a per parcel rate for the contribution towards the installation of fibre optics in the rural area. Reliable, quality connectivity and high-speed internet is essential for families and businesses in the community. The proposed local improvement by-law is for a 3-year period (2021 to 2023 inclusive).

B. Municipality for Local Improvement:

The proposed local improvement district will be all taxable, grant-in-lieu and otherwise exempt property within the rural area in the Municipality of Oakland-Wawanesa with the exceptions of:

- All Class 30 properties with no dwelling units including Roll #s 83150, and 88025 which will soon be Class 30.
- Cemetery and cairn properties described in Roll No.'s: 15500, 18650, 24150, 28800, 50300, 53800, 87500, and 94200.
- Vacant land belonging to community clubs and halls described in Roll No.'s: 38600, 39300, 61012 and 88200.
- Wawanesa properties, except Roll #220600 and #221200.

C. Method and Rate of Calculating the Local Improvement Tax:

The method of calculating the local improvement levy will be based on an amount per parcel.

The rates will be:

- \$380.95 cash (prepay) option or \$132.10 per year for three years (finance) option. There are 525 properties.

D. Estimated Cost of Local Improvement:

The total estimated cost of the project is \$1,950,000 including large build costs of \$640,000 and hook-up costs of approximately \$1,310,000.

E. Anticipated Sources of Funding

- \$1,750,000 funded through client service agreements with RFNow Inc.
- \$200,000 funded through Local Improvement

F. Particulars of Borrowing

The borrowing of \$200,000 shall bear interest at a rate estimated for the time being at 2.0 % per annum and shall mature December 31, 2023. Annual payments will be \$69,350.93.

G. Annual operation and maintenance costs of local improvement

Annual operation and maintenance of the fibre optics will be the responsibility of RFNow Inc.

A written objection may be filed with the Chief Administrative Officer at 54 Main St., PO Box 28, Nesbitt MB R0K 1P0 prior to the commencement of the hearing. At the hearing, Council will hear any potential taxpayer who wishes to make a presentation, ask questions, or register an objection to the local improvement plan.

All objections, written or verbal must be filed prior to the adjournment of the hearing and must include the name, address and property description of the person filing the objection and the grounds of their objection.

THE MUNICIPALITY OF OAKLAND-WAWANESA

By-law No. 02-2021

Being a By-law of the Municipality of Oakland-Wawanesa to authorize the Expenditure and Borrowing of money for the municipal contribution towards the installation of fibre optics in Wawanesa as a Local Improvement.

Whereas Section 311 of *The Municipal Act*, S.M. 1996, C.58, provides in part as follows:

If approved by by-law, a municipality may undertake, as a local improvement for the benefit of all or part of the municipality,

....

(b) any other project the cost of which includes a capital component.

And Whereas subsection 320(1) of *The Municipal Act* provides as follows:

Subject to subsections (2) to (6) and subsections 321(4), a Council may by by-law

(a) approve the local improvement or special service as set out in the plan or proposal; and

(b) authorize the municipality to impose taxes as set out in the plan or proposal.

And Whereas Section 172 of *The Municipal Act* provides in part as follows:

In this Division,

"Borrowing" means the borrowing of money, and includes

....

(b) borrowing to pay for a local improvement under Division 4 (Local Improvements and Special Services) of Part 10,

...

(e) issuing debentures.

And Whereas, the Council of the Municipality of Oakland-Wawanesa has prepared Local Improvement Plan No. 02-2021 providing for the spending, borrowing authority and imposition of taxes for the municipal contribution towards the installation of fibre optics in Wawanesa as a local improvement pursuant to Part 10 of *The Municipal Act*;

And Whereas, in order to complete such undertaking, it will be necessary for the Municipality of Oakland-Wawanesa to borrow the sum of \$25,000 as hereinafter provided, which is the amount of the debt intended to be created by this by-law;

And Whereas the annual amount, including principal and interest, required to be raised each year for one year, as hereinafter provided, for paying the principal and interest under this by-law are the amounts set out in Schedule "A" hereto;

And Whereas the amount of the existing borrowing debt of the Municipality of Oakland-Wawanesa is \$1,003,155.49, of which no portion of the principal or of the interest thereon is in arrears;

And Whereas the requirements are prescribed in Sections 318, 319 and 320 of *The Municipal Act* have been complied with;

Now Therefore the Council of the Municipality of Oakland-Wawanesa in regular session assembled, enacts as follows:

1. That pursuant to subsection 320(1) of *The Municipal Act*, the Municipality of Oakland-Wawanesa adopt Local Improvement Plan No.02-2021 attached hereto as Schedule "B".
2. That the Municipality of Oakland-Wawanesa may expend up to fifty thousand dollars (\$50,000.00) for the purpose of the municipal contribution towards the installation of fibre optics in Wawanesa as a local improvement.
3. That for the aforesaid project, the said municipality may borrow twenty-five thousand dollars (\$25,000.00), such borrowing shall be issued by the Municipality of Oakland-Wawanesa in the Province of Manitoba, and shall be payable at the Royal Bank of Canada in the Village of Wawanesa, and shall be dated the 31st day of December, A.D. 2020.
4. That the said borrowing shall bear interest at a rate estimated for the time being at 2.0% per annum, and subject in any event to the authorization of The Municipal Board at the time of sale and shall mature in accordance with the maturities set out in Schedule "A" hereto on the 31st day of December, A.D. 2021.
5. That the issuance of borrowings shall be signed by the Head of Council, or by some other person authorized by by-law to sign same, and by the Chief Administrative Officer of the Municipality of Oakland-Wawanesa and there shall be affixed thereto the corporate seal of the said municipality.
6. That during the currency of the said borrowing; namely, in the year 2021 there shall be raised by a special per parcel rate on all the rateable property described in Schedule "C" hereto, an amount sufficient to meet the requirement for principal and interest.
7. That, at any time prior to or within (30) days following completion of the work, any ratepayer of the area affected by the local improvement as described in Schedule "C" hereto may commute and pay in one principal sum that part of his/her share of the debt herein authorized in respect of the per parcel rate(s) provided herein to the said Chief Administrative Officer of the Municipality of Oakland-Wawanesa and thereafter no per parcel rate(s) shall be levied against his/her said lands in respect of the borrowing to be authorized herein.
8. That pursuant to subsection 174(3)(d) of *The Municipal Act*, pending the issue of the borrowing, the Council of the Municipality of Oakland-Wawanesa may agree with a bank or person or borrow from the general funds of the municipality for temporary advances from time to time to meet expenditures incurred for the purpose aforesaid, and the total of such advances shall not exceed twenty-five thousand dollars (\$25,000.00).

LOCAL IMPROVEMENT PLAN NO. 02-2021

To contribute toward the installation of fibre optics in Wawanesa area

Pursuant to section 320(1) of The Municipal Act

A. Proposed Local Improvement:

The Municipality of Oakland-Wawanesa wishes to establish a local improvement levy based on a per parcel rate for the contribution towards the installation of fibre optics in Wawanesa. Reliable, quality connectivity and high-speed internet is essential for families and businesses in the community. The proposed local improvement by-law is for a 1-year period.

B. Local Improvement District:

The proposed local improvement district will be all taxable, grant-in-lieu and otherwise exempt property within Wawanesa in the Municipality of Oakland-Wawanesa with the exceptions of:

- cemetery and church properties described in Roll No.'s: 209000, 220000 and 228250,
- HMQ dam site property described in Roll No. 222600
- two properties that can't access the service located south of the river described in Roll No's: 220600 and 221200.

C. Potential Taxpayers

All property owners of taxable, grant-in-lieu and otherwise exempt properties within the urban centre of Wawanesa with the above noted exceptions, as described in Schedule "C" hereto attached.

D. Method and Rate of Calculating the Local Improvement Tax

The method of calculating the local improvement levy will be based on an amount per parcel.

The rates will be:

- \$41.95 cash (prepay) option or \$42.79 finance option for vacant lots. There are 38 vacant properties (i.e. lots with no dwelling units or lots that are secondary to a main commercial or industrial properties). The rate is 50% of the per parcel rate.
- \$83.89 cash (prepay) option or \$85.57 finance option for all other properties. There are 279 other properties.

E. Estimated Cost of Local Improvement:

The total estimated cost of the installation of fibre optics in Wawanesa area is \$900,000.

F. Anticipated Sources of Funding

- \$850,000 funded through client service agreements with Westman Communications Group
- \$25,000 funded from General Reserve
- \$25,000 funded through Local Improvement levy

G Particulars of Borrowing

The borrowing of \$25,000 shall bear interest at a rate estimated for the time being at 2.0% per annum and shall mature December 31, 2021.

H. Annual operation and maintenance costs of local improvement

Annual operation and maintenance of the fibre optics will be the responsibility of Westman Communications Group.
