Verbal representation was received as follows:

Glenda Garden, 27 Souris Street, Nesbitt, MB on behalf of the Nesbitt Community Club, read a written presentation in opposition to the local improvement plan as community clubs had seen a reduction in revenue with the Covid-19 situation and in increase in taxes would add to the distress. A copy of the presentation was kept on file.

John Robinson, SW 4-7-18 WPM, appeared to ask questions with respect to running fibre optic to a farm property. He also indicated that many residents were facing financial hardships and that applying additional taxes could increase the hardship. That said, he reported that as a person who had been involved in the industry, he believed fibre optics was the way to go and he supported the levy.

Norma Vint, SE 26-7-19 WPM, appeared in opposition to the plan and to ask questions including whether or not the decision was already made or if there was still the opportunity for input. She enquired if Starlink had been investigated. She voiced a concern with respect to the ability to receive information about the project from either RFNow or the Municipality. She indicated her family was not interested in fibre optic connection.

Lorna Kincaid, S ½ 26-7-18 WPM appeared before Council to ask questions with respect to the ability to connect everyone who is interested, to the fibre optic.

Neil Bok, NE 12-8-19 WPM, appeared before Council in support of the plan and to advise that his home was connected to fibre optic and has had excellent service. He was supportive of the opportunity to receive free installation for the fibre optic service, particularly if the free installation was offered for 7 years.

Charlie Clark, SW 33-8-18 WPM, appeared before Council in support of the proposal. As a person who has been in the internet business for several years, he reported that fibre optic is definitely the best option available, even better than satellite systems, and has always told individuals that if they have the opportunity for fibre optic, to take it.

Chad Lalonde, SE 36-8-17 WPM, appeared before Council in support of the proposal and to ask questions with respect to costs for the monthly service, and noted that improved service was worth the fees.
