AMM Western Director's Update

As your AMM Board Directors, we are pleased to provide an update on the issues we discussed at the last Board meeting that was held on June 27, 2024.

While the AMM Board maintains the policy of confidentiality regarding ongoing discussions with the provincial government and stakeholders, we are pleased to share some of the topics with you.

Accessible Information and Communication Standard

On May 1, 2024, the Accessible Information and Communication Standard came into force for public sector organizations, Manitoba's ten cities, libraries and education institutions. The standard focuses on removing and preventing barriers that exist digitally, in print or through interaction with technology and people. Please note that all other municipalities will be required to comply with this legislation by May 1, 2025.

The AMM has long advocated for increased funding to implement these standards and ensure the Department provides the necessary tools and resources for a smooth transition to compliance. As a result of these efforts, the Department has created a new online training module available anytime, anywhere. Additionally, the online learning portal features downloadable, standard-specific modules for use within organizations' internal learning management systems. The AMM is collaborating with the Manitoba Accessibility Office (MAO) to facilitate a dedicated webinar on the

standard this fall to ensure all municipalities are ready to meet the forthcoming legislative requirements. Please stay tuned for more information.

Provincial Public Safety Initiatives

In May, the Manitoba government hosted a Public Safety Summit as part of its commitment to making Manitobans feel safer at home, school and work and to discuss pathways to reduce crime, keep communities safe and address the root causes of crime.

The Summit brought together a variety of community leaders from across Manitoba, and sessions included topics on mental health, addictions and homelessness, youth violence, gender base violence and MMIWAG2s+, rural and northern safety, access to justice and victim services, law enforcement, organized crime and strengthening the Criminal Code. Further to this, the AMM was pleased to have senior Justice staff as well as the Hon. Matt Wiebe, Minister of Justice and Attorney General, attend the AMM June District Meetings and host public safety roundtable sessions to build off the Summit. The feedback from both initiatives will be incorporated into a province-wide strategy to reduce crime and make communities safer that is expected to be released later this summer or early fall.

Pipeline Assessment Consultation Update

In April 2024, the provincial government held an <u>information session</u> regarding potential changes to the pipeline assessment methodology for all municipalities. According to their presentation, 84 municipalities will be impacted either directly or indirectly by these changes. The AMM has been actively discussing this issue with the department and has received several letters from members outlining specific concerns about the impact on their municipalities.

During the tax impact meetings scheduled between May and June 2024, the department provided municipality-specific information. We encourage members to send any comments or concerns directly to the AMM office. We will also continue to relay these concerns to the Department.

Bill 37 Review Update

Manitoba is required by law to undertake a comprehensive review of recent amendments made to *The Planning Act and The City of Winnipeg Charter* (former Bill 37 and Bill 34), that includes public representations, by October 29, 2024.

Braid Solutions Inc. is conducting the independent assessment of the legislative amendments and facilitating stakeholder engagement.

AMM has supported Braid to identify municipal stakeholders to participate in this process. As part of this effort, a virtual questionnaire will be released for municipal government and administration leaders to contribute to the online consultation. Additionally, all municipalities in the province will be asked to provide data on

development and planning approvals, including financial costs and administrative burdens, to assess the impacts since the legislation was introduced.



Universal Broadband Fund's Manitoba Call for Expressions of Interest

NOTE: This message is being sent on behalf of Innovation, Science and Economic Development Canada (ISED).

July 24, 2024 - In June 2019, the Government released Canada's Connectivity Strategy with the objective of bringing access to Internet speeds of at least 50/10 Megabytes per second (Mbps) to all households by 2030. Since then, federal, provincial and private sector investments have been bridging our country's connectivity gap. This includes federal investments being made through the \$3.225 billion Universal Broadband Fund (UBF).

In 2017, 69.8% of households in Manitoba had access to speeds of 50/10 Mbps. It is projected that by 2026, 95.1% of households in the province will have access. As such, while significant progress is being made, more needs to be done on the path to 100% access by 2030.

Today, a special call for interest is being launched for Manitoba, inviting eligible applicants under the UBF to express their interest in developing a proposal to connect underserved households in the province in areas which remain without access to Internet speeds of 50/10 Mbps. Funding is currently available until March 31, 2027 and projects must be completed by that date.

The focus of this call for interest is on the most dense areas without service as indicated by the attached map. Densely populated areas outside of this map are either already considered served or will be served through existing projects, including those under the UBF.

Under the UBF, eligible applicants are:

- 1. Canadian entities or groups of Canadian entities that operate broadband infrastructure; or
- 2. Canadian entities or groups of entities that do not operate broadband infrastructure but have identified a plan to engage an entity or group of entities with experience building, owning, and operating the infrastructure their project(s) is proposing may also be eligible.

Innovation, Science and Economic Development Canada (ISED) is interested in hearing from all parties ready to participate in a project to bring improved connectivity underserved households. Eligible applicants are invited to come forward with expressions of interest until September 27, 2024. In addition to expressed interest, ISED will require that parties demonstrate the project is technically feasible, sustainable and financially viable. The maximum amount of funding available for a broadband project is up to 75% of the total eligible costs, or up to 90% of the total eligible costs for projects targeting very remote areas, satellite-dependent and/or Indigenous communities. ISED will work with interested parties to determine if they have a project that meets these criteria.

To submit an expression of interest, or to bring forward your questions including more detailed mapping information, please reach out to: get-connected-branchezvous@ised-isde.gc.ca. A program official will follow up with you directly in your preferred method of communication.

ISED has tried to be as inclusive as possible in this call out and therefore it is possible you are receiving this message but already have high-speed Internet in your community or have supported a project underway.

We are looking forward to working with you towards our common goal of 100% access to high-speed Internet for all households in Manitoba by 2030.

AMM Facing Problems with Municipal Roads on a Provincial Scale

Since February, unexpected spring-like conditions and heavy traffic have wreaked havoc on municipal roads. Brad Saluk, Vice President of the Association of Manitoba Municipalities (AMM) and Reeve for the RM of Brokenhead, weighed in on the current situation.


"The winter weather conditions and heavy truck traffic on these roads have caused hundreds of thousands of dollars in damage," Saluk shared. "Which, normally, we would never anticipate happening in the middle of February. I know, in some municipalities, they're still not even caught up fixing the amount of damage that has occurred from the spring yet. It's unbearable that you can even have the municipality dealing with this in the middle of July."

Municipalities have been forced to spread gravel in winter months, creating deep ruts and adding unexpected costs. Continued provincial highway restrictions have pushed more truck traffic onto already damaged municipal roads, further straining budgets.

Saluk emphasized the urgent need for Disaster Financial Assistance (DFA) from the provincial government.

August 8, 2024 - The annual AMM Fall Convention will take place in Winnipeg from November 25-27, 2024. There will be elections at this year's convention for the AMM Executive Committee, consisting of the President and two Vice-Presidents. The term of office for the President and Vice-Presidents is two years. The President and Vice-Presidents can be elected to an Executive Committee position in multiple terms.

Executive Committee Nominations:

Municipalities can nominate a municipal official for the President position, Vice-President position, or both, but the official can only accept nomination for and be elected to one position. Nominations for positions on the Executive Committee must be by resolution of Council. Each nomination must be supported by a separate resolution.

Only elected officials of member municipalities are eligible to be President or Vice-President of the AMM Executive Committee.

Nominations for candidates for a position on the Executive Committee must be submitted in writing, accompanied by a supporting Council resolution, to the Executive Director of the AMM. No nomination for an Executive Committee position is effective unless the nominee accepts the nomination by giving written notice to the Executive Director <u>no later than 14 days</u> before the opening day of the AMM Fall Convention. For this year's elections, accepted nominations must be received by the Executive Director by no later than <u>November 12, 2024</u>.

Any member of the AMM Board of Directors who accepts a nomination for an Executive Committee position vacates their position on the Board effective as of the date the member accepts the nomination.

*** Please note that the AMM Board of Directors made changes to Article 5, Section 2 of By-Law 1998. These changes were approved by members at the AMM Fall Convention in November 2023 and include the following:

• THEREFORE BE IT RESOLVED THAT nominations for the positions of President and Vice-President shall be made by notice in writing by a Regular Member to the Executive Director no later than 21 days before the opening day of the AMM Fall Convention. The nomination is ineffective unless accepted by the nominee by notice in writing to the Executive Director no later than 14 days before the opening day of the AMM Fall Convention. Nominees can only accept nomination for one position, that is, for the position of President or for Vice-President position, not both.

These changes will enable all candidates to determine the level of resources they wish to allocate to their campaigns.

Executive Committee election:

President: A candidate for President must receive 50% plus 1 of the total number of votes cast to be elected as President.

Vice-Presidents: The 2 candidates for Vice-President who receive the highest number of votes are elected as Vice-Presidents. There will be a further ballot at the Convention if there is a tie, involving only the tied candidates.

In June 2019, the Government released Canada's Connectivity Strategy with the objective of bringing access to Internet speeds of at least 50/10 Megabytes per second (Mbps) to all households by 2030. Since then, federal, provincial and private sector investments have been bridging our country's connectivity gap. This includes federal investments being made through the \$3.225 billion Universal Broadband Fund (UBF).

In 2017, 69.8% of households in Manitoba had access to speeds of 50/10 Mbps. It is projected that by 2026, 95.1% of households in the province will have access. As such, while significant progress is being made, more needs to be done on the path to 100% access by 2030.

Today, a special call for interest is being launched for Manitoba, inviting eligible applicants under the UBF to express their interest in developing a proposal to connect underserved households in the province in areas which remain without access to Internet speeds of 50/10 Mbps. Funding is currently available until March 31, 2027 and projects must be completed by that date.

The focus of this call for interest is on the most dense areas without service as indicated by the attached map. Densely populated areas outside of this map are either already considered served or will be served through existing projects, including those under the UBF.

Under the UBF, eligible applicants are:

- a) Canadian entities or groups of Canadian entities that operate broadband infrastructure; or
- b) Canadian entities or groups of entities that do not operate broadband infrastructure but have identified a plan to engage an entity or group of entities with experience building, owning, and operating the infrastructure their project(s) is proposing may also be eligible.

Innovation, Science and Economic Development Canada (ISED) is interested in hearing from all parties ready to participate in a project to bring improved connectivity underserved households. Eligible applicants are invited to come forward with expressions of interest until September 27, 2024. In addition to expressed interest, ISED will require that parties demonstrate the project is technically feasible, sustainable and financially viable. The maximum amount of funding available for a broadband project is up to 75% of the total eligible costs, or up to 90% of the total eligible costs for projects targeting very remote areas, satellite-dependent and/or Indigenous communities. ISED will work with interested parties to determine if they have a project that meets these criteria.

To submit an expression of interest, or to bring forward your questions including more detailed mapping information, please reach out to: get-connected-branchez-vous@ised-isde.gc.ca. A program official will follow up with you directly in your preferred method of communication.



2. Government of Canada: Zero Emission Vehicle Infrastructure Program



Funding Amount:

- \$4,000 incentive on new qualifying EV purchases
- \$2,500 incentive on used qualifying EV purchases

Eligible Vehicles:

- Both battery electric vehicles and plug-in hybrid electric vehicles are eligible for the incentive.
- Used EVs must be less than four years old and incentives for leased vehicles will be proportionate to the length of the lease, with a full incentive for a four-year lease.
- Manitobans who already bought an EV between Aug. 1, 2023, and July 1,
 2024, can apply for the incentive on the Manitoba Public Insurance website.



On behalf of Enbridge Pipelines Inc. and Enbridge Southern Lights GP Inc. (collectively known as Enbridge), Synergy Land Services Ltd. is continuing efforts to advance the process of attaining formal agreements with third party stakeholders. Enbridge is conducting an investigative program for our pipeline systems. Following analysis of our Inline Inspection tool results, we will be proceeding to check any possible anomalies. In order to verify the features, we are required to excavate and expose the portion(s) of pipeline that have been identified as a possible risk. The program is part of Enbridge's continued efforts in maintaining the integrity and safe operations of its pipeline system.

Our Procedure is as follows:

- 1. Survey and identify the dig location
- 2. Excavate to expose the pipe
- 3. Clean the pipe of existing coating
- 4. Inspect the pipe
- 5. Maintenance on the pipe, if required
- 6. Re-coat the pipe
- 7. Backfill excavation and reclaim all affected areas
- 8. Revisit site 1 year from reclamation date to monitor affected lands

The amount of time required at each dig location can range from 5-15 days. However, access may be required for a greater length of time if adverse weather is encountered or multiple digs exist within the same section of land.

The equipment involved will include:

- · XL5200 tracked Gradall or Excavator, or similar equipment
- 1/2, 3/4, 1, and 3 ton trucks for welding, sand blast and coating.
- · Small reclamation and snow clearing equipment
- Hydrovac

In order to expedite the process of acquiring permissions, we would like to propose that a blanket consent be considered, with uniform and appropriate Terms and Conditions to be accepted by Enbridge. Please consider:

- The Enbridge Land Consultant will provide documentation and a survey sketch showing access, workspace, approaches and access points that are proposed.
- No formal applications for permits will be required for access utilizing existing approaches, or for temporary access development, which would be standardized.
- No formal applications for permits will be required for Temporary Workspace for excavations.
- No formal applications for permits will be required for Temporary Workspace for equipment and soil storage.
- Existing approaches will be used whenever possible.
- Any temporary access and workspace will not affect natural drainage paths or affect the landowners directly adjacent to the access routes.
- All existing approaches will be left in the same or better condition once the project is complete.
- All ditch access (no fill added) must be restored to same or better condition, with original grade maintained.
- All temporary approaches/culverts (fill added) will be removed as soon as possible and the area restored to the same or better condition. If a temporary approach is required a representative may direct the contractor.
- All excavation(s) will be filled and the lands monitored and restored to the same or better condition through our remediation program.
- A representative may, at time to time, inspect the affected areas and may choose to inspect the final clean-up once Enbridge is complete. Enbridge may provide notification once final restoration is complete at each location.
- Enbridge or an Enbridge designate will make formal requests on a site by site basis when actual excavation
 is required within any portion of the traveled Road Allowance or temporary access is required through a
 ditch, the city will impose conditions on a site by site basis.
- Enbridge or an Enbridge designate will make formal requests on a site by site basis when a road or lane closure is required.
- A representative may contact one of the Enbridge representatives listed below if any issues or concerns are reported regarding the chosen access routes.





Launch of the Canada Public Transit Fund

Following many years of advocacy, FCM was pleased to see the launch of the new Canada Public Transit Fund (CPTF) on July 17, an important step forward for public transit infrastructure in Canada.

Two funding streams were opened in mid-July:

 The baseline stream, \$500 million annually, is open to existing transit systems and will support state of good repair, expansion and other capital improvements. Expressions of interest are due September 16, 2024. The metro-region agreement stream, \$2 billion annually, is targeted to transit expansion in metropolitan regions through Integrated Regional Plans. FCM particularly welcomes the \$20 million made available for early planning costs.

A third stream, yet to be launched, will target other priority areas like rural transit, active transportation and electrification.

FCM will continue to engage with the federal government on the details and design of the fund. This includes exploring how funding streams can be applied in communities of all sizes, making the fund permanent and indexed to ensure the fund retains its value over time, and ensuring the funding is quickly accessible to municipalities.



Spotlight on a Manitoba Accessibility Fund Project

The Manitoba Accessibility Fund is proud to spotlight projects from three previous grant recipients.

South Interlake Regional Library – Literacy for All Manitobans

× Management of the second of

South Interlake Regional Library provides public library services to the rural municipalities of Rockwood and Rosser and the towns of Stonewall and Teulon. Our mission is to enhance South Interlake communities through literacy by providing innovative, accessible and dynamic library services and programs. We strive to be the welcoming heart of our communities where patrons of all generations are included, educated, informed and inspired.

Rural libraries in our province have recently gained access to the digital collection of the Centre for Equitable Library Access (CELA). CELA provides library patrons with print disabilities access to 1.2 million titles in accessible formats via a smart device. In many parts of Manitoba, people with print disabilities do not have access to a smart device due to economic or technology barriers such as a lack of high-speed internet.

Our project, funded by the Manitoba Accessibility Fund, used the existing inter-library loan system to lend accessible audiobook players preloaded with titles from CELA free of charge to people across Manitoba who have a print disability. In partnership with CELA, we also hosted a training workshop and displayed materials for rural librarians to raise awareness of Manitoba's Accessible Information and Communication Standard.

The project was launched at the end of April, and we are pleased that several audiobook players are already in circulation. Feedback from patrons using the service has been very positive, with more than one saying that this service has been life-changing. We are delighted to offer this new service to remove barriers to literacy and accessibility for persons living with print disabilities. We are also proud to support rural librarians in providing this service in their own communities.

Transportation Options Network for Seniors

Transportation Options Network for Seniors (TONS) is a provincial organization that focuses on developing and enhancing relationships with current transportation providers in the public and private sector as well as distributing research and best practice recommendations. We aim to

increase awareness and provide education on the transportation needs for older adults in Manitoba with the goal of ensuring that individuals can choose to age in place within community and that communities see transportation as a valuable investment for creating age-friendly communities. We work to provide resources, tools and networking opportunities for transportation services and service providers who support older adults across Manitoba with a specific focus on, but not limited to intercommunity transportation programs like accessible van services in rural communities.

With support from the Manitoba Accessibility Fund, TONS worked with the Independent Living Resource Centre to host three online wheelchair securement and customer service training sessions via Zoom. Fifty people from 30 different communities attended. The goal of the training was to reduce barriers to accessing information about wheelchair securement. Training included tips on how to tie down wheelchairs in transportation vehicles, customer service training that meets AMA standards and training on the Accessible Transportation Standard.

There are training requirements in place for all para-transit providers, contained within the Accessible Customer Service and Accessible Transportation Standards, although training is not always available to small rural transportation providers. It was extremely beneficial to provide training to smaller transportation groups in hopes that community members and older adults can safely access transportation across the province. As the training sessions were recorded, organizations could go back to re-watch. They could also access resources which included a transportation toolkit and an online training manual.

Boyne Regional Library

Boyne Regional Library is a public library in Carman, Manitoba serving the town, the Rural Municipality of Dufferin and several surrounding communities. Many of our patrons request books in large print as they can no longer read regular print comfortably and want to continue reading. We offer tech help to the community, in the library and through an outreach program. This helps to remove barriers that seniors are facing in the everchanging digital age.

With support from the Manitoba Accessibility Fund (MAF), we were able to expand our large print collection and purchase a fully accessible public workstation, an accessible high contrast keyboard, computer and a large monitor. Patrons without internet access at home can now comfortably access information, participate in continuing education and communicate through email. By providing help with our library reading apps, library users with accessibility barriers learned to access online eBooks and audiobooks, giving them a wider selection of reading materials in formats to meet individualized needs. Through an iPad lending program, patrons are also given access to apps and technology.

MAF funding enabled us to introduce Wonderbooks into our collection. Wonderbooks are print books with a ready to play audiobook inside. Each book is a customizable reading experience based on reading levels and abilities. The response for the Wonderbooks has been incredible with families and educators.

Our library and community have greatly benefited from MAF. The funding allowed us to improve and provide accessible library materials for all and

inform staff about ways to recognize and proactively address accessibility barriers.

Workplace Accommodation Requests

All employees, who are temporarily or permanently disabled by one or more accessibility barrier in the workplace, have the right to request workplace accommodations. Under the <u>Accessible Employment Standard Regulation</u> when an employee makes a request for an individualized accommodation plan to remove a temporary or permanent barrier in the workplace, it sets in motion the employer's **legal obligation** to assess, develop and implement a plan to review reasonable accommodation options.

The Accessible Employment Standard Regulation outlines responsibilities for both the employer and the employee in relation to individualized accommodation plans. Among other requirements, an employee is responsible for providing relevant information to assist in the assessment of an accommodation request, while the employer must identify how often an established plan will be reviewed. Additional details about these responsibilities can be found in sections 12 and 13 of the regulation.

Reasons for Denying a Request

If a request for an individualized accommodation plan is denied, employers in Manitoba are obligated to provide **written** reasons for the decision. Such circumstances may include, but are not limited to:

- If an independent regulated health professional does not support the employee's self-assessed requirement for a workplace accommodation.
- If there is evidence that the request would cause undue hardship (e.g., create a major and measurable cost to the employer or health and safety risks).

It is important to note that a reasonable accommodation offered by the employer may not always be the requested or preferred accommodation of the employee. An employer may offer a different reasonable accommodation to remove the barriers presented.

Remember: Creating workplace accommodations is a shared responsibility between the employer and employee. Collaboration is critical to identifying and implementing a reasonable accommodation that meets the individual's unique needs in the workplace.

This July, Celebrate Disability Pride Month

Recognized each July, Disability Pride Month is a movement of empowerment and visibility for people with disabilities. It's a time for community members and advocates to reflect and speak out against societal barriers.

Disability Pride Month was first celebrated in the United States in July 1990. This was the same year that the Americans with Disabilities Act came into law. Today it is recognized around the world. This July, take some time to celebrate Disability Pride Month by reflecting on the role society plays in removing barriers while reflecting on the multiple intersecting identities within our community.

- The Five Colours: Representing the variety of disabilities, needs and experiences, including Mental Illness, Neurodiversity, Invisible and Undiagnosed Disabilities, Physical Disabilities and Sensory Disabilities.
- The Parallel Stripes: Forming solidarity within the disability community, despite differences.




