

## Manitoba Government Invests in Dike and Dam Construction Projects

The Manitoba government is investing \$20.4 million to repair dikes and dams throughout Manitoba.



#### **AMM** Supports Call to End Rail Labour Dispute

Nisku, AB, Regina, SK, and Portage la Prairie, MB, August 20, 2024 — As a nationwide labour dispute looms between Canada's two major freight railways and the union representing workers at each, the associations representing rural municipalities in Alberta, Saskatchewan and Manitoba are extremely concerned about the impacts that a rail work stoppage would have on Prairie agricultural producers, consumers and other industries crucial to rural communities.

The Rural Municipalities of Alberta (RMA), Saskatchewan Association of Rural Municipalities (SARM), and Association of Manitoba Municipalities (AMM) are urging Steven MacKinnon, federal Minister of Labour, to order binding arbitration if the railways and union are unable to reach an agreement prior to Thursday, when labour disruptions would begin. Even a short-term work stoppage will have massive impacts on the agriculture sector, which already struggles to access rail cars to move harvests to market.

"Canada's Labour Code allows the Minister to require binding arbitration for situations just like the one looming later this week," explained Bill Huber, SARM acting President. "Both CN and CPKC provide Prairie farmers with critical access to markets. Without trains running, the livelihoods of thousands of producers are at risk. If Minister MacKinnon does not act on requiring binding arbitration, he and his government must be willing to live with the economic and social consequences the decision will bring across the Prairies."

The RMA, SARM and AMM represent rural municipalities in Alberta, Saskatchewan, and Manitoba respectively. Members of each association provide municipal guidance and services to municipalities that host the vast majority of western Canada's agricultural production. Across the Prairie provinces, a strong, stable agriculture industry is directly linked to vibrant and sustainable rural communities. Access to rail is an essential aspect of industry and community strength, and it cannot be undermined by labour disputes, particularly when the Government of Canada has tools available to resolve the dispute fairly through binding arbitration.

"Across rural Alberta, producers of all sizes rely on access to rail to get their product to market. Even a short disruption in rail service may have a domino effect which could lead to long-term industry-wide impacts," commented RMA President Paul McLauchlin. "From the perspective of Alberta's rural municipalities, this is not simply a labour issue; it is an economic development issue, it is a community sustainability issue, it is even a food security issue. While I understand that the Minister wants to allow the railways and union as much time as possible to negotiate, not stepping in to protect rural livelihoods and communities will escalate this from a labour dispute into a situation that puts entire rural communities and industries at risk."

Much of the grain produced in the Prairie provinces is exported internationally, meaning that without rail access to international ports there are simply no alternative markets available for producers. This creates significant issues locally through strain on grain-handling and storage facilities, as well as related to Canada's international reputation as a stable and high-quality agricultural producer. If international customers are unable to trust the reliability and timeliness of Canada's agriculture industry, they will begin to look elsewhere, which will create a ripple effect throughout the industry and rural communities.

"Agriculture is a sophisticated, complex, and internationally connected industry based on a complex worldwide supply chain. When one of the first 'links' in that chain is compromised, as would be the case if a rail work stoppage occurs, the impacts are widespread, in Manitoba,

Canada and across the world," explained AMM President Kam Blight. "We are very concerned that a work stoppage will not only place several municipalities at risk in the short-term but will create a significant reputational and logistical challenge that could harm local communities in Manitoba and across western Canada for years to come."





While the AMM Board maintains the policy of confidentiality regarding ongoing discussions with the provincial government and stakeholders, we are pleased to share some of the topics with you.

#### **Bill 37 / Planning Legislation Review Update**

Throughout the summer months, Braid Solutions Inc. has been holding focus group discussions to better understand municipal concerns regarding amendments to *The Planning Act and The City of Winnipeg Charter* (former Bill 37 and Bill 34). Please note, that as part of these discussions, all municipalities in the Province have been asked to provide data on development and planning approvals, including financial costs and administrative burdens, to assess the impacts since the legislation was introduced. As the deadline has been extended, we encourage you to complete the survey to capture accurate data on resources and cost impacts of the legislation.

#### Medical First Responders Update

Back in April, the Department of Health, Seniors and Long-Term Care proposed changes to the Medical First Response model in Manitoba. For nearly four years, our organization and municipalities have raised concerns about public safety risks and emergency response impacts resulting from the framework established by the College of Paramedics of Manitoba (CPMB) on December 1, 2020. We thank the Province for proposing regulatory amendments to address these concerns and allow communities to operate Community-Based First Response programs.

The public consultation closed on May 25, 2024, and the Department is currently reviewing the feedback as they move forward with launching the new MFR system. We anticipate an announcement in the fall and will keep you informed as updates become available.

#### **Proposed Amendments to Power Engineers Regulation**

The AMM and municipalities have voiced concerns about the challenges recreation complexes face in recruiting and retaining sufficient certified staff to keep arenas open due to power engineering certification requirements. Therefore, we welcome and support the proposed amendments, particularly the introduction of a tiered certification system for refrigeration plant operators. This approach ensures that certification requirements are more closely aligned with the responsibilities and expertise required for different types of refrigeration facilities, while still upholding the highest level of safety for all occupants.

Please note that the Department of Labour and Immigration is seeking your feedback on proposed amendments to *The Power Engineers Regulation*. We encourage you to review the proposed amendments and submit your feedback through the consultation portal by **September 22, 2024**.

#### Accessible Employment Standard Regulation – Engagement Opportunity

On July 15, the Manitoba government launched an engagement session on EngageMB, as each standard under *The Accessibility for Manitobans Act* must be reviewed every five years to ensure they continue to meet the needs of all Manitobans. The AMM has consistently advocated for increased funding to support the implementation of these standards and for the Department to provide the necessary tools and resources to facilitate a smooth transition to compliance. The engagement session is open until **November 1**, and we encourage you to share your insights on how this standard affects municipal operations and staff time.

## Nomination Information: Executive Committee Election

**September 10, 2024** - The annual AMM Fall Convention will take place in Winnipeg from November 25-27, 2024. There will be elections at this year's convention for the AMM Executive Committee, consisting of the President and two Vice-Presidents. The term of office for the President and Vice-Presidents is two years. The President and Vice-Presidents can be elected to an Executive Committee position in multiple terms.

#### **Executive Committee Nominations:**

Municipalities can nominate a municipal official for the President position, Vice-President position, or both, but the official can only accept nomination for and be elected to one position. Nominations for positions on the Executive Committee must be by resolution of Council. Each nomination must be supported by a separate resolution.

Only elected officials of member municipalities are eligible to be President or Vice-President of the AMM Executive Committee.

Nominations for candidates for a position on the Executive Committee must be submitted in writing, accompanied by a supporting Council resolution, to the Executive Director of the AMM. Please submit these by **November 4**, **2024**, which is **21 days before** the opening day of the AMM Fall Convention, at:

No nomination for an Executive Committee position is effective unless the nominee accepts the nomination by giving written notice to the Executive Director <u>no later than 14 days</u> before the opening day of the AMM Fall Convention. For this year's elections, accepted nominations must be received by the Executive Director by no later than <u>November 12</u>, 2024.

Any member of the AMM Board of Directors who accepts a nomination for an Executive Committee position vacates their position on the Board effective as of the date the member accepts the nomination.

\*\*\* Please note that the AMM Board of Directors made changes to Article 5, Section 2 of By-Law 1998. These changes were approved by members at the AMM Fall Convention in November 2023 and include the following:

THEREFORE BE IT RESOLVED THAT nominations for the positions of President and Vice-President shall be made by notice in writing by a Regular Member to the Executive Director no later than 21 days before the opening day of the AMM Fall Convention. The nomination is ineffective unless accepted by the nominee by notice in writing to the Executive Director no later than 14 days before the opening day of the AMM Fall Convention. Nominees can only accept nomination for one position, that is, for the position of President or for Vice-President position, not both.

These changes will enable all candidates to determine the level of resources they wish to allocate to their campaigns.

#### **Executive Committee election:**

**President:** A candidate for President must receive 50% plus 1 of the total number of votes cast to be elected as President.

**Vice-Presidents:** The 2 candidates for Vice-President who receive the highest number of votes are elected as Vice-Presidents. There will be a further ballot at the Convention if there is a tie, involving only the tied candidates.

We encourage all municipal officials to attend this year's Fall Convention.

The Town of Carberry and Municipality of North Cypress-Langford were pleased to receive a \$10,000 Age Friendly grant to enhance our local Drop-In Centre, which serves as a central hub for our senior community. This grant was a crucial step in our effort to ensure a comfortable and welcoming environment for our aging residents.

In late spring, we installed five ductless split heating and cooling units at the Drop-In Centre. The total cost of this project was \$17,312.45. Beyond the \$10,000 grant, we leveraged milestone achievement funds from both the Town of Carberry and the Municipality of North Cypress-Langford to cover the remaining expenses, with the balance funded by both councils.

The new air conditioning units have already made a significant difference, creating a more comfortable space for our seniors and the volunteers who provide weekly lunches. The purpose of this email to provide an update on the number of Statutory Review of Planning and Development Legislation – Data Requests that have been completed as of Thursday August 29<sup>th</sup> at 5:30 PM CST:

- Data Requests Completed 22 (16% of municipalities)
- Data Requests **Underway 55** (47% of municipalities who have not completed the request)

This represents significant progress since the last update.

Manitoba would also like to bring attention the revised direction to the data request that was released last Friday August 23<sup>rd</sup>. The deadline to submit the data request has been extended and guidance on planning and development records has been introduced:

- Timeline Extension: the deadline to submit the Statutory Review of Planning and Development Legislation Data Request is at 4:00 PM CST on Friday September 20<sup>th</sup>.
- Records Prioritization: continue to prioritize records relating to (a) Zoning-By Law
   Amendments (e.g., Rezoning) and (b) Subdivisions (Standard and Minor) for the years of 2023, 2022, 2020, and 2019. Participants are still encouraged to provide all data as originally requested if their resources permit.

Manitoba appreciates the efforts municipalities continue to allocate towards this request. The objective of this review is to identify ways of improving planning and development legislation and to incorporate your municipality's perspectives into any decisions made by the province on existing planning and development legislation. Your participation in this initiative is highly encouraged by Manitoba and the Project Review Team to ensure we are considering your municipality's perspectives into any recommendations made.







# Water breakages highlight the need for infrastructure investment

This summer, a series of high profile and highly disruptive water breakages have struck Canada's major cities and impacted millions of Canadian residents and businesses.

These breakages have highlighted the need for much needed infrastructure investment.

FCM has long championed improved investment in our water and wastewater systems. A major concern in urban and rural communities, these breakages are symptoms of stretching local government budgets struggling to maintain approximately 60 percent of our infrastructure and a municipal funding system that isn't fit for a modern, growing Canada.

In media comments this week, FCM President Geoff Steward called the issue of aging water infrastructure an urgent one, and advocated for a new Municipal Growth Framework to tackle the root causes of the issue.

FCM has highlighted the need for additional federal funding for water and wastewater in our recent **recommendations for Budget 2025**. We will continue to focus closely on this vital issue and call for the federal government to convene all orders of government to negotiate this urgently needed framework.

A Municipal Growth Framework is necessary to prevent a serious infrastructure gap.

Minister Wiebe,

I am writing to you today to request additional resources be allocated from your department to Blue Hills RCMP.

Over the summer, serious incidents of property crime have increased at an alarming rate in Westman, causing significant concern about the level of police presence within our communities. My constituency of Spruce Woods is predominantly policed by the Blue Hills RCMP, and these officers do excellent work in our communities, but they need further support from your government.

Following your unilateral decision earlier this year to disband the Rivers Police Service and add Riverdale Municipality to Blue Hills RCMP's area of jurisdiction, you have significantly increased the population and geographic area that Blue Hills RCMP cover, and yet you have added no new resources or positions to support this increased work load. In addition, the Blue Hills area has experienced significant population and economic growth in recent years, adding to the number of property crimes, traffic incidents and domestic calls for Blue Hills RCMP officers.

Your office has received correspondence from two municipal councils within Spruce Woods Constituency and the Blue Hills RCMP area requesting support to address these concerns, and I have no doubt that more will follow. I am adding my voice to urge that you and your government to take action and add new officer positions to the Blue Hills RCMP to ensure this region has the police presence and coverage that residents expect and deserve.

I look forward to your prompt intervention in this matter.

The Green and Inclusive Community Buildings (GICB) program is launching its third intake and will be accepting applications as follows:

#### Small and medium retrofits

Eligible applicants with small and medium-sized projects to retrofit existing

community buildings ranging in total eligible cost from \$100,000 to \$2,999,999 can apply from **August 1, 2024 until October 16, 2024, 15:00 ET.** 

#### Large retrofits and new builds

Eligible applicants with large projects to retrofit existing community buildings or projects to build new community buildings with total eligible costs ranging from \$3 million to \$25 million can apply from **September 4**, **2024 until October 16**, **2024**, **15:00 ET.** 



# 2. Government of Canada: Zero Emission Web rie Infrastructure Program

This funding opportunity will support:

- the deployment of EV chargers, including fast chargers, in public places across Canada such as highways and public lots.
- the deployment of EV chargers at private locations, including multi-unit residential buildings, workplaces and where on-road vehicle fleets are serviced.

- Electric utilities

- Indigenous businesses and community groups

#### 3. Manitoba Government - Electric Vehicle Rebate program

This funding opportunity provides \$25-million for the Manitoba Electric Vehicle Rebate program.

- There is a limit of only one vehicle per purchaser during the duration of the program.
- The vehicle must remain in owner's name and be registered in Manitoba for a minimum of 12 months.
- Crown corporations, federal and provincial governments are not eligible.

**Application period:** for EVs purchased on or after Aug. 1, 2023, and will run until March 2026.

#### **Funding Amount:**

- \$4,000 incentive on new qualifying EV purchases
- \$2,500 incentive on used qualifying EV purchases

#### **Eligible Vehicles:**

- Both battery electric vehicles and plug-in hybrid electric vehicles are eligible for the incentive.
- Used EVs must be less than four years old and incentives for leased vehicles will be proportionate to the length of the lease, with a full incentive for a four-year lease.
- Manitobans who already bought an EV between Aug. 1, 2023, and July 1,
   2024, can apply for the incentive on the Manitoba Public Insurance website.

We do this by delivering in-class and field training opportunities for onsite practitioners, providing networking and learning opportunities for industry stakeholders, forging positive relationships with local and provincial regulators, and educating the public. MOWMA's operating budget is entirely funded through its programs and membership fees.

MOWMA is a provincial chapter of the Western Canada Onsite Wastewater Management Association (WCOWMA). WCOWMA is registered federally as a not-for-profit corporation.

#### What Services Do We Provide?

 Advocacy for the onsite wastewater industry The Association communicates and works with the industry and regulatory authorities to help professionalize and improve service delivery to people in Manitoba who live in unsewered areas.

#### Onsite Wastewater Practitioner Training

Those working in the onsite wastewater industry in Manitoba are required to complete a
training program recognized by Manitoba Environment and Climate. With the changes in
technology and the basis of system design in soil science, training in this discipline is needed to
meet the regulatory requirements. The training program offered by our organization has been
formally recognized by the regulatory authority in Manitoba for over two decades.

#### > Field Training

 To improve the quality of installation in the Province, the Association hosts Site and Soil Evaluation Days and when available, System Installation Days. These opportunities to gain hands-on experience promote better installation practices and a higher level of understanding about how wastewater is treated in the soil profile.

#### Education Days

 MOWMA provides annual education days to the onsite wastewater community, to bring environmental officers and contractors together to discuss industry concerns, new rules, regulations, and standards, review system design, and introduce new technologies.

#### Public Education

 The Association's Septic Sense program provides homeowners with information on how to operate and maintain their onsite wastewater system to improve performance and longevity.

#### System Design Review

 The Association provides system design review services for contractors who need help, information, or resources to ensure their designs meet the regulatory requirements. This service is also available for Environmental Officers with questions about a permit application that is under review.

#### Consulting and Resources

 The Association is available to provide consulting services and resources to help promote and maintain the quality of onsite wastewater systems being designed and installed in Manitoba.





#### **AMMONIA or ANHYDROUS AMMONIA**

Ammonia is a naturally occurring chemical. Our bodies make it in small amounts as a waste product. Farmers use it in concentrated form as a nitrogen fertilizer. It is also used for refrigeration and to make many industrial products such as adhesives and cleaning products like Windex.

Ammonia is a hazardous product in its concentrated form, so people using ammonia take many precautions to ensure its safe use. If you are near an ammonia facility or operation, it is important that you know about ammonia and what precautions to take in the unlikely event of an emergency.

Ammonia is caustic in nature, and will cause chemical burns if it contacts your eyes or lungs in high enough concentration. Ammonia has a pungent, biting odor that you can easily smell at very low concentrations.

Ammonia fertilizer is transported and stored as a liquid in pressurized tanks .If an accident were to occur, any ammonia spilled quickly turns to vapour and blows with the wind as it dissipates.

#### WHAT TO DO

If there is an ammonia accident nearby, you should move across wind to get away from the ammonia vapour. In a building, it is best to shelter in place. Quickly close all the windows, doors, and vents and call for help. The smell may become strong inside, but not enough to hurt you.

#### WHO TO CALL

In an emergency, please call local emergency services (911). You are also welcome to call your local ammonia fertilizer business at any time.

For skin contact:

 Remove contaminated clothing as quickly as possible. Flush exposed skin with large amounts of water for at least 30 minutes. Use warm water if available. If irritation persists, seek medical attention. Dispose of contaminated clothing in a manner that limits further exposure.

Using appropriate respiratory protection remove the affected individual from the area of overexposure. Allow the person to rest in a well ventilated area. If irritation persists, obtain medical attention.

#### For severe inhalation:

Use proper respiratory protection to evacuate affected individuals to a safe area as soon as possible. Loosen tight clothing around the person's neck and waist. If breathing is difficult administer oxygen. If the person is not breathing, perform artificial respiration and obtain immediate medical attention.

For ingestion:

 If the victim is not breathing, begin artificial respiration and continue until the victim is breathing. Do not induce vomiting. Careful removal of the ammonia from the stomach by medical personnel is required. Call a physician or poison control center and seek immediate medical attention. If tolerated and if victim is conscious, give no more than 1 cup of milk or water to rinse the mouth and throat and dilute the stomach contents. No more than 8 ounces (1 cup) in adults and 4 ounces (1/2 cup) in children are recommended to minimize the risk of vomiting.

What should you do in the event of a spill?

Follow any special instructions given over the radio, T.V., or by someone in authority.

If there is a fire or an explosion, stay away from the site. Follow standard, marked emergency routes or directions from police to travel to your destination.

#### there has been a release of toxic vapors:

- Go indoors immediately and tightly close all doors, windows, and openings.
- Turn on your radio or television to a local news station. (Be prepared to wait a few minutes for news.)
- Follow any special instructions given over the radio or television, or by someone in authority.
- Shut off all air conditioning units, fans, ventilation systems and clothes dryers. In winter, turn your furnace to its lowest setting and close fireplace dampers.
- Evacuate only if advised to do so by local authorities.

#### YOU may wish to:

- Place wet towels at the base of doors or breathe through damp towels.
- Bring in pets if they are nearby and easily found.

#### Unless you are told to do so by authorities:

- DO NOT evacuate or travel.
- DO NOT bring home children from school, or other family members from work.
- DO NOT call 911 or any other authority for information. Keep your telephone line free.

When you have been advised of an ALL CLEAR, open your house to let it air out.

#### What is Anhydrous Ammonia?

Anhydrous ammonia is a liquefied gas, which is made by putting ammonia gas under pressure and chilling it to below -33°C. The term "anhydrous" means "without water". This product has a sharp odor and is both naturally occurring in the environment and industrially-manufactured.

#### HOW is Anhydrous Ammonia used?

Anhydrous ammonia is one of Agrium's key fertilizer products. It is used as the nitrogen source for fertilizer, and also in the manufacture of some specialty fertilizers. It is used by other industries for making refrigerants and household cleaning products.

#### What are the potential hazards?

Anhydrous ammonia is transported as a liquid at temperatures below -33°C. In the event of a large spill it can form a toxic vapor cloud that is heavier than air until its temperature increases.

Anhydrous ammonia is corrosive to copper, silver, aluminum, zinc, and alloys. It reacts with body moisture, so it may burn body tissue - skin, eyes, mouth, throat, lungs, and stomach - on contact, if inhaled or swallowed.

Ammonia is generally tolerable at concentrations up to 25 parts-per-million (ppm), although the smell is unpleasant and sharp. Above this concentration, imitation of the eyes, nose, and throat may begin. Above 400 ppm, skin burns and coughing occur immediately. The U.S. National Institute for Occupational Safety and Health (NIOSH) has established 300 ppm as the concentration that is immediately dangerous to life and health (IDLH); at this concentration a person's ability to escape is impaired.

At concentrations between 1000 ppm and 2500 ppm, increasing chest tightness and severe eye, skin, and lung irritation will result. Immediate suffocation may result at concentrations above 2500 ppm. Effects may be more pronounced at lower concentrations in children, the elderly, and persons with impaired lung function.

#### S Anhydrous Ammonia flammable or explosive?

Anhydrous ammonia is a slightly flammable liquid. It is not explosive.

#### What are the Emergency Response procedures?

In the event of a spill or accidental discharge of anhydrous ammonia, the fire department will assess the scene. Possible actions could include, but are not limited to, evacuating the area or implementing Shelter-in-Place procedures (see the section titled "If there has been a release of toxic vapors"). The emergency responders will attempt to stop the leak of anhydrous ammonia. When anhydrous ammonia is released it maintains its temperature below -33°C (auto-refrigeration) for some time, depending on factors such as outdoor temperature. The product stays in its liquid form, with only the outer layer closest to the air vaporizing at any given time. Emergency responders will not mix water used for firefighting directly with the anhydrous ammonia, as this could result in warming of the product, causing the liquid to turn into a toxic vapor cloud. However, they may use a water spray downwind of the leak source to absorb ammonia gas and dilute the vapor cloud, ensuring the water that is sprayed does not come into contact with the product. The spilled anhydrous ammonia would be recovered using earth moving equipment and sent to a Class1 landfill for appropriate disposal.

#### What should you do if you are exposed to Anhydrous Ammonia?

#### For eye contact:

Check for and remove contact lenses. IMMEDIATELY flush eyes with running water for at least 30
minutes, keeping the eyelids open. Use warm water if available. Obtain immediate medical attention.
