

Decentralizing Food Waste in Manitoba: RM of Ritchot's FoodCycler Program



Food Cycle Science highlights the RM of Ritchot as one of the recent Manitoba municipalities to participate in the FoodCycler program, an innovative initiative aimed at tackling residential food waste. Using food recycling technology, households are empowered to manage their food waste right at the source of creation – in their own home.

100 homes in the community took part in the 12-week pilot last summer, diverting approximately 6.6 metric tonnes of food waste from their local landfill over that

short span. On an annual basis, participating households are expected to save over 4000 standard bags of garbage from the local landfill. For context, this is equivalent to diverting 34.4 metric tonnes of CO₂ (which is the same amount of carbon sequestered by 41.6 acres of forest!).

Ritchot is one of 25 Manitoba municipalities to participate in the FoodCycler program, and they are now exploring ways to build on this success and extend the program's impact across more homes. These strong waste diversion results have driven other communities to act on

decentralizing food waste management, and your municipality could be next. 



Legacy Drainage Licensing Project

July 25, 2025 – In 2023, Manitoba Environment and Climate and the Association of Manitoba Municipalities (AMM) worked together on a Legacy Drainage Licensing Project to help municipalities take a coordinated approach to bringing older, unlicensed drainage works into compliance and achieve best value from the licensing system.

The AMM has confirmed that the project materials remain current and relevant. As a <u>reminder</u>, a summary of the Legacy Drainage Licensing Project process can be found at the links below:

- <u>Drainage FAQ (January 2021)</u>

The Legacy Drainage Licensing Project allows municipalities to submit a single application to provide permanent authorization for maintenance of an entire drainage network. In order to defray applications costs, the single application fee (\$500) can be potentially spread over multiple drainage projects.

At the present time, applications need to be submitted using a paperbased application form. Once received, the application will be uploaded to your existing water licensing portal account. All of the work referenced in the application would need to be accompanied by survey data for all drainage works. This would also include non-contiguous works (if a contiguous survey is included) and would support a "whole watershed approach" to drainage.

Paper-based applications can also be obtained by contacting **drainage@gov.mb.ca**. If you need further assistance in submitting an application, please contact your local water resource office - www.gov.mb.ca/sd/pubs/water/water_rights/officer_aof_contact.p df.

The AMM commends the provincial government for taking action to address long-standing municipal concerns related to drainage project approvals. This initiative will help streamline the approvals process and significantly reduce costs for municipalities.







I am reaching out to invite municipal input into a provincial net-zero roadmap and the start of detailed action plans. We have reflected on past conversations, engagements and communications with you and other Manitobans. We would like to build on shared goals and identify key opportunities.

The Province of Manitoba is committed to a path to a net-zero future where we reduce greenhouse gas emissions while building a strong Manitoba economy for all. Addressing climate change has wide ranging benefits including the broader objectives of protecting the land, water and air. Getting to a net-zero emissions future will mean switching away from fossil fuels to low or zero emission energy sources, being more efficient with the energy we use, and adopting new production practices. As a province, we will need to invest in new skills training, technologies, systems and infrastructure across all sectors and communities to ensure that this shift results a prosperous economy.

Manitoba is examining ways we can reduce emissions over the next 25 years. At this time, we are identifying some key considerations and priorities that will be the framework for a Net-Zero roadmap. This Framework will lead to the development of Action Plans that will be reported on and updated regularly.

FCM attends the National Association of Counties' Annual Conference

This past weekend, FCM's Rural Forum Chair Neal Comeau and Board Director Alysson Storey traveled to Philadelphia to attend the National Association of Counties' Annual Conference. Their visit was part of FCM's ongoing efforts to strengthen cross-border relationships with American counterparts.

Many of today's most pressing challenges—such as housing, infrastructure, and local economic resilience—are deeply felt in rural communities on both sides of the border. During the conference, FCM engaged with local leaders from across the United States, exchanging insights and building stronger ties.

As part of the program, Board Director Alysson Storey highlighted FCM's policy and programming work to protect the Great Lakes and Canada's water sources. Her presentation sparked meaningful dialogue and laid the groundwork for collaborative action on shared environmental priorities.

This visit reinforced the importance of international cooperation in addressing rural challenges and advancing solutions for communities across North America.

FCM ready to oppose new U.S. tariffs inc. on Canadian copper

Last week, U.S. President Donald Trump announced a new 50% tariff on all U.S. copper imports, plus broader 35% tariffs on Canadian goods that are non-CUSMA compliant, with both to be applied August 1.

Canada provides the overwhelming majority of U.S. copper imports, with mines and facilities in British Columbia, Ontario, Manitoba, Newfoundland and Labrador, Quebec and Yukon producing world-class copper and employing thousands of highly skilled Canadian workers.

Since the trade war began, FCM has stood shoulder-to-shoulder with provincial, territorial and federal leaders in opposing all unjust tariffs. In light of these new threats, we will redouble our efforts to ensure support for Canadian communities and oppose these tariffs with effective advocacy on both sides of the border.





We are pleased to provide you with a copy of Multi-Material Stewardship Manitoba Inc.'s (MMSM) 2024 Annual Report, highlighting the results of Manitoba's residential recycling programs for packaging and printed paper.

The year had many highlights, with a large focus of our work geared toward the anticipated government approval of MMSM's draft transition plan to full Extended Producer Responsibility (EPR). The report highlights the 2023 recovery rates, community outreach and engagement, our continued efforts to engage and support First Nations and remote communities with their residential recycling programs, and the 2024 audited financials.

Other highlights of the report include:

- 74,888,843 kg of packaging and printed paper were collected in 2023, with a recovery rate of 71.8%.
- There were 148 participating communities and other partners.
- MMSM paid \$17,450,843 in funding to participating communities.
- 95% of Manitoba's population participates in their residential recycling program.
- There were 3,384 downloads of the Recyclepedia app and 146,459 material views.

Through Manitoba's Affordable Home Energy Program, eligible households who heat their homes with oil can receive **up to \$20,000 upfront** by applying to the federal <u>Oil to Heat Pump Affordability (OHPA)</u> program co-delivered by Efficiency Manitoba. This offer is a great way to help **low- to median-income** households **connected to an integrated electricity grid** looking to upgrade their oil heating system to a more energy-efficient one.

Households that participate in the OHPA program:

- Receive a grant payment of up to \$15,000 in federal funding and up to \$5,000 through Manitoba
- Receive a one-time payment of \$250 to further assist with the costs associated in transitioning from oil heating to an electric heat pump
- Experience year-round comfort an electric heat pump provides heating in the winter months and cooling in the summer
- Save \$1,337 on energy costs and 2.78 tonnes in greenhouse gas reductions on average, every year
