## FCM Communiqué to Manitoba Municipalities

Water and Wastewater Facility Operators

In December 2022, the AMM presented to the Water and Wastewater Operator Certification Advisory Committee (CAC) on barriers and opportunities for possible solutions to address municipal concerns. The CAC has been tasked with providing valuable recommendations to the Minister of Environment and Climate Change on improvements to the Water and Wastewater Facility Operator regulatory framework in Manitoba. The CAC's report and recommendations are expected by Spring 2023.

## Broadband Connectivity Update

In November 2022, the federal government announced a <u>\$475 million top-up to the Universal</u> <u>Broadband Fund (UBF)</u> that now totals \$3.225 billion. Since this fund's establishment, only \$9.6 million has been allocated to Manitoba according to the selected UBF projects webpage. Further, the AMM understands that UBF projects are being prioritized with MoU signatory provinces with targeted federal-provincial funds, yet Manitoba is one of two provinces that is not a signatory. Broadband connectivity in Manitoba continues to lag behind other parts of the country.

Moving forward, the AMM will continue to call on the Province of Manitoba to work in partnership with all orders of government to ensure available funds to support broadband connectivity, including funds under the Universal Broadband Fund (UBF), are fully maximized to support projects in local communities.

### **New AMM Resolutions Policy**

The AMM has implemented a new Expired Resolutions Policy effective immediately. Under this new policy, active resolutions that have been passed at the Annual Fall Convention will be active for eight years, totalling two full Council terms. Once a resolution has become more than eight-years-old, it will automatically be removed from the active resolutions list, unless it is retained by the AMM Board of Directors using the existing four-years-old reconfirmation process.

Resolutions older than eight-years-old may span multiple Councils and provincial governments. In this period, local priorities and the legislative and/or regulatory environment may have changed considerably since the resolution's original passage.

Please note that if a resolution is not reconfirmed, it will be removed from the active resolutions list and a letter will be sent to the sponsor(s) summarizing AMM advocacy efforts. At this time, sponsor(s) may be encouraged to put forth a new resolution based on updated advocacy efforts and current information.

Please note that other western Canadian municipal associations have similar polices in effect.

Good Morning,

We are writing to let you know that Environment and Climate Change Canada is developing a Management Plan for the Prairie Skink in Canada, a small burrowing lizard that is listed as Special Concern under the federal *Species at Risk Act* (SARA).

In Canada, the Prairie Skink is found only in southwest Manitoba, in two separate populations: the Brandon Sandhills and the Lauder Sandhills. Please see the attached Summary for more information.

For each species of Special Concern, Environment and Climate Change Canada must develop a Management Plan that provides information on the species and its habitat, establishes a management objective, identifies threats, and recommends broad strategies and conservation measures to address those threats and achieve the management objective.

The proposed *Management Plan for the Prairie Skink* was posted on the Species at Risk Public Registry on January 12, 2023 for a 60-day public comment period that ends on March 13, 2023. Following this, we will consider all comments received and work to finalize the document.

We invite your review of the proposed *Management Plan for the Prairie Skink* during this 60-day period. Your support will help to make this recovery document a success. # PRAIRE SKINK

Environment and

Under the Species at Risk Act (SARA), a management plan must be developed for each species listed as Special Concern in order to identify measures for the conservation of the species. This document highlights the key sections of the proposed management plan.

## **Species Conservation Status**

The Prairie Skink (Plestiodon septentrionalis) was initially listed as Endangered on schedule 1 of SARA but was down-listed to Special Concern in April 2021 because of a different interpretation of status assessment criteria. While the species is deemed to no longer be at risk of imminent extinction, it could become Threatened if factors affecting it are unmitigated.

## **Description and Distribution**

Prairie Skinks are small, slender burrowing terrestrial lizards (55-91mm snout-vent) with olive-brown backs and sides and four light stripes running the length of the body and onto the tail. The tails of juvenile skinks are bright blue. Males develop a reddish-orange patch on the chin during the breeding season.

The Prairie Skink is found throughout much of the great plains of North America from Manitoba to Texas. In Canada the (Northern) Prairie Skink is found in southwest Manitoba (Figure 1), in two separate populations: the Brandon Sandhills and the Lauder Sandhills. This is the northwest extent of their range, and is about 130 km distant from the closest populations in northeastern North Dakota.

## Habitat Needs

Prairie Skinks are associated with mixed-grass prairie on sandy soils that presumably allow them to dig below the frost line to avoid freezing winter conditions. Open grassland, with limited shrub canopy, allow the Prairie Skink to bask in order to achieve optimal body temperature for movement; vegetation structure and surface objects provide retreats and shade to avoid lethal higher body temperatures and predators. Prairie Skinks feed on a variety of small invertebrates, including crickets, grasshoppers, spiders and moth larvae.

## Management Objective

The management objective is to maintain the current distribution of the two Canadian populations of the Prairie Skink (Brandon Sandhills and Lauder Sandhills), and any new populations which may be discovered in the future.







## Threats to the Species' Survival

Past and ongoing low-medium threats to the Prairie Skink resulting in habitat loss and degradation include, but are not limited to:

- Invasive non-native species- Leafy Spurge (*Euphorbia virgata*) and Smooth Brome (*Bromus inermis*), threaten native mixed-grass prairie habitat by aggressively replacing native vegetation. The effects of these invasive plants on skinks are largely unknown, but dense stands could reduce structural heterogeneity of the habitat and limit skinks' thermoregulatory options.
- Fire Suppression Prairie Skinks require the open yet heterogeneous vegetation structure of native mixed-grass prairie. Fire suppression is a threat to mixed-grass prairie habitat (and skinks) in southwestern Manitoba because woody succession (growth of shrubs and trees) creates increased shade, which reduces the thermal suitability of the habitat for skinks.
- Housing and urban area development disturbs vegetation and soils, often by converting native prairie into gardens and lawns. This results in loss and fragmentation of native habitat, and additional issues for skinks in residential landscapes, including mowing lawns, predation by pets, and traffic.

## Strategies to Help Meet Objectives

To achieve the objectives of this management plan, three broad strategies are recommended. These and the *high* priority conservation measures that support these strategies are outlined below. See section 6 of the Management Plan for more detail on these and other conservation measures and associated research required to address knowledge gaps.

- 1. Habitat assessment, management, conservation and protection:
  - Participate in conservation efforts to halt loss of sandhill grassland habitat
  - Engage landowners and land managers in conservation or stewardship including best management practices and protection of important habitat
  - Monitor and assess effectiveness of implemented best management practices
- 2. Monitoring, assessment and research:
  - Develop and implement a monitoring program to assess trends in populations and habitat quality to address knowledge gaps.

## 3. Communication, collaboration and engagement:

 Engage landowners with known or potential Prairie Skink populations to raise awareness, and encourage the implementation of best management practices, reporting of occurrences, and participation in monitoring.

## Southwest Manitoba Priority Place Planning Initiative

#### **Project Overview**

Goal: a conservation plan for southwestern Manitoba that honours and incorporates socio-economiccultural perspectives and that is founded on a shared vision for the landscape and a spirit of collaboration and reconciliation.

Together with a broad group of partners we will develop a communitydriven, multi-partner, adaptive management-grounded approach to multi-Species at Risk recovery in the Southwest Manitoba Priority Place (formerly known as the Mixed Grass Prairie Priority Place - see map). The project is co-led by Environment and Climate Change Canada (ECCC) and the Nature Conservancy of Canada (NCC).



A priority place is an area of high biodiversity value that is seen as a distinct place with a common ecological theme by the people who live and work there. 11 Priority Places have been identified across the country as part of the Pan-Canadian Approach to Transforming Species at Risk Conservation in Canada

#### What Principles guide the project?

The project is built on the following principles:

- Multi-species & ecosystem-based approach
- Shared leadership and priorities
- Community-driven
- Reconciliation-minded
- Strengthened partnerships
- Evidence & Knowledge-based decision making
- Improved monitoring and reporting
- Better conservation outcomes for Species At risk
- Increased co-benefits for biodiversity, ecosystems and communities
- Delivery of strategic community relations and communication actions to inspire conservation
   action

#### **Project Description**

The project is a broad, multi-partner initiative co-led by ECCC and NCC, with the objective of using a conservation management framework (Conservation Standards) to engage local communities, peoples, industry and current and new partners in the framing, development and finalization of a shared conservation plan for Species at Risk (SAR) in the Priority Place project area. Planning will be people-oriented, with an emphasis on social-ecological systems, perspective sharing, and exploration of a lternative approaches, including pilot projects. Strategic sharing of interim and final conservation plan results and key messaging with planning partners and key communities will be emphasized to accelerate widespread plan adoption and cooperation. Overall, it is envisioned that by incorporating strategic public engagement and land management initiatives, outcomes will support enhanced viability for Species at Risk and biodiversity overall.

A Joint Community Relations Team will be established to develop and implement a Joint Community Relations Strategy. This community relations strategy will be implemented throughout the Priority Places area and will be a crucial tool for cultivating partnerships and sharing information about the area. Through this committee we will increase conservation awareness, come together for common interests and strengthen trust and relationships in the area.

Through the process of developing a pan-Priority Place conservation plan and associated activities, the relationship between existing conservation partners will be re-enforced, common ground with new partners and communities explored, and a common vision and goals created.

#### **Expected outcomes of Community Engagement**

- To enhance collaboration and new partnerships
- All forms of knowledge are being used to inform best-practice conservation
- Increased community-led nature-based conservation efforts
- Help advance the understanding of the importance of the area, its relationship with the communities that call it home, and the natural heritage that benefits all residents.
- Enhanced pride and awareness of the area's natural landscapes and wildlife heritage

#### January 2023

As the Hudson Bay Route Association welcomes in the new year, we want to share some of the successes throughout 2022! With a large amount of investment and increased visibility for both the Port and Rail, we believe that the opportunities and consistency will only become better in 2023!

To start things off, we have to appreciate the large federal government contribution of **\$147.6 Million** to the Rail-line and the port upgrade. The Province of Manitoba has also come to the table with a substantial **\$73.8 million**. The Route Association representatives Eldon Boone and Jim Berscheid met with Deputy Premier Cliff Cullen and his team to understand these long discussed moves. This was accompanied by an additional \$40 million of provincial investment in Center Port Winnipeg.

Some of their interest for investing stems from the need for shipping access from Prairie grain producers and other commodities including Potash, Oil, LNG, Hydrogen and Mine Concentrate- Nickel, Lithium, and Zinc to name a few.

At the Hudson Bay Route Association 79<sup>th</sup> AGM held in The Pas, Manitoba on October 17, 2022, we had a presentation from Keith Burak (Fortescue), on the shipping and production of green hydrogen in Northern Manitoba. This included the exciting prospect of shipping hydrogen in an ammonia form for nitrogen fertilizer. Fortescue, being based in Australia, is very interested in seeing this through to completion. Others in the energy sector look to the opportunities Churchill offers for international shipping. The need for a mid-Canada northern shipping port is clear and capacity at the port will fill quickly as the rail and port upgrades are completed.

In closing, we are proud of the Association's work and look forward to your ongoing support and loyalty to the Hudson Bay Route Association. Together we can see the success of our local port and rail come to fruition! Memberships and additional information are detailed in the accompanied attachment for anyone interested. Dear Manitoba Motor Carrier,

Manitoba Transportation and Infrastructure (MTI) regulates the operation of heavy commercial vehicles registered in the Province of Manitoba. The Manitoba *Highway Traffic Act* (HTA) defines a regulated vehicle as a motor vehicle that has a registered gross weight of 4,500 kg or more, or a bus or passenger vehicle with a seating capacity of 11 or more, including the driver.

Section 312.2 of the HTA states that carriers must have a valid safety fitness certificate (SFC) to operate a regulated vehicle in Manitoba. SFCs are renewed annually and a valid SFC is required to register a regulated vehicle in Manitoba. Some regulated vehicles are exempt from obtaining a SFC, including farm plated trucks and personal use vehicles. (For more information:

https://manitoba.ca/mit/mcd/safety\_monitoring/sfc/index.html)

The purpose of this communication is to provide information to stakeholders regarding recent changes to the Safety Fitness Criteria and Certificates Regulation. The changes have a more significant impact on new carriers, however there are some impacts to existing motor carriers operating under a Manitoba safety fitness certificate.

#### New entrant process after January 1, 2023:

New entrants to Manitoba's trucking industry are required to meet additional criteria after the implementation of the Safety Fitness Criteria and Certificates Regulation amendments on January 1, 2023.

What stays the same?

- Application The carrier submits an application for a new SFC. The application requires a carrier representative authorization (if applicable).
- **Proof of insurance** New carriers must provide proof of adequate insurance.
- **Proof of valid periodic mandatory vehicle inspection (PMVI)** –New carriers will continue to be required to provide proof that all the regulated vehicles they plan to register have a valid PMVI certificate at the time that their new SFC is approved and issued.
- **Proof of valid business entity** If the new carrier is a company, the carrier must provide proof that they are registered with the Manitoba companies office.

#### What is changing?

There are three changes that impact new carriers seeking a SFC in Manitoba for the first time:

- Application Fee New entrants applying for a new SFC in Manitoba must pay a \$200 application fee.
- Certification of Compliance Officers Manitoba requires that motor carriers name a Manitoba resident as the compliance officer for their company. The compliance officer, along with the company directors, are responsible for ensuring that the company complies with applicable highway safety laws and national safety code standards. After January 1, 2023, compliance officers will be required to take a 5-day safety course in order to be the named compliance officer for a new motor carrier starting operations in Manitoba. The New Entrant Training (NET) course is being administered by the Manitoba Trucking Association. Information on the course is available at: <a href="https://trucking.mb.ca/compliance\_courses/new-entrants-training/">https://trucking.mb.ca/compliance\_courses/new-entrants-training/</a>.
- Safety Plan New carriers are required to submit a safety plan to the department along with their SFC application. The NET course will assist a new carrier to develop the key components of a safety plan and prepare them to meet this new criterion for obtaining a new SFC in Manitoba.

#### Implications for existing operators after January 1, 2023:

Although most of the regulation changes impact new entrants to the trucking industry in Manitoba, there are some changes that impact existing operators, most specifically carriers with a poor safety record. Carriers with poor operating records may be required to submit a safety or action plan, and to certify their compliance officer prior to renewing their safety fitness certificate.

#### What stays the same?

- Application The carrier submits an application to renew their SFC, including the total annual kilometres travelled by regulated vehicles in their fleet in the last year and a carrier representative authorization (if applicable).
- Proof of insurance Carriers must provide proof of adequate insurance.
- **Proof of valid periodic mandatory vehicle inspection (PMVI)** –Carriers are required to provide proof that all the regulated vehicles they plan to register have a valid PMVI certificate at the time that their SFC is renewed.
- **Proof of valid business entity** If the carrier is a company, department staff will confirm if the company has a valid registration with the Manitoba companies office.

#### What is changing?

There is one change that has an impact for carriers who use a consultant or non-managing partner as their compliance officer:

• Eligibility of Compliance Officers - Under section 318.5(2), Manitoba requires that motor carriers name a Manitoba resident as the compliance officer for their company. The compliance officer, along with the company directors, are responsible for ensuring that the company complies with applicable highway safety laws and national safety code standards. After January 1, 2023, companies must name a compliance officer who is a company employee or company director/partner with day-to-day management responsibilities. Existing compliance officers, who meet the eligibility requirement, are not required to take the NET course. However, if a company changes its compliance officer, the new compliance officer will be required to take the NET course within 180 days prior to assuming the

position. Information on the course is available at: <u>https://trucking.mb.ca/compliance\_courses/new-entrants-training/</u>.

There are two changes with an impact to existing Manitoba based carriers with a poor safety record:

- Safety Plan or Action Plan may be required The performance thresholds calculated monthly for all Manitoba based carriers, are based on the carrier's inspection, accident and conviction information. When a carrier's overall performance threshold exceeds 65% they are required to submit a safety plan prior to renewing their safety fitness certificate. If a safety plan is already on file for the carrier, or the carrier's accident, inspection or conviction thresholds exceed 65%, the carrier will be required to submit an action plan that documents how they intend to improve their on road performance. Carriers will receive the safety plan/action plan request at the time that Manitoba Transportation and Infrastructure sends out the letter that informs them that their performance threshold needs attention to improve road safety.
- Certification of Compliance Officers for Conditional Carriers After January 1, 2023, if a company has a 'conditional' safety rating assigned, the named compliance officer must take the NET course administered by the Manitoba Trucking Association within 180 days (June 30, 2023) in order to become a certified compliance officer. Conditional carriers who need to review their safety fitness certificate prior to June 30, 2023 will be renewed conditionally, and will have to provide proof that their compliance officer has completed the course by June 30, 2023. Most of Manitoba's motor carriers have excellent safety records. The increased requirements for carriers with less safe operating records will help these operators understand how to implement safe operating practices in their company, and will increase road safety for all road users in Manitoba.

#### **The Planning Act Handbook**

Manitoba Municipal Relations has produced a new Planning Act Handbook to provide a general plain language overview and summary of The Planning Act which establishes the legal framework for planning in Manitoba excluding the City of Winnipeg whose planning framework is established under Part 6 of The City of Winnipeg Charter

The purpose of the Handbook is to help communities navigate land use planning processes and guide municipalities and planning districts in completing the minimum requirements for land use planning as required in The Planning Act. The Planning Act Handbook can be downloaded from the Department's website here:

https://www.gov.mb.ca/mr/land use dev/pubs/the planning handbook.pdf

This release version of the Handbook contains all provisions of The Planning Act effective up to December 31, 2022. Manitoba Municipal Relations is committed to developing an updated version which would incorporate all remaining legislative amendments passed and proclaimed in Version #2 to be released later this year.

The Handbook is intended to be a living document, with regular updates to ensure it reflects upto-date legislation and addresses pertinent land use planning issues. Municipalities and planning districts are welcome to provide suggestions for improvements to the Community Planning Branch (contact information below).

A French translation is currently in development, and will be posted on the website when complete.

The Planning Act Handbook is intended to complement, not replace, other planning guides produced by the Province of Manitoba. However, many of these additional resources are linked within the Handbook for ease of access.
